Subject: Davis Wright Tremaine LLP voucher.

Recommended Motion:

Accept the voucher for Davis Wright Tremaine LLP in the amount of \$5,964.00.

Background/Discussion:

At its meeting of September 8, 2014, the City Council voted to retain the law firm of Davis Wright Tremaine LLP to assist with obtaining a legislative ruling to allow the addition of an Emergency Department at the Brookings Clinic, and to bill the Curry Health Network (CHN) for 50% of the expenses. Upon receiving the ED designation, CHN contracted with Rivers Edge Construction, owned by Councilor Brent Hodges, for the remodel.

Normally, the attached voucher, or expenditure, would appear as a line item on the Voucher list, (list of paid bills, which is routinely accepted by the City Council under the Consent Calendar. However, Councilor Hodges' business contract with CHN creates a potential conflict of interest. By separating out acceptance of this particular expenditure from the other expenditures on the Voucher list, Councilor Hodges is able to remove himself from any discussion or action involving this expenditure and the full Council is able to approve the Consent Calendar, as written.

As the bill has already been approved and expensed, and CHN has been billed for 50% of the cost, the only action required at this time is acceptance of the voucher.

City Council Meeting MINUTES

Monday, July 27, 2015

The City Council met in Executive Session at 6:30 PM, in the City Manager's office under the authority of ORS 192.660(2)(i) to review and evaluate the employment-related performance of the City Manager, who did not request an open hearing.

Call to Order

Mayor Hedenskog called the meeting to order at 7:02 PM.

Roll Call

Council present: Mayor Ron Hedenskog, Councilors Jake Pieper, Kelly McClain, Brent Hodges and Bill Hamilton; a quorum present.

Staff present: City Manager Gary Milliman, Public Works & Development Director LauraLee Snook, Administrative Assistant Lauri Ziemer, City Attorney Martha Rice and City Recorder Joyce Heffington.

Others Present: Curry Coastal Pilot Report Jane Stebbins and approximately 15 others.

Ceremonies/Appointments/Announcements

The Capella Docents were recognized as the 2014 Volunteers of the Year. Docent Coordinator, Lauri Ziemer, provided a "Salute to the Capella Docents," and Mayor Hedenskog awarded certificates.

<u>Public Comments</u> – on non-agenda items

Gordon Clay, Brookings, presented statistics regarding school funding and proposed that the City give any tax revenue it received on the sale of marijuana to local schools.

Staff Reports

Discontinuation of pre-Planning Commission Meeting open house.

Director Snook provided the staff report.

Mayor Hedenskog said he had wondered how this would work and apparently interest was lacking.

Councilor Pieper asked if the open houses were conducted with any formal direction on the part of Council and Snook said it had been initiated by staff.

Councilor Hamilton said he thought the City was moving toward having a design standards advisory committee and Snook said staff would be putting a proposal forward to Council on the formation of that committee. Snook also advised that the development notification program would still be in effect.

Councilor Pieper said he was glad to see this go away as it had probably come about during the time when the big box stores were opening up.

Councilor McClain said he'd like to see it go away.

Mayor Hedenskog said the City received a lot of backlash about not being notified and this had been a way to address that citizen concern.

Authorization of Salmon Run Golf Course request to apply its 2015-16 lease payment toward the installation of irrigation bypass line.

Director Snook gave the staff report.

Councilor McClain asked Salmon Run Golf Course Manager, Ed Murdock, how water at the golf course was dispersed and Murdock said through the irrigation system. The new line, Murdock said, would be easier on the system as it would allow water to be pumped to hole 9 without shutting it down, while also providing a source of potable water to the club house.

Mayor Hedenskog asked if this had been reviewed by the City's engineer and Snook said it had not.

Councilor Pieper asked if this would be an appropriate use of the lease funds and Councilor McClain said in his mind it fit the intent.

Councilor Hodges said the pond was really low and Murdock said it takes two to three days to fill it and the new line will help save water, because turf, once its lost, is hard to bring back.

Councilor Hodges said he wasn't sure the water would be potable and Murdock said as long as the line is sealed and the appropriate backflow devices are installed it would be.

Councilor Hamilton said it looked like it would fit the parameters set by Council for use of the funds.

Councilor McClain said he would have no problem using the funds for this project and would include the additional funding needed for the project as well.

Councilor McClain moved, a second followed and Council voted unanimously to execute a letter of approval for the irrigation bypass line and to allow the current lease payment of \$20,000 to be diverted for this project and allow the additional \$8,984.78 to be taken out of lease payment fund.

Authorization to name the Transit Shelter at Elmer Bankus Park in honor of retired Curry Public Transit Manager Joanne Wasbauer.

Councilor Hamilton presented the request, which he said would be fitting considering everything that Wasbauer had accomplished.

Councilor Hamilton moved, a second followed and Council voted unanimously to name the Transit Shelter at Elmer Bankus Park in honor of retired Curry Public Transit Manager Joanne Wasbauer.

Ordinances/Resolutions

Ordinance 15-0-745 naming Brookings Municipal Code Title 4, "Franchises," and adding Chapter 4.05, Communications Infrastructure, to Title 4.

City Manager Milliman gave the staff report.

Councilor Hodges moved, a second followed and Council voted unanimously to do a first reading of Ordinance 15-0-745.

Mayor Hedenskog read the title.

Councilor Pieper moved, a second followed and Council voted unanimously to do a second reading of Ordinance 15-O-745.

Mayor Hedenskog read the title.

Councilor Pieper moved, a second followed and Council voted unanimously to adopt Ordinance 15-O-745 [naming Title 4 "Franchises" and adding Chapter 4.05, Communications Infrastructure to Title 4].

Resolution 15-R-1068, authorizing a loan from the Oregon Department of Transportation for reconstruction of Railroad Street.

City Manager Milliman presented the staff report.

Mayor Hedenskog said this would drain the Urban Renewal funds and Milliman concurred. Hedenskog said it would be "a game changer," as it would finalize what was begun years ago when the couplet was voted down.

Councilor Pieper moved, a second followed and Council voted unanimously to adopt Resolution 15-R-1068, authorizing a loan from the State of Oregon Department of Transportation for the Railroad Street Reconstruction Project.

Mayor Hedenskog moved, a second followed and Council voted unanimously to approve the Consent Calendar as written.

Mayor Hedenskog remarked that the Hot Rods concert in Azalea Park was packed and parking was scarce.

Councilor Hamilton thanked Boy Scout Troop 232, Loring's Eagle Scouts and Parks Supervisor Tony Baron and his crew for doing such a great job on the dog park. He said that projects like this one and the disc golf course will put Brookings on the map.

Mayor Hedenskog moved, a second followed and Council voted unanimously by voice vote to adjourn at 8:09 PM.

MINUTES BROOKINGS PARKS AND RECREATION COMMISSION May 28, 2015

CALL TO ORDER

Chair Patricia Brown called the meeting to order at 7:00pm followed by the Pledge of Allegiance.

ROLL CALL

Present. Commissioners Tom Bozack, Don Vilelle and Chair Patricia Brown

Absent: Commissioner Trace Kather

Also present: Parks/Tech Services Supervisor Tony Baron and Austin Dunn, RARE employee,

and members of the public.

APPROVAL OF MINUTES

A. Motion made to approve the minutes of March 19, 2015 as written; motion seconded and Commission voted; the motion carried unanimously.

PUBLIC APPEARANCES

A. Dane Tipman – BH School District employee and Azalea Park Foundation volunteer appeared on behalf of the school district and presented a letter from the HS Vice Principal discussing the issue of student activity in Stout Park and their efforts to discourage inappropriate behavior during school hours. They have stepped up their efforts to monitor the problem and plan to continue those efforts to have students act appropriate and respectively and discourage inappropriate behavior in Stout Park and hope to continue partnering with the City in efforts to maintain Stout Park. Don asked if the school has considered a closed campus and he was advised they have been discussing that option and are reviewing costs. He was aware of the upcoming agenda item to ban smoking in parks and thought school district staff would not oppose that measure. Tony advised that he has noticed a change at Stout Park since the school district began monitoring the area and he's not seen as many kids in the morning, during school or lunch hour and there are less kids congregating afterschool; believes the efforts the school district has taken have made a huge difference.

REGULAR AGENDA

- A. Prohibit Smoking in Parks Tony reviewed current smoking regulations and presented proposal to prohibit smoking in parks. He thought a ban prohibiting smoking in all park areas would be easier to enforce and that most people would adhere to the rule if it was posted. Committee discussed that state parks, rest areas and public areas already ban smoking. Audience member of 17160 Ocean Park Court, Brookings, advised that he sees juveniles loitering in the parks looking for cigarette butts and that activity would be curtailed. An all out ban would eliminate determining where smoking is allowed and if person smoking is of age before approaching. Motion made to approve proposed BMC revisions prohibiting smoking in all City parks; motion seconded and Commission voted; the motion carried unanimously. Matter forwarded to City Council.
- B. Tree Removal Lundeen Lane Azalea Park- Tony reviewed Coos Curry Electrics Coop (CCEC) request to remove 37 fir trees along Lundeen Lane at Azalea Park. Trees are endangering electrical lines and could cause essential damage if they come down during a storm and hit the transmission lines. CCEC willing to pay tree removal costs and timber could be sold for profit which could be used to invest in planting lower growing trees. Commission asked about possibility of thinning out the trees; Tony believed as their root system is so shallow would only weaken the trees and make them more susceptible to coming down in a storm. Commission questioned the public's perception of tree removal in the park which is not

favorable. Candice Michel, 1253 Rowland Lane, Brookings - thought the public's reactions could be mitigated with public notification of the issue and informing them of the problem, so the matter does not turn into a social media complaint campaign which recently happened when some trees in town were taken down. Tony advised that the public is informed and invited to all public meetings; projects and details are publicized well in advance and citizens should make an effort to voice their opinions and concerns before projects are in process. Chris Eckerson, 521 Fir Street, Brookings - spoke saying he is one of the people who posted a comment on social media and that online forums are not going to slow down and it is a place where public officials can see public reaction. Don questioned if trees were thinned out by removing the oldest, weakest, or tallest trees if the roots would improve, Tony did not know. Don thought removal of 37 trees was overkill but thought the safety aspect was the most important. Pat mentioned this same problem occurred a few years ago at Stout Park when trees had to be removed because they had grown into the transmission lines and agreed that again the safety factor was more important to pursue before expensive damage was done. Motion made by Tom Bozack to recommend to City Council removal of the trees in accordance to the recommendations of Coos Curry Electric; motion seconded and Commission voted: the motion carried unanimously. Matter forwarded to the City Council.

INFORMATION UPDATES/DISCUSSION ITEMS

- A. Disk Golf Course Azalea Park Austin Dunn provided update and progress report on the Disk golf course, first nine holes will be completed around mid-July. Volunteers have been clearing ground and an Eagle Scout will be installing the baskets. The back nine holes are being excavated and trails are being brush cut, graded and groomed. Have already seen increased activity in the park, including dog walkers and regular walkers using the area which discourages some of the negative activities that occur. Austin advised they have only thinned out some myrtle trees and taken out invasive holly, berry bushes and dangerous alder trees.
- B. Azalea Park Native Azalea Work Plan Tony reviewed Dick Cavendar"s letter reviewing Azalea Park. Still working out a plan with Azalea Park Foundation, Master Gardeners, City of Brookings and volunteers to pursue his recommendations. First step may just be pruning and thinning of the azaleas, at this time no fir trees are planned to be removed. Tom recommended when time comes to remove trees to consider time of year for birds nesting.
- C. Recreational Programming Youth Flag Football League Tony been approached to conduct a recreational youth flag football program through the City for boys and girls, 6-14 years during the summer. Jay Jost, 17160 Ocean Park, Brookings, advised he has previously been involved in a flag football league and would like to encourage this type of structured summer activity for kids. Different options to begin establishing a league are available by joining up with an already established NFL youth organization or the City initiating and recruiting sponsors. Flag football season occurs in the summer preparing kids for the fall tackle season league conducted by Curry Youth Football. Initial start up costs would be equipment expenses of @\$2000 which could be paid for by participation fees. Tony would like commission to pursue possibility of establishing more Park and Rec program activities like this and believes it would benefit the community. Drew Farmer, High School Football coach believes the idea would be very well received by parents and would be a great alternative to tackle football for kids. Matter continued for next agenda. CARTED

STAFF REPORTS

A. Tony advised he has been awarded a grant from West Family Foundation of \$7500 for Azalea Park Ballfields backstops and dugouts, which is one element of the Azalea Park ballfield reconfiguration project. Total project costs are @\$32,000, and hoping to have enough capital improvement funds next year to proceed with the reconfiguration. He is also presenting another Oregon Parks & Rec grant for other elements of the reconfiguration next week in Salem.

- **B.** Rhodys at Bankus Park advised that some of the rhodys have grown thick and large encroaching use of the bench, blocking visibility and encouraging unwanted behavior that can go unseen by the Police Dept; thinning/removal needed. Commissioners to look over the area and let Don know what they think and he will thin out.
- **C.** Gerry Livingston has been hired as new Pool Director. Pool is scheduled to open for summer in the next week. Also a new pool heater was installed this week.

COMMISSIONER REPORTS/COMMENTS

Commissioner Bozack – curious about what caused the pathway to subside at Chetco Point, Tony advised it was probably combination of compaction, settling and rain.

Commissioner Vilelle – advised Azalea Park Foundation is reorganizing its board and moving forward. He advised that as of May 7th the Azalea Park Foundation had not taken a position on the pruning of the azaleas in Azalea Park.
