WHEREAS, such funds have been requested to be expended for certain items, and

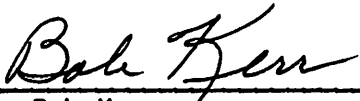
WHEREAS, Ordinance No. 329 provides that the Brookings City Council approve the acceptance and expenditure of such funds;

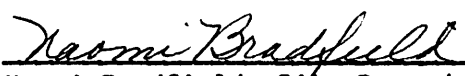
