

RESOLUTION NO. 332

A RESOLUTION ESTABLISHING USER FEES FOR THE
CHETCO COMMUNITY LIBRARY.


WHEREAS, Resolution No. 331 pertaining to the above referenced matter, was approved and passed by the Brookings City Council on July 12, 1983; and

WHEREAS, said City Council after further deliberation and consideration of public input at its continued meeting held on July 20, 1983 did entertain the motion to dissolve said resolution and enact a furthering resolution.

NOW, THEREFORE, BE IT RESOLVED as follows:

1. Resolution No. 331 is herein and hereby repealed.
2. The following fee schedule be and hereby is adopted to finance library operations.
 - A. A single fee of \$15.00 per household entitling family members thereof to full library privileges. Except equipment rental, government trip fees and meeting room rental fees.
 - B. Rental of equipment at \$5.00 per day or any part thereof, with a \$10.00 refundable deposit.
 - C. Governmental trip fee of \$10.00 per trip or such other amount as may be set from time to time upon motion by the City Council through negotiations between the City Council and governmental units subject to the fee.
 - D. Meeting room rental fee of \$7.50 for an average length meeting which fee may be adjusted from time to time upon motion of the City Council.
3. The City Staff be and hereby is directed to implement the aforementioned fee schedule forthwith upon the enactment of this resolution.

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF ALBANY, NEW YORK, CONCERNING THE ESTABLISHMENT OF A LIBRARY IN THE CITY OF ALBANY.

WHEREAS, the Board of Supervisors of the County of Albany, New York, has determined that it is in the best interests of the County to establish a library in the City of Albany, New York;

and whereas, the Board of Supervisors of the County of Albany, New York, has determined that it is in the best interests of the County to establish a library in the City of Albany, New York, and to provide for the maintenance and operation of such library;

Therefore, the Board of Supervisors of the County of Albany, New York, hereby resolves as follows:

1. That the Board of Supervisors of the County of Albany, New York, hereby resolves that the following fee schedule be and hereby is adopted to finance library operations:
 - A. A single fee of \$10.00 per household existing family members thereof to fully library privilege. Excess equipment rental, government trip fees and meeting room rental fees.
 - B. Rental of equipment at \$5.00 per day or any part thereof, with a \$10.00 refundable deposit.
 - C. Governmental trip fee of \$10.00 per trip or each other amount as may be set from time to time upon motion by the City Council through negotiation between the City Council and governmental units subject to the fee.
 - D. Meeting room rental fee of \$5.00 for an average length meeting which fee may be adjusted from time to time upon motion of the City Council.
2. The City shall be and hereby is directed to implement the aforementioned fee schedule forthwith upon the enactment of this resolution.
