# **CITY COUNCIL MEETING Minutes**

### Monday, September 24, 2012

City Hall Council Chambers, 898 Elk Drive, Brookings, OR 97415

### **Call to Order**

Mayor Hedenskog called the meeting to order at 7:00pm.

#### **Roll Call**

Council Present: Mayor Ron Hedenskog, Councilors Dave Gordon, Jake Pieper, Brent Hodges and Kelly McClain; a quorum present.

Staff Present: City Manager Gary Milliman, City Attorney Martha Rice, Administrative Services Director Janell Howard and City Recorder Joyce Heffington.

Others Present: Curry Pilot Editor, Scott Graves and one other.

#### **Ceremonies/Appointments/Announcements**

Mayor Hedenskog proclaimed October as Bullying Prevention Month and October 10<sup>th</sup> as Unity Day.

Councilor Pieper moved, a second followed and Council voted unanimously to appoint Marianne Padilla to the Planning Commission.

Councilor Hodges moved, a second followed and Council voted unanimously to appoint Don Leque to the Parks & Recreation Commission.

#### **Staff Reports**

Flower baskets on downtown street light poles.

City Manager Milliman provided the staff report, adding that the baskets and standards would need to meet the 120 mph wind standard.

Mayor Hedenskog suggested initially using a few freestanding arrangements to avoid light pole issues and suggested two potential locations; Hillside Oasis park and a parking strip east of Kerr's Ace Hardware.

Councilor Hodges said flowering baskets would make the town look nice and added that he'd recently met a woman in Mt. Angel who watered and fertilized flowering baskets in on a daily basis. He said the woman used a golf type cart and water tank and it took her 2-3 hours a day. He said he could get more information if it would be helpful.

City Manager Milliman said they would be removed in winter.

Councilor Pieper said he thought it was worth having staff prepare a cost proposal to be presented to Council prior to the next budget cycle.

Councilor Pieper moved, a second followed and Council voted unanimously to direct staff to explore technical feasibility of installing flower baskets on downtown street light standards and develop a budget estimate for installation and maintenance of the flowering baskets.
