

RESOLUTION NO. 224.

A RESOLUTION ESTABLISHING AN ASSESSMENT DISTRICT IN THE CITY OF BROOKINGS FOR THE IMPROVEMENT OF WHARF STREET.

BE IT RESOLVED By the Council of the City of Brookings, as follows:


Section 1. That it is necessary to make improvements to Wharf Street and for that purpose, the Wharf Street Assessment District shall be initiated.

Section 2. The city engineers shall prepare and submit a report as required by City of Brookings Ordinance No. 146, Section 4.

Section 3. That upon completion of the report in Section 2 of this resolution, the City shall, by publication, send out a notice as required by City of Brookings Ordinance No. 146, Section 6.


Section 4. The boundaries of the proposed assessment district are as shown in Exhibit "A" attached hereto and made a part hereof by reference.

DESCRIPTION FOR CITY OF BROOKINGS
WHARF STREET
ASSESSMENT DISTRICT BOUNDARY

Beginning at the Northeast corner of property conveyed to Anderson and Elina Coy as recorded in Book of Records 63, pages 693 and 694, Deed Records, Curry County, Oregon; thence, Southerly along the East line of said Coy property to the Southeast corner of said Coy property; thence, Southerly to the Northeast corner of property conveyed to Bernard and Phyllis Bishop as recorded in Book of Records 51, pages 169, 308, 309, 527, 528, 536, and 602, Deed Records, Curry County, Oregon; thence Southerly to the Southeast corner of said Bishop property and being on the South line of Block 11; thence, Southerly to the North line of said property conveyed to Bishop; thence, Easterly, Southerly and Westerly along said property conveyed to Bishop; thence, Southerly to the Northeast corner of property conveyed to Richard Wilson in Book of Records 69, page 447, Deed Records, Curry County, Oregon; thence, Southerly and Westerly along said property conveyed to Wilson; thence, Southerly to the Northeast corner of property conveyed to Chester A. and W. Thompson as recorded in Deed Volume 63, page 14, Deed Records, Curry County, Oregon; thence, Southerly and Westerly along said property conveyed to Thompson to the Southeast corner of property conveyed to City of Brookings as recorded in Book of Records 21, page 281, Deed Records, Curry County, Oregon; thence, Westerly, Northerly and Easterly to the Southwest corner of property conveyed to L.C. Bliss and Sons, Inc., as recorded in Book of Records 61, Page 373, Deed Records, Curry County, Oregon; thence, Northerly along said property conveyed to L.C. Bliss and Sons, Inc. to the South line of property conveyed to Eldon and Nancy Gossett as recorded in Book of Records 53, page 373, Deed Records, Curry County, Oregon; thence, Westerly, Northerly and Easterly along said property conveyed to Gossett to the point of beginning.
