

RESOLUTION NO. 119

RESOLUTION ADOPTING BUDGET, MAKING APPROPRIATIONS, AND
LEVYING TAXES

1. BE IT RESOLVED that the Council of the City of Brookings hereby adopts the budget approved by the Budget Committee of the City of Brookings on April 19, 1966, as the same was legally changed at the public hearing held May 25, 1966, now on file in the Office of the City Recorder, City of Brookings, Oregon.
2. BE IT RESOLVED that the Council of the City of Brookings hereby levies the taxes provided for in the budget adopted in paragraph 1 of this Resolution in the aggregate amount of \$71,645.65 and that these taxes are hereby levied and assessed pro-rata upon all taxable property within the City of Brookings, Oregon, as of 1:00 A.M. January 1, 1966.
3. BE IT RESOLVED that the amounts for the fiscal year beginning July 1, 1966, and for the purposes shown below are hereby appropriated as follows:

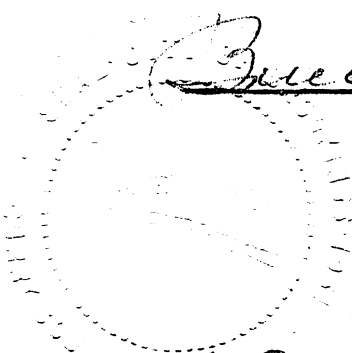
