

RESOLUTION FOR PROCEEDINGS
TO VACATE ALLEY

No. 75

WHEREAS, it has been brought to the attention of the Council that a certain portion of an alley, located in BROOKINGS PLAT NO. 1, and more particularly described below, has never been opened to public use, that said alley should be vacated, and that the vacation thereof will not substantially affect the market value of the abutting property,

RESOLVED, by the Council of the City of Brookings, that proceedings be undertaken to vacate a portion of an alley located in the City of Brookings, Curry county, Oregon, described as follows:

That portion of the fifteen (15') foot alley bisecting Blocks 19 and 27, PLAT NO. 1, BROOKINGS (recorded in Book 1 at page 5, Plat Records of Curry County, Oregon) between the intersection of said alley with the easterly side of Fern Avenue, and the intersection of said alley with the westerly side of Alder Street, EXCEPT the portion thereof located in Oak Street.

FURTHER RESOLVED, that a hearing on this resolution and upon any objections filed hereto shall be held at the City Hall, Brookings, Oregon, on the 3rd day of APRIL, 1962 at 8:00 ~~A.M.~~ (P.M.). The City Recorder or other recording officer shall give notice of this resolution and of said hearing by publication and posting as provided by Section 271.110 Oregon Revised Statutes, the posting and first day of publication to be not less than twenty-eight (28) days before said hearing.
