RESOLUTION NO. 57

A RESOLUTION PROPOSING THE SUBMISSION TO THE LEGAL VOTERS OF THE CITY OF BROOKINGS, OREGON, THE PROPOSITION THAT THE CITY BE AUTHORIZED THROUGH ITS COUNCIL TO LEVY A SERIAL TAX OF \$7,000.00 ANNUALLY FOR FIVE YEARS, BEGINNING WITH THE FISCAL YEAR JULY 1, 1960 TO JUNE 30, 1961, FOR THE PURPOSE OF PROVIDING FUNDS FOR THE PURCHASE OF A FIRE ENGINE, HOSE AND OTHER FIRE FIGHTING EQUIPMENT FOR THE CITY OF BROOKINGS, WHICH SERIAL TAX LEVY WILL BE OUTSIDE OF THE LIMITATION ON TAXATION AS SET FORTH IN SECTION 11 OF ARTICLE XI OF THE CONSTITUTION OF OREGON, AND ANY CHARTER LIMITATION OF THE CITY OF BROOKINGS.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BROOKINGS, OREGON:

That the following tax levy be and the same hereby is proposed for submission to the legal voters of the City of Brookings for their adoption or rejection:

In each of the five fiscal tax years beginning with the fiscal tax year July 1, 1960 to June 30, 1961, and ending with the fiscal tax year July 1, 1964 to June 30, 1965, inclusive, the City of Brookings, Curry County, Oregon, through its Council, is authorized to levy annually a serial tax of \$7,000.00 for the purpose of providing funds for the purchase of a fire engine, hose and other fire fighting equipment for the City of Brookings, which serial levy is outside the limitation on taxation as set forth in Section 11, of Article XI of the Constitution of the State of Oregon and the limitations of the Charter of the City of Brookings.

BE IT FURTHER RESOLVED that for the hereinabove proposed serial tax levy the following ballot title be and the same hereby is adopted by the Council, to-wit:

CITY OF BROOKINGS SERIAL TAX LEVY

A five-year \$7,000.00 a year serial tax levy submitted and referred to the legal voters of the City of Brookings, Oregon, by the Council of said City.

AN ACT


In each of the fiscal years beginning with the fiscal year July 1, 1960 to June 30, 1961, and ending with the fiscal tax year July 1, 1964 to June 30, 1965, the City of Brookings, Curry County, Oregon, through its Council, is authorized to levy annually a serial tax of \$7,000.00 for the purpose of providing funds for the purchase of a fire engine, hose and other fire fighting equipment for the City of Brookings, which serial tax levy is to be outside of the limitation on taxation as set forth in Section 11 of Article XI of the Constitution of the State of Oregon and any limitations of the Charter of the City of Brookings. This proposed levy is to provide better fire protection and the estimated total outlay for the five-year period is \$35,000.00.

BE IT FURTHER RESOLVED that the aforesaid five-year serial tax levy proposal shall be filed with the City Recorder of the City of Brookings for submission to the legal voters of said City.

BE IT FURTHER RESOLVED that said serial tax levy shall be submitted to the legal voters of the City of Brookings, Oregon, on Tuesday, June ~~14~~²¹, 1960, at the special city election heretofore called.
