

ON MOTION DULY MADE AND SECONDED, THE FOLLOWING RESOLUTION WAS UNANIMOUSLY ADOPTED:

WHEREAS, THE COUNCIL OF THE CITY OF BROOKINGS, CURRY COUNTY, OREGON, HAS RECEIVED FROM THE UNITED STATES NATIONAL BANK OF PORTLAND (OREGON) AT ITS BROOKINGS BRANCH, THE FOLLOWING WRITTEN OFFER TO ACCEPT DEPOSITS OF THIS BODY AND TO PAY THEREFORE INTEREST:

"TIME DEPOSIT-OPEN ACCOUNT", WHICH WILL RECEIVE MONTHLY INTEREST AT THE RATE OF 1% PER ANNUM WHEN DEPOSITED ON INSTRUMENTS REQUIRING 30 DAYS WRITTEN NOTICE OF INTENT TO WITHDRAW AND $2\frac{1}{2}\%$ PER ANNUM WHEN DEPOSITED ON INSTRUMENTS REQUIRING 90 DAYS WRITTEN NOTICE OF INTENT TO WITHDRAW."

NOW, THEREFORE, BE IT RESOLVED, THAT THE SAID OFFER BE ACCEPTED AND THE CITY RECORDER OF THIS BODY BE, AND SHE HEREBY IS AUTHORIZED AND EMPOWERED TO ACCEPT THE SAME, IN WRITING, AS PROVIDED FOR UPON SAID WRITTEN CONTRACT BETWEEN THIS BODY AND THE UNITED STATES NATIONAL BANK OF PORTLAND (OREGON) COVERING THE SUBJECTS THEREIN SET FORTH;

BE IT FURTHER RESOLVED, THAT THE MAYOR OF THIS BODY BE, AND HE HEREBY IS AUTHORIZED TO CERTIFY THIS RESOLUTION OVER THE SEAL OF THIS BODY AND DELIVER THE SAME TO SAID THE UNITED STATES NATIONAL BANK OF PORTLAND (OREGON).

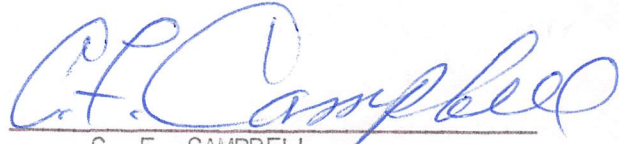
