Mayor Davis opened the public hearing at 7:16 p.m. Mayor Davis asked if any Councilor wished to declare ex parte contact or a conflict of interest. There was no response.

City Manager Tom Weldon presented the staff report, which stated that, "The proposed name change makes sense because it will provide a new name to a street that is no longer a part of the State Highway system but is addressed as if it were on the current highway alignment. The proposed name change would lessen the possibility of confusion on the part of the emergency services and on the part of the public trying to find a highway address that is not actually on the highway." The Brookings Planning Commission recommended to the Council that the street be renamed Bridge Street.

Mayor Davis asked for testimony from proponents. Those speaking were: Rex Atwell, representing Southern Curry Ambulance Association.

Mayor Davis asked for testimony from opponents, interested parties and public agencies. There being no response, Mayor Davis closed the public hearing at 7:24 p.m.

Councilor Hagbom moved, Councilor Curry seconded and the Council voted unanimously to change the name of old Highway 101 on the north side of the Chetco River that crosses under the B.A. (Dot) Martin Bridge from Old Highway 101 to Bridge St.

# 1. Jack Creek Golf Course Financing

Councilor Scott moved, Councilor Curry seconded and the Council voted unanimously to set a \$5,000 legal fund to be expended in the review of the options and procedural steps that are necessary for the City to enter into a partnership or liaison with any group of people prior to subordinating the 187 acres of the Jack Creek Golf Course.
