1. Introduction and swearing in of two new Police Officers

Sgt. Wayne Sheffel introduced Barbara Palicki who has been hired through the FASTCOPS grant, and John Riddle who has been hired as a result of the passage of the tax levy.

Municipal Court Judge Roger Sanders administered the oath of office to the new Police Officers.

2. Employee of the Season - Summer, 1995

Mayor Davis proclaimed Municipal Court Clerk Ruth Roberts as the "Employee of the Season" for the summer of 1995.

Councilor Hagbom moved, Councilor Curry seconded and the Council voted unanimously to adopt the Collective Bargaining Agreement between Teamsters Local Union No. 223 and the City of Brookings.

2. Amendment to City of Brookings Employee Handbook - Section XV.C (Retirement)

Councilor Curry moved, Councilor Brendlinger seconded and the Council voted unanimously to remove the following language from Section XV.C of the Employees Handbook:

“The City pays the entire contribution for the employee into the Public Employees Retirement System.” -

and staff was instructed to add the following language to Section XV.C of the Employees Handbook:

“Retirement. The City shall pay all required employer contributions for employees into the Oregon Public Employee Retirement System. Employees shall pay the six percent (6%) employees contribution through payroll deduction.


XII. REMARKS FROM MAYOR AND COUNCILORS
