1. Ordinance No. 95-O-510 - An ordinance granting Curry Transfer and Recycling, Inc. A franchise to provide all solid waste, infectious waste and recyclable materials services within the City of Brookings; and repealing Ordinance No. 86-O-402.

Councilor Brendlinger and Ted Freeman, Jr., requested changes in the language of Section 1, Subsection L. Following a 20 minutes recess, CTR Attorney Tim Arntzen and City Attorney Martin Stone recommended the following language be added to Subsection L of Section 1:

"Solid waste does not include:

- (1) Environmentally hazardous waste as defined in ORS 466.055.
- (2) Sewer sludge and septic tank and cesspool pumping or chemical toilet waste.
- (3) Reusable beverage containers as defined in ORS 459.005(18)(b).

This section shall not be construed to prohibit Oregon licensed contractors from collecting and transporting demolition and construction waste, wood waste, concrete rubble, manure, contaminated soils, and fill dirt incidental to such person's business or occupation; or to prohibit yard maintenance persons from collecting and transporting grass clippings and yard debris produced as part of that person's business or occupation."

Administrative Assistant Donna Van Nest read Ordinance No. 95-O-510 into the record in its entirety.

Councilor Hagbom moved, Councilor Curry seconded and the Council voted unanimously to adopt Ordinance No. 95-O-510 by first reading.

Administrative Assistant Donna Van Nest read Ordinance No. 95-O-510 into the record by title only.

Councilor Curry moved, Councilor Brendlinger seconded and the Council voted unanimously to adopt Ordinance No. 95-O-510 - An ordinance granting Curry Transfer and Recycling, Inc. a franchise to provide all solid waste, infectious waste and recyclable materials services within the City of Brookings; and repealing Ordinance No. 86-O-402. - by second reading.
