They want to jointly update local information and pursue dual technical assistance grants, which will hopefully lead to an FmHA or RDA grant.

There was some discussion as to whether this should be considered since the Applicant's representative had left the meeting. After Council deliberation and the City Attorney's opinion, it was decided to continue with this agenda item.

Council acted to allow one time use of city equipment and personnel under the following conditions:

- 1. Use of 4-man city crew (2 workmen, 2 flaggers) and equipment @ \$240/hour;
- 2. City crew performs sealing work whenever they can be spared from other city jobs;
- 3. Owner/developer provide one year warranty on original trench and patch work;
- 4. Owner/developer provide bond for sealing work (if bond includes a letter of credit, it must be for a one year time period);

- 5. Slurry required after sealing complete; and,
- 6. A hold harmless clause for city work on street patching, recognizing they are working for the owner/developer/contractor.

Councilor Curry moved to approve the proposed Marine Drive sewer line-street repair with the above specifications, which motion was seconded by Councilor Hagbom. The clerk called the roll with the following results:
