V. <u>PUBLIC HEARINGS</u>

1. Community Development Block Grant - Second Hearing

The Oregon Community Development Block Grant (CDBG) is a grant program for nonmetropolitan cities and counties that is funded by the U.S. Department of Housing and Urban Development (HUD) and administered by the State of Oregon Economic Development Department. The Oregon Economic Development Department (OEDD) has been administering the grant program since 1982. Since that time, more than \$111,000,000 has been awarded to small cities and counties throughout Oregon for a variety of community development and housing projects that primarily benefit low and moderate income persons. Since the demand for the grant program exceeds the funds available, applications are rated and ranked in a competitive system that utilizes predetermined criteria to select projects for funding.

During 1993, approximately \$15 million of federal funds were available for the program. In June of 1993, nine jurisdictions received a total of \$16 million in grant funds for local housing rehabilitation programs more than half of the 14 that applied. The OCDBG program provides an opportunity to jurisdictions that recognize preservation and improvement of low income housing as a need in their community. Jurisdictions with populations as small as 300 persons have been successful in applying for grant funds and implementing housing rehabilitation programs.

Staff is proposing to apply for a \$10,000 technical assistance grant for the purpose of conducting a housing analysis of low to moderate income households to determine the need for a housing rehabilitation program.

Mayor Davis opened the public hearing at 7:18 p.m.
