Councilor Brendlinger presented a video of the condition of the skateboard park, and made several suggestions for cleaning up the area.

- 1. Repair all ramps so that they do not present hazards to skaters and keep in repaired condition. (replace dry rot, broken pieces, uneven pieces, etc.)
- 2. Pick up all trash including odds and ends of masonite board and KEEP AREA TRASH FREE!
- 3. Enclose ramp frames to reduce trash hiding places and improve appearance.
- 4. Apply wood preservative to avoid future breakage due to deterioration thus reducing hazards to skaters.
- 5. Remove all graffiti on ramps and asphalt.
- 6. Designate one backboard for skateboard logos and have the best artist do the work. Exceptions: No suggestive (double meaning - obscene) logos.

Councilor Curry moved to give the skateboard people 30 days to follow Councilor Brendlinger's suggestions and to have the skateboard park equipment secured for the winter, which motion was seconded by Councilor Brendlinger. The clerk called the roll with the following results:

#### FINDINGS IN SUPPORT OF ORDINANCE No. 93-0-446.Q

The Common Council of the City of Brookings, in adopting Ordinance No. 93-0-446.Q, makes the following findings as required by Section 144.050D of Ordinance 89-0-446:

- 1. Ordinance No 93-0-446.Q amends Ordinance No 89-0-446 ( Land Development Code of the City of Brookings) to allow a nonprofit rehabilitation training center with a related retail store as a conditional use in residential districts, and to establish parking and buffering requirements relating to such use.
- 2. Ordinance No. 93-0-446.Q was initiated by the City of Brookings.
- 3. A public hearing before the Common Council of Brookings was held on October 25, 1993 to consider the proposed ordinance, and at the hearing testimony and exhibits were presented to the Council by staff, proponents and opponents of the ordinance.
- 4. The proposed conditional use will provide for a rehabilitation training facility and related retail store for products produced, repaired or recycled through the facility.
- 5. Rehabilitation training facilities, either with or without related retail stores, are not specifically mentioned in the Land Development Code. There is a need to provide for rehabilitation training facilities in the city's existing zones.
- 6. Conditional use of land as a rehabilitation training facility is similar in nature to other conditional uses permitted in residential zones, such as public, private or parochial schools.
- 7. The criteria for approval of a conditional use includes requirements for compatibility with the neighborhood in which the use is located. The residential characteristics of a neighborhood can be protected through application of conditions of approval.
- 8. Adoption of Ordinance 93-0-446.Q will encourage the appropriate use of land within the city. Existing structures that otherwise might not accommodate residential use may be utilized.

- 9. The welfare of the city will be promoted by adoption of the ordinance. Rehabilitation training centers provide jobs for individuals who are in training, and permit those individuals to lead a more independent life. Retail stores related to rehabilitation training centers provide affordable clothing and other goods to families with lower incomes.
- 11. Ordinance 93-0-446.Q complies with and conforms to the Comprehensive Plan goals, policies and generalized land use map.
