IV. ADOPTION OF TENTATIVE URBAN RESERVE MAP

V. ADOPTION OF 1993-94 BUDGET

Council recessed for a break at 12:22 p.m. and reconvened at 12:30 p.m.

Council recessed for lunch break at 1:15 p.m. and reconvened at 2:14 p.m.

Council recessed at 4:15 p.m. in order to allow staff to maked the necessary changes to the budget document, which were decided by council.

Council reconvened at 7:03 p.m., with Councilor Scott absent.

With all changes incorporated into the approved budget, Councilor Hagbom moved to adopt Resolution No. 93-R-559 - A resolution adopting the budget, declaring tax levied and making appropriations for the 1993-94 fiscal year - which motion was seconded by Councilor Curry. The clerk called the roll with the following results:

Motion carried; Resolution No. 93-R-559 - A resolution adopting the budget, declaring tax levied and making appropriations for the 1993-94 fiscal year - adopted.
