In a memo from City Attorney Mike Gillespie he advised that based upon the claim against the Surety Bond in this matter filed with the City June 2, pursuant to Supplementary General Condition Number 14.12.1 to the Contract, the City can only make final payment after certain things happen. One requirement is a certification that "all claims for material and labor" have been paid. No such certification has been made and can't be made until this claim is resolved.
