I. CALL TO ORDER

Mayor Hummel called the reconvened meeting to order at 7:00 p.m.

A. Mayor

Wastewater Treatment Plant Construction Update

Mayor Hummel announced that the construction project at the wastewater treatment plant outfall is beginning and access to the beach at Chetco Point will be temporarily curtailed due to blasting. Access will be reinstated as soon as is safely possible.

2. ODOT Parkway Plan

Mayor Hummel indicated that the city has received a letter from the Southern Curry Merchants Association requesting more information on the Parkway Project, and requested that City Manager Dennis Cluff be directed to attend the public hearing on March 5 in Grants Pass to ascertain information on the ODOT 6-year plan.

G. City Manager

1. Report on study of proposed skateboard park

Interim City Manager Dick Kahanek presented a brief report on the study done by Chief of Police Kent Owens on skateboard facilities in other areas and then offered the following options for council consideration:

Option 1 - Reject the request and refer the skateboarders to the operators of Azalea Park.

Option 2 - Refer the request to Brookings Harbor School District 17C for inclusion in their extracurricular sports program.

Option 3 - Submit the proposal to the recently-formed city Parks and Recreation Commission for a priority consideration.

Option 4 - Request \$40,000 from the budget committee at their March 20, 1990 meeting. Seek the funds for construction of a facility such as is being considered in Coos Bay, plus security fencing and an all weather cover.

Option 5 - Refer the matter back to staff in order to provide additional research, consider other options, and report back at Council's March 12, 1990 meeting.

Mayor Hummel recommended Option 2 and stated that he wants to meet with the 17C board chairman to discuss a joint venture project.

Councilor Henry moved to follow Option 2 and to authorize the mayor to meet with the 17C board chairman to discuss a joint venture project, and request the Parks and Recreation Commission to follow up, which motion was seconded by Councilor Brendlinger. 2A. Report on the scope of the sidewalk problem and private property needing repairs

Interim City Manager Dick Kahanek quoted Ordinance No. 55-0-073, which states, "It shall be the duty of the city works superintendent to periodically inspect the condition and shape of repair of all sidewalks in the city. He shall periodically make a report of such inspection to the council. He shall diligently, in his said report, set forth and describe all nonconforming sidewalks that he has discovered, prior to the date of his report, and submit the same to the council."

Mr. Kahanek then presented the council with a study showing that not counting mailboxes located within the sidewalk right-of-way on Highland, Midland and Ransom Streets, the following locations are considered minor hazard areas involving drop offs, broken sidewalk sections, or raised sidewalks:

Councilor Schutt moved to accept the report and direct staff to notify the property owners of their liability, in order to reduce the liability of the city, which motion was seconded by Councilor Henry. The clerk called the roll with the following results:

2B. Report on the defective caution lights at the schools

Interim City Manager Dick Kahanek reported that the blinking lights on pedestrian signs are located over three crosswalks fronting Kalmiopsis Elementary School (Easy St.) and Azalea Middle School (Pacific Ave.) Maintenance of the yellow signal heads and bulb replacement has been accomplished in the past by Coos-Curry Electric maintenance personnel but staff has been advised that they are no longer able to maintain the flashing warning lights because of salt air deterioration of the aluminum light housings. They will install replacements, however, if provided by the city.

Mr. Kahanek noted that there is little question but what the city is responsible for all markings, and safety equipment on or over city streets. The matter of potential liability just naturally follows in the event of accident or injury caused by a malfunctioning safety device. Mr. Kahanek presented the Council with four options open to the city:

Option 1 - Remove the lights and replace the two-sided pedestrian crossing signs only. This can be accomplished at a cost of approximately \$65.00 each or \$200 for all three locations.

Option 2 - Remove both the inoperable lights, signs and support wires completely, leaving only the painted crosswalks.

Option 3 - Replace both the two-sided pedestrian crossing signs, lights and bulb housings. A contact with Northwest Signal Supply Co. of Lake Oswego quoted 1989 prices for this option as follows:

This option can be accomplished at an approximate cost of \$900 each or \$2,700 for all three.

Option 4 - Refer this matter (B) to the city attorney for research as to potential city liability on the various alternatives and direct staff to report back at the March 12, 1990 council meeting.

Councilor James moved to follow Option #3 and direct staff to budget \$2,700 in the 1990/91 budget for this project, which motion was seconded by Councilor Brendlinger. The clerk called the roll with the following results:

The minutes of past council meetings showed that the contract had been deleted from the council agenda on September 11, 1989 and had not been reconsidered by the council since that time. City

Attorney John Babin advised the council that there is no contract, implied or otherwise, with the Benkendorf Associates at this time. Councilor Schutt moved to not sign the contract, which motion was seconded by Councilor Brendlinger. The clerk called the roll with the following results:

The matter was placed on the agenda for the March 12 council meeting.

H. Community Development Director

1. Report on how many North Bank Chetco River Road undeveloped lots front on a city water main that don't presently have city water service

Community Development Director Leo Lightle gave a brief report, showing approximately 73 lots fronting on a city main and 12 lots which may receive water. He reported that there are currently approximately 60 meters turned on in these two exception areas.

Councilor Brendlinger moved to amend Ordinance No. 66-0-190 to include the availability of water connections to undeveloped lots in Exception Areas 48 and 49. The motion died for lack of a second.

I. City Attorney

1. Proposed amendment to Ordinance No. 60-0-146

City Attorney John Babin advised that Councilor Brendlinger has requested an amendment to Ordinance No. 60-0-146, Section 2. B., which states, "Any proposal to levy and collect such assessment may be defeated by a remonstrance of the persons owning two-thirds of the front footage of the property to be subject to the assessment when the proposal is to levy and collect such assessment against only the property abutting upon such public improvement, or by a remonstrance of the persons owning two-thirds of the area within the boundaries of any special assessment district, whether the property within the boundaries of said proposed assessment district abuts upon any such proposed public improvement or not." Mr. Babin advised that the Bureau of Governmental Affairs shows that the 2/3 remonstrance is the most common, but that there is no constitutional requirement for any remonstrance whatsoever.

Councilor Brendlinger moved to amend Ordinance No. 60-0-146 to reflect the current policy and require a 51% remonstrance. Motion died for lack of a second.

2. Report on Van Pelt Hills dedication of water system to City - pressure situation on fire hydrants

City Attorney John Babin gave a report on his study of city liability for inadequate supply of water to extinguish fires in the Van Pelt Hills Subdivision. Following the report, Councilor Henry moved to direct staff to make a study specifying areas served by water systems that are to be used for fire protection services, and to identify areas where fire protection will be at minimum levels, which motion was seconded by Councilor James.

Following further discussion, Councilor Henry amended his motion to direct staff to discuss with the city's fire marshal alternative methods of adequately testing fire hydrants and bring the results back to the council at the March 12 meeting, which motion was seconded by Councilor Schutt.
