VII. COMMUNICATIONS/ANNOUNCEMENTS/REPORTS/REQUESTS

A. Mayor

1. Mayor Hummel announced that he and the Council had attended the League of Oregon Cities annual conference in Eugene in November, and advised that the Council would be giving reports at their workshop on November 27.

2. City Manager Evaluation Criteria

Mayor Hummel requested that this matter be discussed further at the November 27 workshop. The Council agreed.

3. Parks and Recreation Commission

Mayor Hummel advised that an ordinance creating a Parks and Recreation Commission is further on the agenda and he requested, if the ordinance is passed, that persons wishing to serve on the Commission write a brief resume to him.

3. Discussion on left-turn light at Oak Street and Chetco Avenue

City Attorney John Babin stepped down from the bench to participate in the discussion as a business owner.

Mayor Hummel briefed the Council on the status of the proposed left-turn light.

Following several suggestions for alternatives, Mayor Hummel indicated that he would be contacting the Oregon Department of Transportation concerning the alternative proposals for the intersection of Chetco Avenue and Oak Street and would be reporting back to the Council as soon as possible.

B. Council

1. "Cities Fight Back Against Drugs Week" - Councilor Schutt

Councilor Schutt requested that the Council adopt a resolution declaring December 3 to 9 as "Cities Fight Back Against Drugs Week". Executive Secretary Donna Van Nest read Resolution No. 89-R-472 into the record. The clerk called the roll with the following results:

Motion carried; Resolution No. 89-R-472 adopted. Mayor Hummel designated Councilor Schutt to coordinate a community drug abuse task force with assistance as needed from Interim City Manager Dick Kahanek.

2. Joint City Council/Planning Commission Meeting -Councilor Brendlinger

Councilor Brendlinger inquired as to the status of the request from the Vice Chairman of the Planning Commission for a joint City Council/Planning Commission meeting to discuss some possible changes in the planning ordinances. Mayor Hummel offered to contact the Planning Commission and the Planning Director for further information.

- C. Planning Commission
 - 1. Proposed amendment to Land Development Code to exempt remodel of structures not in excess of 50% assessed value from development permit requirements

City Attorney John Babin advised the Council that a public hearing must be held on this matter before the City Council. Staff was directed to publish a public hearing notice for the January 8, 1990 Council meeting.

D. <u>Chamber of Commerce</u>

Board Member Norma Fitzgerald was in the audience but there was no report from the Chamber of Commerce.

E. <u>City Manager</u>

1. Report on drug programs - Chief Kent Owens

Chief of Police Kent Owens gave a presentation on substance abuse problems, drug programs available to this area and the actions by the Council and the community needed to curb drug abuse in Brookings. No action taken.

2. Report on Systems Development Charges Seminar

Engineering Technician Leo Lightle briefed the Council on the Systems Development Charges Seminar which he attended in Springfield in October. Mr. Lightle explained House Bill 3224 which authorizes local governments to establish system development charges, defines "system development charge", and limits improvement fees to be spent on capacity increasing capital improvements. No action taken.

3. Report on water quality and conservation

Engineering Technician Leo Lightle briefed the Council on a meeting which he attended in Grants Pass presented by the Oregon Water Resources Division concerning water quality and conservation. No action taken.

4. Request for no parking areas at First Baptist Community Church on Pacific Avenue

Engineering Technician Leo Lightle presented the Council with a request from members of the First Baptist Community Church requesting curb markings denoting no parking areas (one at the front entrance of the church and one at the back entrance to the church) at the First Baptist Community Church. Mr. Lightle indicated that staff had inspected the area and recommended that the request be approved.

Councilor Schutt moved to approve the request as presented by staff, which motion was seconded by Councilor James. The clerk called the roll with the following results:

Motion carried; no parking areas approved at the First Baptist Community Church at the rear and front entrances.

4. Request for extension of contract time - Marv's Utility Specialist - Water Line and Pump Station Contract

Interim City Manager Dick Kahanek advised the Council that Marv's Utility Specialist has requested a contract extension from November 2, 1989 to January 19, 1990. The engineering firm of CH2M Hill has recommended that the extension be granted due to a delay in delivery of pumps and motors. This delay, according to CH2M Hill, appears to be a factor of current construction conditions and not within the contractor's control.

The council expressed concern about additional engineering costs which will be incurred by the City if the extension of time is granted.

City Attorney John Babin advised the Council that according to the contract signed by Marv's Utility Specialist, the completion was to be within 150 Mr. Babin indicated that there was no days. provisions in this contract document for extension. However, in the bid documents there is a provision under Section 58 which states, "Delays in delivery of equipment or material purchased by the Contractor or his Subcontractors, including Owner-selected equipment, shall not be considered as a just cause for delay, unless the Owner determines that for good cause the delay is beyond the control of the The Contractor shall be fully Contractor. responsible for the timely ordering, scheduling, expediting, delivery, and installation of all equipment and materials." Mr. Babin indicated that the city's engineering firm has stated that the delay is not the fault of the contractor.

Engineering Technician Leo Lightle explained that at the time of the original bid and award of the contract, Marv's had received definite dates of delivery for certain equipment, but by the time the order was actually placed, the manufacturer could no longer guarantee that delivery date and instead offered delivery on December 22.

Councilor Schutt moved to extend the contract time to January 19 but the contractor would pay all additional incurred engineering costs. The motion died for lack of a second.

Councilor Brendlinger moved to direct the City Manager to draft a letter granting the contract extension to January 19, 1990, without waiving any further rights and with the provision that Marv's indemnify the City from any costs or expenses which it might incur solely as the result of the extension of time, which motion was seconded by Councilor Henry. The clerk called the roll with the following results:

Motion carried; City Manager to draft a letter granting the contract extension to January 19, 1990, without waiving any further rights and with the provision that Marv's indemnify the City from any costs or expenses which it might incur solely as the result of the extension of time.

Interim City Manager Dick Kahanek presented the Council with job descriptions for city employees and requested that they receive and file the data but take no action at this time. He advised that the Council will receive policies and procedures at a later date and requested that the job descriptions also be considered at that time. No action taken.

7. Request for street improvements on Marina Heights Road

Mr. Paul Rettig, Commissioner, Marina Heights Special Road District, presented the Council with a request for improvements by the City to the portion of Marina Heights Loop Road which is inside the city limits, in conjunction with improvements proposed by the newly formed Marina Heights Special Road District.

Following a brief discussion, Councilor James moved to table this matter until such time as more information is available, which motion was seconded by Councillor Henry. The clerk called the roll with the following results:
