At 6:00 p.m., before the regularly scheduled meeting, a Council/Planning Commission joint work session was held with the following Planning Commissioners present: Commissioners Gorman, Fritz, Nishioka and Cofrances. Commissioners Mickelson, Davis and Freeman were not present. Councilors in attendance were Dentino, Kuhn, Curry, Johns Kern and Mayor Hagbom. City Attorney John Trew was present, as were City Planner John Bischoff, Special Projects Assistant Jeremy McVeety, Curry Coastal Reporter Brian Bullock, and three other citizens

Charles Kupper, Urban Renewal consultant with Spencer and Kupper, presented the draft Urban Renewal Plan and a draft Report on the Urban Renewal Plan. He briefly ran through the state requirements, background of work already accomplished, and covered the contents of the draft documents. He answered questions from the Commissioners and Councilors.

The Planning Commission will hold a public hearing on the draft plan August 6 where it will make a recommendation to the City Council. The City Council will hold public hearings August 12 and 26. The plan will be sent to all taxing bodies and to the community three to four weeks in advance of those dates.

After the joint work session the regularly scheduled City Council meeting was held.

IV. Ceremonies/Appointments/Announcements

A. Announcements

Police Chief Wallace introduced new officers Gregory Johnson and Marvin Parker. They both started work June 17. Gregory has been a police officer in Crescent City for the past four years and said he felt fortunate to get hired on the Brookings force. Marvin Parker was formerly the School Resource Officer for the Gold Beach Police Force and is now the Brookings School Resource Officer. He is replacing Curt Fox who is retiring. Parker has been in law enforcement for over 15 years. He explained his SRO philosophy.

Chief Wallace then introduced Officer Donny Dotson and Canine Officer Robby V.D. Lobo Hoeve. Dotson and Robby recently won awards at the Springfield Oregon Canine Police Competition. Dotson remarked it was rewarding coming from a small community and doing so well. He thanked the Council for their support and recognized Chief Wallace for his support and knowledge.

Councilor Johns Kerns asked if there would ever be a drug awareness program at the school, particularly at the middle school. Chief Wallace said SRO Parker would do this through a puppy program.

V. Oral Requests And Communications From The Audience

- A. Committee and Liaison reports
 - 1. Chamber of Commerce None
 - 2. Council Liaisons
 - a. Councilor Kuhn: She said it had been pretty quiet and thanked city staff for completing the Second Street project. It is working out well but it may need signs.
 - b. Councilor Johns Kern: She attended the school board meeting and last Wednesday took a tour of the school construction site.
 - c. Councilor Dentino: Dentino attend a Harbor Sanitary District meeting, a presentation to the Curry County Commissioners by Curry County Commission of Families, and staffed an AMF concert Sunday. He will be out of town for one week, starting June 25.
 - d. Councilor Curry-He will distribute copies of handouts from the June 13 and 14 OCZMA meeting. One item that was discussed in length, DLCD seeking comments on Goal 18 amendments (Beaches and Dunes), will affect Curry County. City managers up and down the coast have been watching this discussion. He commented there was little discussion on fisheries.

3. Unscheduled None

VI. Staff Reports

A. City Manager

1. "Amended Port Orford Landfill Trust Agreement," proposed by the Curry County Solid Waste/Recycling Committee.

City Manager Blodgett reported the 1993 agreement signed for closure and post-closure of the Port Orford landfill needed amended to meet DEQ requirements for 30 years post-closure monitoring. He proposed monitoring the agreement every 5 years or so to make sure no surplus funds had been collected.

Councilor Johns Kern moved, it was seconded, and the Council voted unanimously to approve the amended Port Orford Landfill Trust Agreement, to authorize the Mayor to sign the agreement, and to monitor the program in 5 years.

2. Downtown Parking

City Manager Blodgett reported Ordinance 157 gives the Council authority to establish parking limits on city streets and the one-hour parking on Chetco Avenue was set by resolution years ago. During the downtown development meetings merchants said one-hour parking does not give enough time to shop, eat, etc. Blodgett originally recommended drafting a resolution for consideration at the next Council meeting to change the parking limit on Chetco Avenue to two hours. However, after calls from merchants, he was changing that recommendation to no action now and when the new city downtown public parking lot and Kerr Hardware's parking lot were finished, the resolution to change parking limits would be brought before the Council

No action was taken.

The public parking lot being built by the city has encountered some delays because of the downtown master planning process. The City Engineer was in town today and working with conceptual designs from Urban Design Studios, is developing engineering and drainage plans. Blodgett and Mayor Hagbom met with Dr. Rush regarding a lease agreement to utilize adjoining property for public parking purposes. Application has been made to ODOT to close a portion of Fern Street behind the "triangle" for access into the parking lot. Major construction should be started in the next 60 days.

3. Other

The City Engineer met with city staff today to begin engineering Pioneer Road sidewalks and drainage. The goal is to have sidewalks done by beginning of school this August.

John Trew will not be at July 8 City Council meeting.

The Planning Commission is going to hear the Borax annexation application July 2. Blodgett cautioned Councilors to avoid ex parte contact with Borax representatives who will be in town for the hearings.

Blodgett stated the Port of Brookings Harbor is taking a lead to educate the public on the subject of Marine Reserves.

B. Finance Department

1. Refinance of police cars lease

Finance Director Hughes reported the city currently has a 36-month, 6% lease for four Police patrol vehicles. Chetco Federal Credit Union has offered to refinance the remaining 12 months at 2%. This will result in approximately \$250 savings over the remaining year and give the City the opportunity to do business locally.

Councilor Curry noted that on the loan transaction papers identical ID numbers were listed twice and Councilor Kuhn added that a third number was incorrect.

Councilor Dentino moved, it was seconded, and the Council voted unanimously to approve the refinance of four Police vehicles and to allow Mayor Hagbom to execute the loan documents after they have been checked for completeness and accuracy.

City Manager Blodgett explained the conflict that was found between the newly passed short-term rental ordinance and the existing transient room tax. This amendment to the transient room tax deletes wording waiving tax for private homes, vacation cabins or like facilities. It also added wording to waive transient tax during a local disaster or emergency if the rent is paid by a local agency. Mayor Hagbom called for City Manager Blodgett to read Ordinance No. 02-O-342.C in its entirety. He did so.

Councilor Kuhn, moved, it was seconded, and the Council voted unanimously to have the second reading of Ordinance No. 02-O-342.C, titled In the matter of an ordinance amending Ordinance No. 80-O-342, an ordinance providing for a six percent (6%) Transient Room Tax for the City of Brookings; providing administrative procedures for collection of same; and further, establishing violations of such and penalties therefore, by title only.

Blodgett read the ordinance by title only.

Councilor Johns Kern moved, it was seconded, and the Council voted unanimously to adopt Ordinance No. 02-O-342.C, titled In the matter of an ordinance amending Ordinance No. 80-O-342, an ordinance providing for a six percent (6%) Transient Room Tax for the City of Brookings; providing administrative procedures for collection of same; and further, establishing violations of such and penalties therefore.

Staff Present: City Manager Leroy Blodgett, Public Works Supervisor Dennis Barlow, Special Projects Assistant Jeremy McVeety, and Community Development Secretary Cathie Mahon.

Chair Boynton introduced Cathie Mahon as the new recording secretary, recently hired as Secretary for the Community Development department. Cathie moved to Brookings last year from Littleton, Colorado, where she worked for 14 years in the Community Development Department.

Public Appearances

Dennis Barlow, Public Works Supervisor, discussed a request from the adult softball association, for a shed at the Azalea Park field. An exhibit for an 8' x 8' shed, and placement on the field, was reviewed by the Commission. Dennis explained the request was due to some vandalism of equipment. He added the shed will be temporary until a permanent block-type shed is constructed at a later date.

Chetco Point Park: Commissioner Canfield reported on her research with CTR for a portapotty at the park. CTR quoted \$50.50 a month with bi-monthly emptying. She emphasized more emptying may be necessary depending on the volume of visitors and whale-watchers. Discussion ensued concerning placement, with input from Public Works Supervisor Barlow

and City Manager Blodgett. After further discussion City Manager Blodgett suggested that he direct city staff and work with them for appropriate placement.

Commissioner Canfield agreed to that suggestion and made a motion, it was seconded, and voted unanimously to follow the City Manager's suggestion.

Softball/Soccer Fields: Public Works Supervisor Barlow reported the flag pole at Bud Cross Park has been reinstalled, adding the fields are getting heavy usage.

Kidtown: None

Skate Park: City Manager Blodgett reported the final concrete work has been completed. He discussed the proposal to pave between the rest rooms and the park. This would be a flat area for those intimidated by the skate bowls; leave an area for the younger kids to practice skating. He further reported the cost involved, an injury that occurred with a worker, and the cost for grading and gravel. He advised everyone to get their skates waxed for the Skateboard Dedication, scheduled in conjunction with the Azalea Festival. He stated the dedication would be a short ceremony on Monday, May 26th, at 1:00 p.m., with Mayor Hagborn and Craig Mickelson saying a few words. He conveyed that there have been relatively few problems or complaints, any disruption is just "kids being kids".

Public Works Supervisor Barlow and City Manager Blodgett discussed the redirection of traffic for people entering the ball field parking area. The solution, approved by City Council, is to block the end of 2nd street. People going to the baseball games will then have to enter the parking lot from Hassett Street.

Special Projects Assistant Jeremy McVeety distributed a "Brookings/Harbor Community City Survey". He stated it was the final portion of the Parks Master Plan. Chair Boynton commended Jeremy stating "well done".

Liaison Reports

Azalea Park Foundation: Commissioner Williams reported the Park is looking gorgeous, and full of people enjoying the park. She added she shined the placards.

Staff Announcements/Concerns/Follow-ups

Financial Report: City Manager Blodgett discussed the budget print-outs included in the Commissioners packet. He stated the Capitol Improvement Plan, a 5-year plan, is being prepared and will be ready for the next meeting. He directed the Commission to the Personnel Services section stating 83% of the budget year is through, but 105% has been spent, due to skate park workers being employees; instead of contractors.

City Manager Blodgett discussed the Parks and Rec Department budget, directing the Commission to the figure of \$116,300. The major change for next year is the total figure changed from \$116,000 last year to \$79,000 because the swimming pool; budgeted at \$73,000, was made into its' own department in order to better track revenue and expenditures. The swimming pool is anticipated to run a \$40,000 deficient in the coming

fiscal year. He concluded by stating that the City needs to look at new ways (to generate monies) for things like new playground equipment.

City Manager Blodgett discussed the "Stout Park Trust Fund" print-out. Although there is a bottom line figure of \$18,430.00, the trust fund stipulates a provision that \$15,000 must always remain in the fund. He explained the difference between "appropriated end fund balances" which are not dedicated to any specific expenditure, and "unappropriated end fund balances" which are not appropriated; money that can not be spent.

With no further discussion on the budget, City Manager Blodgett stated "we're in pretty good shape" but generally speaking, it's a "bare bones budget".

Commissioner Canfield expressed the possibility of replacing old porcelin bowls with steel ones for the park restrooms. During her travels she has noticed the low maintenance on steel bathroom fixtures versus porcelin ones.

City Manager Blodgett mentioned the upcoming Azalea Festival, inviting folks to participate in the shrimp luncheon on Saturday. Noted also was the City's purchase of a new fire engine; money has been saved for 8 years, with a couple more years of payments.

Commissioner comments:

Commissioner Sherman suggested a parcel of land, on Wharf Street next to Chetco Point, as a good location for a swimming pool and community center. City Manager Blodgett countered that location because of the prohibitive cost; it would be several million dollars.

Commissioner Dori Blodgett commented how good the town looks for the Azalea Festival; it looks "shiny and spiffy". Commissioner Williams added the hope for good weather. Chair Boynton directed to Public Works Supervisor Barlow commending them for "beautifying" our town.

Commissioner Williams moved, it was seconded and the Commission voted unanimously to adjourn at 7:45 p.m.
