

#### V. SCHEDULED PUBLIC APPEARANCES

A. Nancy Osterbauer, Oregon Department of Agriculture—Update on Sudden Oak Death

Representing the U.S. Forest Service, Oregon State University, State Department of Forestry, and the Oregon Department of Agriculture, Nancy Osterbauer gave a report on sudden oak death including a history of the tree disease and efforts to eradicate it. A total of 40 acres, in ½ to 1 acre parcels of diseased trees were found in the south coast area. The disease had migrated to this area from sites around the San Francisco

Brookings Common Council Meeting Minutes August 26, 2002 - 7:00 p.m. Prepared by Linda Barker, Administrative Secretary Bay area of California, where it was first identified in 1995. The pathogen invades tanoak, native rhododendrons, and California Bay Laurel, girdling their trunks and killing the plants. Eradication methods are to cut infected trees to ground level and immediately burn the cut brush. These effects have been highly successful with infected areas dropping to 5 or less acres this year.

In answer to a question from the audience, Ms. Osterbauer responded the disease is spread from infected areas to other areas by rain splash, then soil being transported by foot traffic, and infected wood being cut for fire wood. They are also looking to see if the pathogen is spread by wind. Research on disease spread and eradication are ongoing.

#### VI. ORAL REQUESTS AND COMMUNICATIONS FROM THE AUDIENCE

- A. Committee and Liaison reports
  - 1. Chamber of Commerce

Les Cohen gave a short report. The Chamber Board voted to support the Rural Resources Alliance. Because of the Biscuit Fire the Chamber has postponed its September 8 golf tournament. Instead Salmon Run Golf Course will host a customer appreciation day with donations going to the firefighters. The Chamber has commissioned banners to hang across Highway 101 thanking the firefighters. Visitors have not been frightened away from the area by the fire news.

2. Council Liaisons
Councilor Kuhn-None

Councilor Johns Kern reported she has been busy with the school board oversight committee. Each Wednesday the group tours the school construction site. She reported there were many forwarded looking actions being taken by Pelican Bay Prison that would be announced by the warden soon. She enjoyed the volunteer/employee appreciation picnic and was pleased to be a part of it and very pleased at the choice of Volunteer and Employee of the year.

Councilor Dentino attended two Economic Development meetings; worked at the Summer Recreation Program track meet; worked two American Music Festival concerts and attended a county-wide ethics seminar in Gold Beach. He also attended a LOC telecommunications committee meeting in Springfield, acted as the Council liaison to both the Port of Brookings-Harbor and Harbor Sanitary District Board of Directors meetings; attended a community fisheries crises meeting, a water curtailment plan meeting and numerous fire informational meetings. He represented the Mayor at a South

Coast Humane Society candlelight vigil for homeless animals and represented the southern part of the county at the Commission on Children and Families meeting. He also attended the City's volunteer/employee appreciation picnic.

Councilor Curry: On August 7 he attended the South Coast Watershed Committee meeting and showed the Council a map of the Chetco River that the Watershed Council has developed and will be selling. The map shows were fishing holes are located along the river and is expected to be a hot seller.

Mayor Hagbom said he attended a great picnic and thanked those who worked so hard. He felt the Volunteer of the Year, Enos Muniz, was completely surprised. Muniz does a lot of work, contributing much to the City and certainly deserved the award. Employee of the Year Barbara Palicki works hard on and off the job and the award could not have gone to a more deserving employee. Police Chief Wallace and Lt. John Bishop were champs in the horseshoe tournament.

#### B. Unscheduled

- 1. Hope Hansen, 97832 Titus Lane, said she had gone to the school board several months ago regarding the dangerous corner at Pacific and Oak streets. They directed her to city. She was wondering what has been done to alleviate the conditions there and requested a four-way stop sign be placed at the intersection. City Manager Blodgett responded that an Ordinance to be considered later in the meeting forming a Traffic Safety Committee for the City would allow the City and citizens to address these concerns. There are concerns that stopping traffic at the intersection could cause more hazards. The situation is being monitored over the next few weeks.
- 2. Augie Kofoet, 797 Ransom Avenue, speaking on behalf of Businesses for a Better Brookings (B4BB), reported the Avenue of Flags would be presented twice in September, first on Labor Day and again on the eleventh, paying homage to those we lost on September 11, 2001, and thanking firefighters, police, and EMTs for doing such a great job. He invited the City and the Chamber of Commerce to assist in retiring flags for those two days. Councilors Kuhn and Johns Kern volunteered to help on the eleventh.

Kofoet passed out a list of flag donors for 2001, noting that each name listed had sponsored at least one flag, many had sponsored more. The list for 2002 is currently at the printers and is longer. He asked that we thank these people when we see them. The flag project, started by Don Nuss in 1999, should

Normally the flags fly for nine holidays each year; this year will have ten occasions. Kofoet showed a window sticker that sponsors of flags receive.

Kofoet also handed out a Flag Income Worksheet starting May 20, 1999, detailing costs and proceeds for the project. These sheet shows ½ of the proceeds distributed to the Vietnam Veterans Association.

He reported that Businesses for a Better Brookings sponsor flower boxes and place trash cans on Chetco Avenue, take care of public restrooms at the intown visitors center, and promote signage for tourists. The Farmers Market is not sponsored by B4BB as the Market is for-profit while B4BB is non-profit.

Mayor Hagbom asked if relations between the Vietnam Veterans and B4BB are still harmonious and received a positive answer from Kofoet: The veterans group will be putting flags out and they are happy with the breakout of expenses. City Manager Blodgett asked if the membership of the B4BB was still confidential. Kofoet replied that yes the membership is confidential as it is a private organization.

#### VII. STAFF REPORTS

- A. City Manager
  - 1. Parks Master Plan

Leroy presented an oral staff report on the Parks Master Plan. The P arks and Recreation Commission has been working on formulating a parks master plan for a number of years. Last year the City was able to retain the University of Oregon Community Planning Workshop to complete the plan, paying \$20,000 for work that would normally cost \$40,000 to \$50,000. Numerous public workshops were held and information from those workshops was incorporated into the plan which was recommended for approval by the Parks and Recreation Commission. The plan includes details of park inventories and results of a survey sent to 1200 households within the Urban Growth Boundary. The survey had a 30% return rate, an unusually high percentage. This plan will be used as a working model by the Parks and Recreation Commission.

Councilor Dentino moved, it was seconded, and the Council voted unanimously to adopt the Brookings Parks Master Plan.

City Manager Blodgett reminded Councilors of the public hearing on the completion of the periodic review process at the Brookings Inn Conference Center beginning at 9:00 a.m., Friday, August 30.

#### B. Police Department

1. Curry County 9-1-1Consolidation Plan

Police Chief Wallace commended Lt. John Bishop on the numerous hours that he and Captain Mark Metcalf of the Curry County Sheriff's Department had put into the state mandated consolidation of 9-1-1. Curry County is one of just two counties who have completed a plan. Clatsop County is the other one.

Lt. Bishop said that HB 3977 required consolidation of 9-1-1 centers into one center per county. September 1, 2002, was set as a deadline for plans to be completed or the state would devise a plan. Although there are remaining issues to work out in the proposed plan these are listed in the plan with a contingency clause starting implementation of the plan is dependent on the resolution of remaining issues.

Councilor Johns Kern moved, it was seconded, and the Council voted unanimously to approve the Curry County 9-1-1 Consolidation Plan.

effective date.

Chief Wallace introduced Officer Marvin Parker who is very familiar with traffic safety committees. Wallace commended Parker stating he does a professional and thorough job.

Officer Parker said a traffic safety committee is an excellent opportunity to form partnerships within the community. The traffic safety committee is a committee formed of citizens and members of the Council to investigate issues with vehicular, bicycle and pedestrian safety. The Committee hears concerns of citizens about traffic issues and interacts with boards and commissions. The City Council will make final decisions as to the Committee's recommendations. Having this Committee in place opens an opportunity to apply for grant funds. The first grants to be applied for would be to fund new video cameras for patrol cars and skate board and bicycle helmets to give to those in need.

City Manager Blodgett read Ordinance No. 02-O-552 in its entirety.

Councilor Kuhn moved, it was seconded and the Council voted unanimously to have the second reading of Ordinance No. 02-O-552 by title only.

#### B. Resolutions

1. In the matter of Resolution No. 02-R-707, a resolution authorizing the transfer of funds from the Oregon State Pool to Umpqua Bank.

Finance Director Hughes explained the City currently invests all of its non-operating cash in the Oregon State Pool. With interest rates decreasing dramatically over the last year from approximately 4% in July 2001 to 2% in July 2002, this investment is not as attractive as it once was. The City was approached by Umpqua Bank offering a fully liquid, collateralized money market account paying an interest rate 15 basis points greater than the State Pool. This could generate

up to an additional \$13,000 of investment income annually for the City. Other financial institutions were contacted to see if they had similar programs. Oregon State law prohibits public funds from being invested in member-owned credit unions. Umpqua Bank's offer was the best of those contacted. Staff recommended approval of Resolution 02-R-707 authorizing the transfer of funds from the Oregon State Pool to Umpqua Bank.

Councilor Johns Kern moved, it was seconded, and the Council voted unanimously to approved Resolution No. 02-R-707.

## PARKS AND RECREATION COMMISSION MEETING MINUTES City of Brookings 898 Elk Drive, Brookings, Oregon July 25, 2002 7:00 p.m.

#### Call To Order

Chair Boynton called the meeting to order with the pledge of allegiance led by Lisa Nowlin.

#### Roll Call

Commissioners Present: Nina Canfield, Dori Blodgett, Lorraine Williams, Bill Boynton, Tony Parrish, and Paul Prevenas.

Commissioners Absent: Pat Sherman

Councilor Liaison Present: Councilor Frances Johns Kern.

Ex Officio Commission Present: Lisa Nowlin.

Staff Present: City Manager Leroy Blodgett, Special Projects Assistant Jeremy McVeety, and Community Development Secretary Cathie Mahon.

#### **Minutes**

The minutes were approved 4-0 (Commissioners Parrish and Prevenas not present at June 27, 2002 meeting, and Commission Sherman absent from July meeting.)

#### **Public Appearances**

None.

#### **Committee Reports**

Stout Park: Tony Parrish briefly discussed a clean-up of the park in the winter.

Chetco Point Park: Commissioner Canfield stated she was planning on working with Pat Sherman to photograph and identify the wild flowers around the Point. She asked if there had been any information or follow-up on getting a bench at the site. City Manager replied he would look into the matter. (Secretary has address of the person who offered to provide a bench).

Softball/Soccer Fields: Paul Prevenas reported the fields have experienced heavy use this summer, especially with the recent tournaments.

Kidtown: Commission Dori Blodgett reported the "clean-up" day has been re-scheduled to the morning of August 10<sup>th.</sup>

Skate Park: City Manager Blodgett reported Mr. Michael Zing of Harbor gave the City \$3,000 to use toward paving the lower portion between the restrooms and the skate bowls. He explained that Mr. Zing was prompted by his young son who liked to skateboard but was wary about using his board in the bowls.

City Manager Blodgett discussed a grant on the "Social Impact of Skate Board Parks in Oregon". The individual working on that grant included our Skate Park in the report because it was rated as "the best park in Southwest Oregon". Interest in this sport had spurned this report because skateboarding has become the second most popular sport for kids.

He reported that City Council has the Park Master Plan on their August 26<sup>th</sup> agenda for review.

#### **Liaison Reports**

Azalea Park: City Manager Blodgett updated the Commission on the park project. Finances are: \$45,000 is from a grant, the Rotary Club has pledged \$4,000, and each Rotary member has pledged \$100, which should amount to another \$4,000. With approximately \$53,000 in cash, the project (restrooms and snack shack) has a solid start. South Coast Lumber has agreed to buy the logs. Money from the sale of the fir trees will pay for most of the costs of the new parking lot, which will be used for the softball fields and the band shell area. Donations include labor, and services such as CTR providing dumpsters for clean-up. The City will do the prep-work for the sewer system, contractors have been working on City projects at minimum costs, lumber has been donated, and volunteers perform the labor.

City Manager Blodgett circulated a blueprint of the project, discussed placement of the structures, and the plan to have the structure and roofing completed by late September, then work on the interior during the wet season.

Commissioner Parrish questioned if money was in the budget for maintenance. City Manager Blodgett answered the city will be responsible for the park maintenance. The Rotary will be responsible for the snack shack; they can rent out the facility for a special event or club, but are solely responsible for the clean-up.

Azalea Park Foundation: Commissioner Williams report the park is in great shape. Since the last meeting there have been two work parties; all the Rhodies have been trimmed up.

#### Staff Announcements/Concerns/Follow-ups

Financial Report: None available.

Parks & Fields Use Calendar Update: none

#### **Commissioner comments:**

Commissioner Prevenas discussed the consideration of additional fields being available once the construction at the schools is completed. He suggested the City and the school look into a partnership for two fields; something to consider next summer.

Commissioner Dori Blodgett proposed the Commission extend an invitation to Pam Calloway, for the August meeting, to report on the Summer Recreation Program. She suggested we honor her in recognition for a very successful summer program; over 400 children participated in the events and classes.

Commissioner Canfield expressed concern about children getting hurt from the broken-down logs and loose boards at Kidtown East Manor Park.

Commissioner Williams stated she was hoping there would be money left over from the \$45,000 (grant for the Azalea Park project). If any money is left over, it is used for new or revamping of the restrooms by Kidtown.

Commissioner Parrish commented on the possible formation of a Park District. Chair Boynton responded study of the CPW Master Plan be completed before going forward on that issue.

City Manager Blodgett discussed the August calendar. On August 12, 2002, a public hearing is scheduled for City Council to consider adoption of the *Brookings Urban Renewal Plan* report. A public hearing is scheduled for August 30, 2002, to review the UGB (Urban Growth Boundary) ordinances.

Also discussed were the open bids due for the *Pioneer Street* project (filling in the open ditches and putting in curb and gutter), and the *Municipal Parking Lot* on Chetco Avenue. Consideration of applying for a *Bicyling* grant, with up to \$250,000 available, is due by August 30, 2002.

Chairman Boynton presented Ex Officio Lisa Nowlin with a Certificate of Appreciation for her 2001-02 term. All Commissioners wished her well for starting college in August.

City Manager Blodgett reminded the Board about the City Picnic August 24th.

There being no further business, Commission Parrish moved to adjourn at 7:50 p.m.

#### Signage recommendation:

Chairman Gorman inquired about the status of the DIA'S (curbs and gutters) on Weaver Lane. He asked Planner Bischoff to continue to make the necessary contacts.

Planning Director Bischoff asked the members if they had filled out the form for the *training day*, scheduled for Saturday, September 21, 2002. He also reminded the members of the City picnic on Saturday, August 24<sup>th</sup>.
