After receiving a letter of resignation from Planning Commissioner Tom Davis, the City of Brookings now has one Planning Commissioner vacancy. The position's term (Pos. #4) expires April 1, 2005.

It is the policy of the City of Brookings that every vacancy on volunteer Boards and Commissions shall be made public so that interested citizens of the community may apply for appointment. Brookings Ordinance No. 483, the ordinance that regulates the Planning Commission, allows for two Commissioners to live outside the city limits and within the Urban Growth Boundary. BACKGROUND

Supporters of lily growers and fishing industries from Curry and Del Norte Counties have joined together to form the "Rural Resources Alliance." Information about the new organization is attached. At this time they are soliciting for membership to the organization. The memberships are for individuals, not businesses or organizations. The Port of Brookings-Harbor sponsored membership for their 24 employees and Commissioners. City staff recommendation is to sponsor membership for city councilors and the city manager. Cost of membership is \$25.00 per year for each individual.

Their first annual meeting is scheduled for 5:30 PM, October 29, 2002 at Ship Ashore.

Unless there is opposition or concern from City Council we will make application for membership for the city councilors and city manager.

Rural Resources Alliance

"To maintain and promote the wise use of our natural resource economy in

Curry & Del Norte Counties."

The name of this organization best describes our function: a group of people from Curry and Del Norte Counties who have come together to protect and enhance the economic, cultural and environmental facets of our region. Although we may be separated by a state line, we are united in the desire to protect jobs, enhance our rural culture and to continue to be good stewards of the land, air and water.

We are tired of being told by people or groups or governmental entities, without input from us, what we must do with our public and private lands. This interference has resulted in the loss of access and use of public and private natural resources. These outside interests have no stake in ownership or employment and seldom seek our input. As a result of this outside interference we have seen local industries decimated and the general decline of property rights. The loss of enterprise has meant the loss of our tax base putting our cities and counties at poverty's edge. The end result is discouragement and job loss. Behind every loss is the face of a family in despair. Human ecology must be part of the environmental equation.

The Alliance

We are members of the major economic underpinnings of Curry and Del Norte County. We are the men and women who have a stake in agriculture, business, fisheries, mining, timber, recreation and tourism. We are builders, tree farmers, and the numerous small businesses who respectfully use our many local natural resources. We are the Grange, the boater, the hunter, the hiker and everyone who enjoys and promotes the many benefits of rural living. We live here, we work here, we recreate here.

Alliance Structure

Any resident of Curry or Del Norte County can join the RRA. Those living outside of the two county area are welcome to join as well. There is a board of directors comprised of individuals from the major natural resource users and those who use our natural resources for recreation or relaxation. There is an executive director who is answerable to and employed by the board of directors.

What the Alliance Does

The Alliance will have several roles. The Alliance expects to educate each other on the problems (and solutions) faced by each natural resource user. A primary role will be to take political, legal or social action to protect our rural way of life. The Alliance expects to influence legislation on any level that impacts our economy, culture or environment. The Alliance expects to lend cross support to each industry or user group when needed. For example when fisheries interests are threatened then those involved in the agriculture, timber, business and tourism sectors will provide support as needed. Such support will show that any threat to a particular industry or group is a threat to everyone's rural way of life. The Alliance expects to show the interrelatedness between industries and groups. If jobs are lost, then groceries aren't purchased, homes aren't bought, taxes aren't paid and there is less demand for those who work in any support role. The Alliance will attempt to build bridges between the residents and businesses of Del Norte and Curry Counties.

Dale Niemie accepted a proclamation from Mayor Hagbom.

Brookings Common Council Meeting Agenda October 14, 2002 Prepared by Linda Barker, Administrative Secretary Niemie spoke about the Skills Center at South Coast Independent Living Center, a volunteer group headed by Liz Pendergrast and him. The group helps keep disabled people in their own homes and works with SSI and SSDI to keep these people employed without loosing medical care and income.

b. National Red Ribbon Week, October 20-27, 2002

Dave Ford of the Brookings Elks Lodge accepted a proclamation declaring the week of October 20-27, 2002, as Red Ribbon Week. Ford gave red ribbons to the Council and told about activities coming up to bring drug awareness to youth in Brookings. Sunday, October 20 kicks off Red Ribbon Week with a program at the Lodge. The Mayor will read the City's proclamation and local law enforcement will be in attendance including the Brookings Chief of Police, and representatives from the Curry County Sheriff's Department, Coast Guard and Pelican Bay Prison. Brookings Officer Donny Dotson will be there with K-9 Officer Robby. Ford stated they hope to get Brookings youth to the Lodge so they can become familiar with local law enforcement.

V. PUBLIC HEARING

A. In the matter of Ordinance No. 02-O-548.A—An Ordinance amending Ordinance No. 02-O-548, an Ordinance adopting revisions to the City of Brookings Comprehensive Plan pursuant to Task 2, 3 and 4 of Periodic Review Work Program (Order #00001) and (Order #00973) effective September 29, 2002, to amend Attachment G2, the Transportation Systems Plan.

A Legislative Public Hearing was opened by Mayor Hagbom at 7:15 p.m. City Manager Blodgett explained ODOT's request to insert language into the Transportation Systems Plan that would have required the City to do additional traffic analysis within a three year period. The City did not include the wording when Ordinance No. 02-O-548 was adopted as the City felt it was not its obligation to do the traffic analysis. ODOT filed an objection to the Transportation Systems Plan with the Department of Land Conservation and Development but later found they had another division doing this traffic analysis. The proposed Ordinance amendment inserts language stating ODOT is responsible for the traffic plan. Planning Director Bischoff had nothing to add. There was no testimony from the audience. The Public Hearing was closed at 7:20 p.m. No action was taken.

VI. ORAL REOUESTS AND COMMUNICATIONS FROM THE AUDIENCE

- A. Committee and Liaison reports
 - 1. Chamber of Commerce-None

2. Council Liaisons

Councilor Johns Kern attended a meeting at Pelican Bay Prison. Crescent City Councilors are also involved in the Pelican Bay Prison Advisory Council and Johns Kern found it interesting meeting and working with them. Brookings Councilors will tour the Prison October 15.

Mayor Hagbom added the Councilors will leave City Hall at 10:45 a.m. October 15 to be at the Prison for the 11:30 a.m. tour.

Councilor Dentino accompanied City Manager Blodgett to the League of Oregon Cities Legislative Session held last week in Tualatin. He also attended the League of Women Voters Candidates Forum, a ground breaking ceremony for the new concession/restrooms building at Azalea Park and a domestic violence awareness candlelight vigil. October 14 he attended a cultural diversity seminary hosted by the Oregon Department of Education.

On September 25, Councilor Curry attended a meeting of the Coos Curry Douglas Development Corporation. He also attended a Crimestoppers meeting, a Chetco Watershed Council meeting, and a working retreat for the South Coast Watershed Council.

Mayor Hagbom attended the League of Women Voters Candidates Forum, and the candlelight service at the Port where he read a City of Brookings Domestic Violence Awareness proclamation. He also attended the ground breaking for the concession stand/restrooms at Azalea Park.

B. Unscheduled

1. Augie Kofoet, 787 Ransom Avenue, asked why, after the sidewalks have been installed, is Pioneer Road not straight at the curb lines. He questioned who was responsible for not using eminent domain to acquire property to straighten the road at the edges. City Manager Blodgett answered the City was addressing the safety of pedestrians, mostly school children, while using a limited amount of money. There was not enough funding to acquire additional land and had there been, acquiring that land would have removed some off-street parking, landscaping and hedges. Kofoet stated it would have been better to do one side properly than two sides improperly. Blodgett said there was no onstreet parking lost as there were open ditches in the area before and the asphalt width was actually slightly wider than before the project began.

Councilor Dentino added this street has been bad, probably since it was first constructed, through many Mayors and Councils with no action, and he felt the children who use this street to walk to school are probably very happy with the sidewalks.

City Manager Blodgett invited Kofoet to come in and talk with staff about this matter.

2. Buzz Hansen, 97832 Titus Lane, asked about a review of a Stout Park drain line alongside the Presbyterian Church. The Church is planning an addition over the area where the drain line is located. Staff will look into this.

VII. STAFF REPORTS

- A. Finance Department.
 - 1. Pool Summary for Year 2002—Jeanne Nelson, Pool Supervisor. City Manager Blodgett introduced Jeanne Nelson who summarized the 2002 pool statistics. Nelson said the numbers were about the same as last year and considering the ash and smoke from the Florence Fire this was amazing. While the fire did affect general attendance, lesson enrollment, the most important thing the pool offers, was up.

In response to a question from Councilor Kuhn, Nelson responded that rates were the same as last year but approximately 40 more people took lessons this year than last. Nelson concluded by saying she had a great staff this year, her 24th season as Pool Supervisor.

- B. City Manager
 - 1. Voting Delegate for LOC Conference.

City Manager Blodgett recommended Mayor Hagbom as voting delegate and Council President Curry as alternate voting delegate for the business meeting to be held at the League of Oregon Cities Annual Conference in November. Blodgett explained everyone attending the conference can attend the business meeting and participate in discussions but each city has only one vote.

Councilor Johns Kern moved, it was seconded, and the Council voted unanimously to appoint Mayor Hagbom as voting delegate and Council President Curry as alternate voting delegate for the 2002 LOC Annual Business Meeting.

2. Other.

City Manager Blodgett reported the first November Council meeting is scheduled for the 11th and may need to be changed as

Councilors will have just returned from the LOC conference. He also explained the consent calendar approved during the September 9 meeting included an incorrect figure for the vouchers paid. This has been corrected and the consent calendar presented this meeting contains the correct August and September figures.

C. Community Development Department

1. Awarding of contract for pickup truck for Public Works. Community Development Director Lightle summarized the bids for a public works pickup truck and recommended purchasing the truck from Butler Ford, Ashland. The two bids received were from Butler Ford, \$16,150 and Coast Auto Center, \$17,458.

Councilor Kuhn moved, it was seconded, and the Council voted unanimously to award the purchase of a ¾ ton pickup truck to Butler Ford in the amount of \$16,150.

Awarding of contract for televising sewer lines-Community Development Director Lightle said the City advertised and opened bids for the televising and cleaning of 20,000 L.F. of sewer line. The City received three bids: TSR Corporation, \$20,400; Kottke Underground Technologies, Inc. \$20,450; and Spec Industries, \$25,020. Staff recommended awarding the contract to TSR Corporation for \$20,400.

Councilor Johns Kern moved, it was seconded, and the Council voted unanimously to award the contract for the Year 2002 Sewerline Cleaning and Televising Project to TSR Corporation in the amount of \$20,400.

Councilor Kuhn moved, it was seconded, and the Council voted unanimously to adopt Resolution No. 02-R-708, a Resolution encouraging Public Notification of Predatory Sex Offenders in Curry County.
