BACKGROUND

The City requested proposals to provide audit services of the City's financial statements. We received proposals from Wall & Wall of Coos Bay and Moss-Adams of North Bend. Finance Director, Randy Reed and I interviewed representatives and checked references of both firms.

We feel both firms are qualified and capable of providing the services required. The most significant difference in the two firms is their size. Moss-Adams is a regional office based out of Seattle. Wall & Wall is a local family operated firm.

The fee proposal from each firm is as follows:

Moss-Adams - Maximum audit fees not to exceed \$17,750 plus out of pocket travel expense. "The bid is for two years ending June 30, 2001 and June 30, 2002. As the City of Brookings is required to implement GASB 34 in the year 2003, we will negotiate a separate contract for implementation of GASB 34, dependent on the amount of time required to bring the City in compliance."

Additional services will be provided at the following hourly rates:

Wall & Wall - Maximum audit fees not to exceed \$15,685 all-inclusive.

"The methodology to be utilized in determining expected all-inclusive maximum fees for audit services for the ensuing two years ending June 30, 2002 and 2003, would be calculated using the same percentage increase as the Portland Consumer Price Index, for the respective period, and utilizing the above fiscal 2001 amount as the base year."

Additional services will be provided at the following hourly rates:

Senior Partner \$ 95 Partner \$ 85 Staff Accountant \$ 65 Assistants \$ 45 Clerical \$ 20

STAFF RECOMMENDATION

Based on the qualifications, interviews, references and fee proposals staff recommends the Council authorize staff to enter into an agreement with Wall & Wall to provide annual audit services for the City.

In anticipation of the 62nd Azalea Festival, scheduled for the Memorial Day Weekend, May 25th through the 28th, 2001, the Brookings-Harbor Chamber of Commerce asks the City to permit the following requests:

- 1. The closure of the Frontage Road in the area bordering Highway 101, in front of Chetco Pharmacy, Video and More and Western Bank (see attached map), from 5 p.m., Friday, May 25 to 7:00 p.m., Monday, May 28, 2001.
- 2. The closure of Ross Lane the area between Mory's and the entrance to Chetco Pharmacy & Gifts (see attached map), for the same time frame as in request #1.

BOTH OF THESE CLOSURES ARE TO INSURE PEDESTRIAN SAFETY. AN ADEQUATE EMERGENCY VEHICLE LANE WILL BE MAINTAINED.

- 5. Waiving requirement for the need for a Brookings Business License for Azalea Festival Street and Crafts Fair participants.
- 6. Waving the fee for the use of the Azalea Park Garden Area on Friday, May 25, 2001, for the Azalea Festival Mixer, and "Stage Under The Stars" for the Park Program component of the festival on Saturday, May 26, 2001 (please see attached "Park Use Application Form").
- 7. Declaring "No Parking" on Chetco Avenue during the hours of 8:00 a.m. through Noon, on Saturday, May 26, 2001, to coincide with the parade.

Page Two – 2001 Azalea Festival Requests

- 8. Use of parking area south of City Hall (between City Hall and the Elks Lodge), for use by non-profit organizations, to set up booths to promote their organizations as an expansion of the Street Fair. Access for emergency vehicles will be maintained.
- 9. Use of public right of way by fountain area adjacent to parking lot in front of Ray's #1, Hwy 101.

With the above requested assistance from the City of Brookings we are confident that this year's Azalea Festival, our community's 62nd, with its theme of "Brookings-Harbor Treasures" will again be a big success.

Issue: Vacation rentals.

Background: The city has recently received the attached letter of complaint about a single family home being used as a vacation rental. The complaints include late night arrivals,

noise, large groups with many cars, lack of respect for neighbors, and damage to a garden due to children, dogs and in one case a car backing into the neighbor's,

garden.

Although other communities along the Oregon coast have experienced significant problems related to vacation rentals, to staff's knowledge, this is the only complaint that the city has received. In response to problems arising from vacation rentals a number of cities have established ordinances that either totally prohibit them or place regulatory standards on them. If they are allowed or recognized as pre-existing non-conforming uses, most cities require a permit, apply standards and impose a bed tax.

At this time the number of dwelling units being used as vacation rentals within the city is unknown. Whether the dwelling subject to the complaint is an isolated case or a harbinger of things to come, is also unknown. If the Council determines that the vacation rental issue has the potential of becoming more problematic, there are two options in which staff can proceed as follows:

Regulation.

Establishing which zones they are allowed. Requiring a permit to operate a vacation rental Set standards for operation.

Impose bed tax.

Prohibit Outright.

Must recognize existing rentals and can:

Require a permit.

Set standards for operation.

Impose bed tax.

If desired, establish a sunset date at which all such use would cease.

Remedies for the specific complaints received by the city, in leu of any other regulatory ordinance, if they continue to occur, would fall under the city's nuisance ordinance and would most likely be handled by the police at the time of occurrence.

Recommendation: Direct staff and City Attorney to investigate the feasibility of creating an ordinance

to regulate vacation rentals within the city.

Dear Mr. Blogott,

This letter is pursuant to a conversation with you on March 6, 2001. This conversation was with regard to R1 zoning and the issue of vacation rentals.

I left your office and went to see City Planner, John Bishoff. I asked Mr. Bishoff if there was any city ordinance with regard to vacation rentals in a residential neighborhood. He apprised me that there are currently no restrictions but that it had become a problem in other seaside communities and that ordinances were passed to protect property owners from this intrusion of a business within a residential neighborhood and that such situations could merit restrictions in Brookings also. He further instructed me to write a letter to you in which I should state clearly my issues and you would present the matter to city council.

I feel it prudent to state clearly at this point that I feel fairly certain that the city has no way of knowing that a business is being carried on in a residential neighborhood without being apprised. Hence, this letter.

Almost nine years ago, I purchased the property known as 427 Buena Vista Loop in Brookings. I purchased this property for many reasons including the fact that is was a nice, quiet and hidden residential neighborhood with little traffic and zoned R1.

Approximately four years ago, a property; adjacent to my home and that shares a driveway with two other properties including mine, was sold to a family from Medford. These people have a business in Medford and their children attend school there also. I was of the impression that they had purchased the property known as 431 Buena Vista Loop as a weekend and vacation home for themselves. However, since the time of purchase, the owner and his family have spent very little time here and further, have listed it as a vacation rental with Property Management of Brookings and I think it safe to assume they also advertise for renters.

During the past four years, the peace and quiet I had previously enjoyed has been seriously compromised by this thriving and monetarily lucrative business. Renters arriving late at night using bright headlights looking for the address which is difficult to find since the home is not situated on the main part of Buena Vista Loop. It actually sits down a long drive and behind my home; making it difficult to find. These weekend or week renters have no vested interest in the

3-19-01 00-9 Bischoff, 9 Trem neighborhood and thus, they have little or no respect for the neighbors. Due to the close proximity of the rental to my home, I am most affected by this business. The absentee owners charge \$250 per night and I am guessing this is the reason that it is seldom rented by a single family but, instead, the renters come in groups to defray the cost. I have found children and dogs in my garden, I have had a baseball come flying onto my deck while I was resting.

Last weekend, there was a softball tournament in Brookings and there were six cars that showed up after 10 pm on Friday night. These people were outside partying even though it was rather cold. They were in and out all weekend; each time every car leaving and returning. Does this sound like a motel. I feel as though I have a motel right next door with only approximately 100 feet separating the properties. Yesterday, a renter backed her car over plants on my property. I was clearly not happy when I approached her about what she had done and she said "Don't get excited." I told her that I own the property and work hard to make my gardens and do not appreciate people who show so little regard for personal property. I phoned Property Management and was asked how much money I wanted to replace the plants. I was adamant about the fact that I was not looking for monetary compensation; but, that I wanted them to make it adamantly clear to the renters that they need to show respect for the neighbors and the neighbors property. Those plants were planted almost nine years ago and cannot be easily replaced due to size and further, I am insulted to think that all my hard work is thought to be so easily compensated with money. This winter, a neighbor caught renters making use of another neighbors seasoned madrone firewood stacked clearly not on the rental property. The owner of the firewood was compensated with \$50 for this abuse. At the time, the neighbor was concerned that we could not trust these renters to not steal other things. My point here is that I seriously doubt that a full time neighbor (even a long term renter or lease holder) would consider stealing his neighbors firewood.

On several occasions, I have spoken with the renters in an attempt to make them understand that this is my home and I dislike the noise and other intrusions. The response I get is indifference in the form of comments like "We cannot tell you how little we care how you feel" or "Hey, we are on vacation." These are just a few of the issues caused as a result of the vacation rental business carried on in my neighborhood which is zoned "non commercial".

The record will show that the rental of this property has escalated since even two years ago and even during this past winter, was rented many weekends. In my opinion, and that of many people I have spoken with, this is a viable business and does not have any place in a R1 zone. My understanding of this neighborhood zoning is that R1 means single family residential. Not a commercial business. There is no way this vacation rental can be considered anything less than a business and yet, here is the motel type establishment in a residential neighborhood. I cannot say enough about how outrageous this appears to me and others. If it was a "Bed and Breakfast", not only would the owners be present to monitor the actions of their guests; but also, the owners would be required to have the proper licensing and be obligated to abide with the requirements for such a business. However, non of these issues are a problem for my absentee neighbors as they are not required to be licensed and it is my belief that they could not operate a "B & B" in this R1 zone. This highly lucrative business is of no benefit to the city of Brookings and the owners pay only the property taxes for a single family residence in a residential zone. In my

opinion, in order for the City of Brookings to maintain the integrity of its zoning, such misuse of single family residential property must be eliminated. Had I known such a problem would arise in this R1 zone, I would never have purchased. As I have previously stated, John Bishoff indicated that just such issues have arisen in other coastal communities in Oregon and the city passed ordinances to protect homeowners from such businesses in residential neighborhoods.

This situation not only compromises the peaceful environment I previously enjoyed, but, also may cause devaluation of my property in particular due to the proximity of this business. I would be remiss in not disclosing to prospective buyers that there is a vacation rental business right in the back yard and the adverse effects of such a business.

In conclusion, I am requesting a hearing with the City Council in regard to this matter at the earliest convenience. I would also appreciate being notified of a date when this matter would be on the Council agenda.

I realize that I could simply appear at a Council meeting and table this issue as public input. However, I prefer to state clearly my issues in advance and give you the opportunity to look into this matter yourself and to add it to the Council agenda.

I shall look forward to hearing from you in the near future.

Thank you for your time and attention to this matter.

V. SCHEDULED PUBLIC APPEARANCES

A. City Engineer Richard Nored of HGE, Inc. - Water System Master Plan and Water Conservation Management Plan presentation
City Manager Leroy Blodgett introduced City Engineer Richard Nored of HGE,
Inc. to provide a brief summary of the Water Ststen Master Plan and Water
Conservation Management Plan. Mayor stated he would want to schedule a worksession for the near future to address these issues.

Nored advised Council a preliminary draft had been furnished approximately one year ago, then a finalized draft, and recently a final report was provided. At this meeting, the presentation is a highlight summary of what the final report says. This study provides a water system master plan and water conservation plan. Nored stated this is the first comprehensive analysis of the water system in Brookings, since 1976, and first comprehensive layout of water service level boundaries. Service level boundaries are important to assure water pressure to all residents of Brookings. Nored proceeded to present breakdown of needs and where those needs will take us for the future.

Discussion ensued, but Hagborn discussed the Harbor community's water use effecting our water system, which will be brought up at the future work session to be planned.

Executive Director Les Cohen of 324 So. Hazel, Brookings, was pleased to report the successful resurrection of the Beachcomber's Festival. He stated there were over 1000 people in attendance, and sees the festival becoming better each year. Cohen felt the time factor of Spring Break for schools in Oregon and California contributed this year and will in the future, for the success of this festival. He reported citizens had expressed their pleasure of the whale lights, which were a demonstration project. The time duration for the project has been extended through the month of May. Cohen ended his report by extending an invitation to the Council for April 7, 2001, at 1:00 p.m., for the dedication of the Oregon Heritage Tree Commemoration Ceremony, honoring the Bombsight Redwood, which Fujita planted in 1992. Additionally, Council was informed the Council General of Japan would be present, along with state and agency representatives including State Rep. Messerle. The ceremony will be at the Historical Marker Wayside at the triangle on Constitution Avenue and will be followed by a convoy tour to the tree site in the Siskiyou National Forest.

Councilor Johns attended the recent school board meeting, noting students and parents had behaved in a mannerly manner and had said properly their intent, which make more points with the Board than at previous meetings. This allowed the Board to respond positively and postpone action. The School Board advised they were pleased with positive behavior leading to better communication. Johns also attended the Parks and Recreation Commission and the Skate Park meeting, where she was pleased there wre six skateboarders present. She congratulated the Richard Gyuro for being the Chamber of Commerce's Volunteer of the year.

Councilor Kuhn attended HOPE (Healthy Opportunity for a Positive Environment) meeting and explained the make up of the organization to Council.

Councilor Curry continues to attend the Coos Curry Douglas Business Development Corporation each month.

Mayor Hagbom reminded Council members to be sure their Oregon Standards and Practices Commission Forms were completed and post marked no later than April 16, 2001. He advised the League Of Oregon Cities had sent notices offering workshops to review the ethics standards, however each year our own City Attorney reviews them with us. This will occur at the April 9, 2001, meeting. Hagbom stated he thought it was more important financially for our Councilors to attend the November Conference, which will include the ethics review, rather than try to attend both. Hagbom reported he had received quite an "education" from a recent workshop he attended through LOC, and felt he needed to apologize to our local library, Chetco Public Library, because he had learned not only are they "well and alive," but they are increasing in large numbers throughout our state and nation. Some discussion ensued regarding the importance of libraries.

B. Unscheduled

Richard Gyuro of 276 Allen Lane, Brookings, acknowledge Brookings citizen Peter Spratt who had received the Business of the Year award from the Chamber of

Commerce. Spratt was congratulated by Council.

Don Nuss, 808 Pioneer Rd, Brookings thanked the Chamber of Commerce for the successful Beachcomber's Festival. Nuss stated he was looking forward to the downtown study and made comments on the tourism application, noting concern over addendum C - item #12 of the contract. He asked Council in regards to the bed tax to require an auditing and separate checking accounts. There were no questions or comments from Council.

VII. STAFF REPORTS

A. City Manager

1. Consider tourism promotions proposals

City Manager Blodgett presented the Chamber of Commerce proposal for tourism, noting the request for proposal had been advertised with a deadline of March 20, 2001 at 4:00 p.m. Blodgett stated no other proposals other than the Chamber's had been received at that time nor had the City received any other requests for the proposal form. He stated the Chamber's proposal meets all criteria of requests and recommended Council direct staff to negotiate a contract. Discussion ensued between Council.

Councilor Kuhn moved, Councilor Johns seconded, and the Council voted unanimously to direct staff to negotiate a contract with the Brookings-Harbor Chamber of Commerce to provide promotions for the City of Brookings and present the draft contract for consideration at the April 23, 2001 regular Council meeting.

2. Other

City Manager Blodgett reported the Chetco Bridge lighting project is continuing to be worked on by ODOT with estimated costs of engineering around \$5000. However, some emergency situations have come up on Interstate Hwy I-5, which have higher priorities (bridges regarding weight restrictions) than the lighting of our bridge. But ODOT promises, we are not forgotten. Blodgett reported ODOT had received the final speed study at the north of town and will be reducing the speed limit to 35 mph from Ransom to about the Harris Beach Rest Area, indicating the remainder area will remain the same.

Blodgett reported the revamping of the City's Web Site is almost to the stage of publication. Our City staff have been working hard with Jim Relaford of PRN, Inc. who has provided us with lots of information and assistance. There will be links with the Chamber, the Port, Salmon Run Golf Course, and others - such as the League of Oregon Cities. Blodgett stated, it's very exciting to see it come together, and is hopeful the site will be published by Saturday @ www.brookingsor.org. He asked the Council

and public to know the site is not complete and will probably never be completed. It will always be developing as the go along with our activities. City Manager Blodgett announced the costs of \$3000 for the site will include the training of 3 staff to maintain it, with the exception of photos.

The <u>City Happenings Newsletter</u> goes out this Thursday, March 29th, and Blodgett asked Council to advise Sharon, if they had anything for the publication. Mayor Hagbom advised if anyone isn't getting it and wants it to contact the offices.

Blodgett concluded reporting on Community Development Director Leo Lightle's health conditions is very good and that staff was looking forward to his return.

Public Appearances

Nuss presented (1) Project Agenda and (2) Drawings for the benches, to be made using harvested logs, and would be in keeping with the natural setting. Committee agreed this would be acceptable and Mickelson would be working with Nuss in this project. Williams thanked Nuss and other youth for their contributions to the community.

Stout Park

REPORT OF THE PLANNING DIRECTOR

Director Bischoff reported the City applied for a \$50,000 rural development grant with a \$20,000 local match. The grant would be used to develop a master plan for development of the core area which is essentially that area covered by the PROUD Study. He attended, along with other city officials, a workshop pertaining to establishing tax increment districts.

He reported he may be bringing a change to the Land Development Code to the Commission next month to allow outdoor sales of items such as storage sheds from paved areas. Staff has discussed this possible change in site plan committee and therefore no action has been taken regarding the sheds for sale in the lot next to Carpenter Auto Sales.

The City and the Department of Land Conservation and Development received several letters of objection to the Urban Growth Boundary Remand. To save processing and review time the matter will be taken directly to the Land Conservation and Development Commission where it will be heard either May 3 or 4.

PROPOSITIONS AND REMARKS FROM COMMISSION MEMBERS

Commission Krebs asked that the Planning Commission receive a copy of the City Council Goals and a memo explaining the change in application of Deferred Improvement Agreements. She stated the DIA change may trigger changes in the Land Development Code. Bischoff said the LDC gives the option to grant DIAs so changes in the code may not be necessary.

Commissioner Nuss questioned staff about the seemingly mobile carports that have been installed at 602 Easy Street. Bischoff reported these meet the buildings code requirements and are anchored into the ground. The property owner is also building another rental unit on the lot.

Commissioner Collis inquired whether, in addition to the Commission informational packet as prepared now, the Planning Commission could receive a resume of the planning preceding the packet preparation: information on the site plan committee meeting or subdivision committee meeting held in conjunction with the application. Director Bischoff explained what information is discussed in

site plan and that many of the conditions of approval come from the site plan committee.

Commissioner Krebs mentioned watching the City Council meeting on Cable Channel 4 and seeing Building Official LauraLee Gray receive commendations from the Mayor for the good job she had done last year as president of the Southern Oregon Association of Building Officials.

Government Ethics

I am providing each of you copies of several sections of Chapter 244 of the Oregon Revised Statutes dealing with Government Standards of Practices. I encourage each of you to review the ORS and the Guide for Public Officials published by the Oregon Government Standards and Practices Commission. The Guide continues to be a very valuable source of information.

- Caution is always the best approach. To protect yourself from a potential 1. violation of the law, it is always best to refrain from doubtful activities.
- ORS 244.020 contains the definitions of "actual conflict of interest" and 2. "potential conflict of interest". An actual conflict of interest is any action or decision that "would" be to the private pecuniary benefit of the public official, a relative or a business with which the official is associated. A potential conflict of interest is any action or decision that "could" be to the private pecuniary benefit of the official, a relative or the official's business.
- ORS 244.120 describes the rules for public officials who have actual or potential conflicts of interest. The official must identify and publicly disclose the nature of the conflict, and, in the case of actual conflicts, refrain from participating in the discussion and the vote.
- ORS 244.040 contains the Code of Ethics for public officials and must always be carefully considered. "No public official shall use or attempt to use official position or office to obtain financial gain . . . ". The Code of Ethics uses the "but for" test

to help determine the proper course of action. These rules apply regardless of whether there is an actual or potential conflict.

- 5. ORS 244.050 sets forth a list of public officials who must file a statement of economic interest. Section 7 of ORS 244.050 authorizes a civil penalty for each day the statement of economic interest is late.
- 6. ORS 244.060 requires a public official to list any honoraria exceeding \$50 on the statement of economic interest. ORS 244.060(7).
- 7. ORS 244.130 requires the public body to record in its records the actual or potential conflict of interest disclosed by the public official, and how it was handled.
- 8. ORS 244.135 sets forth specific rules as to planning commission conflicts of interest. The planning commission is subject to the government ethics provisions of ORS Chapter 244.

Every ethics question is fact specific, making generalizations can be dangerous. Many times answers are not easy and may be unclear even after careful consideration. It is important to recognize the potential problem as soon as possible.

GENERAL PROVISIONS

- 244.010 Policy. (1) The Legislative Assembly hereby declares that a public office is a public trust, and that as one safeguard for that trust, the people require all public officials to adhere to the code of ethics set forth in ORS 244.040.
- (2) The Legislative Assembly recognizes that it is the policy of the state to have serving on many state and local boards and commissions state and local officials who may have potentially conflicting public responsibilities by virtue of their positions as public officials and also as members of the boards and commissions, and declares it to be the policy of the state that the holding of such offices does not constitute the holding of incompatible offices unless expressly stated in the enabling legislation.
- (3) Nothing in this chapter is intended to affect:
- (a) Any other statute requiring disclosure of economic interest by any public official or public employee.
- (b) Any statute prohibiting or authorizing specific conduct on the part of any public official or public employee. [1974 c.72 §§1,1a; 1987 c.566 §7]
- 244.020 Definitions. As used in this chapter, unless the context requires otherwise:
- (1) "Actual conflict of interest" means any action or any decision or recommendation by a person acting in a capacity as a public official, the effect of which would be to the private pecuniary benefit or detriment of the person or the person's relative or any business with which the person or a relative of the person is associated unless the pecuniary benefit or detriment arises out of circumstances described in subsection (7) of this section.
- (2) "Business" means any corporation, partnership, proprietorship, firm, enterprise, franchise, association, organization, self-employed individual and any other legal entity operated for economic gain but excluding any income-producing not-for-profit corporation that is tax exempt under section 501(c) of the Internal Revenue Code with which a public official is associated in a nonremunerative capacity.

- (3) "Business with which the person is associated" means any business of which the person or the person's relative is a director, officer, owner or employee, or agent or any corporation in which the person or the person's relative owns or has owned stock worth \$1,000 or more at any point in the preceding calendar year.
- (4) "Commission" means the Oregon Government Standards and Practices Commission.
- (5) "Development commission" means any entity which has the authority to purchase, develop, improve or lease land or the authority to operate or direct the use of land. This authority must be more than ministerial.
- (6) "Expenditure" has the meaning given that term in ORS 260.005.
- (7) "Potential conflict of interest" means any action or any decision or recommendation by a person acting in a capacity as a public official, the effect of which could be to the private pecuniary benefit or detriment of the person or the person's relative, or a business with which the person or the person's relative is associated, unless the pecuniary benefit or detriment arises out of the following:
- (a) An interest or membership in a particular business, industry, occupation or other class required by law as a prerequisite to the holding by the person of the office or position.
- (b) Any action in the person's official capacity which would affect to the same degree a class consisting of all inhabitants of the state, or a smaller class consisting of an industry, occupation or other group including one of which or in which the person, or the person's relative or business with which the person or the person's relative is associated, is a member or is engaged. The commission may by rule limit the minimum size of or otherwise establish criteria for or identify the smaller classes that qualify under this exception.
- (c) Membership in or membership on the board of directors of a nonprofit corporation that is tax-exempt under section 501(c) of the Internal Revenue Code.
- (8) "Gift" means something of economic value given to a public official or the public official's relative without valuable consideration of equivalent value, including the full or partial forgiveness of indebtedness, which is not extended to others who are not public officials or the relatives of public officials on the same terms and conditions; and something of economic value given to a public official or the public official's relative for valuable consideration less than that re-

quired from others who are not public officials. However, "gift" does not mean:

- (a) Campaign contributions, as described in ORS chapter 260.
 - (b) Gifts from family members.
- (c) The giving or receiving of food, lodging and travel when participating in an event which bears a relationship to the public official's office and when appearing in an official capacity, subject to the reporting requirement of ORS 244.060 (6).
- (d) The giving or receiving of food or beverage if the food or beverage is consumed by the public official or the public official's relatives in the presence of the purchaser or provider thereof.
 - (e) The giving or receiving of entertainment if the entertainment is experienced by the public official or the public official's relatives in the presence of the purchaser or provider thereof and the value of the entertainment does not exceed \$100 per person on a single occasion and is not greater than \$250 in any one calendar year.
- (9) "Honoraria" means a payment or something of economic value given to a public official in exchange for services upon which custom or propriety prevents the setting of a price. Services include, but are not limited to, speeches or other services rendered in connection with an event at which the public official appears in an official capacity.
- (10) "Income" means income of any nature derived from any source, including, but not limited to, any salary, wage, advance, payment, dividend, interest, rent, honoraria, return of capital, forgiveness of indebtedness, or anything of economic value.
 - (11) "Legislative or administrative interest" means an economic interest, distinct from that of the general public, in one or more bills, resolutions, regulations, proposals or other matters subject to the action or vote of a person acting in the capacity of a public official.
- (12) "Legislative official" means any member or member-elect of the Legislative Assembly, any member of an agency, board or committee that is part of the legislative branch and any staff person, assistant or employee thereof.
- (13) "Member of household" means any relative who resides with the public official.
- (14) "Planning commission" means a county planning commission created under ORS chapter 215 or a city planning commission created under ORS chapter 227.
 - (15) "Public official" means any person who, when an alleged violation of this chap-

- ter occurs, is serving the State of Oregon or any of its political subdivisions or any other public body of the state as an officer, employee, agent or otherwise, and irrespective of whether the person is compensated for such services.
- (16) "Relative" means the spouse of the public official, any children of the public official or of the public official's spouse, and brothers, sisters or parents of the public official or of the public official's spouse.
- (17) "Statewide official" means the Secretary of State or Secretary of State-elect, State Treasurer or State Treasurer-elect, Superintendent of Public Instruction or Superintendent-elect of Public Instruction, Attorney General or Attorney General-elect and the Commissioner of the Bureau of Labor and Industries or the Commissioner-elect of the Bureau of Labor and Industries.
- (18) "Zoning commission" means an entity to which is delegated at least some of the discretionary authority of a planning commission or governing body relating to zoning and land use matters. (1974 c.72 §2; 1975 c.543 §1; 1977 c.588 §2; 1979 c.666 §5; 1987 c.566 §8; 1989 c.340 §2; 1991 c.73 §1; 1991 c.770 §5; 1993 c.743 §8; 1995 c.79 §85; 1997 c.249 §75]

244.030 Application. Nothing in this chapter is intended to affect:

- (1) Any other statute requiring disclosure of economic interest by any public official or public employee.
- (2) Any statute prohibiting or authorizing specific conduct on the part of any public official or public employee. [1974 c.72 §24]
- 244.040 Code of ethics; prohibited actions; honoraria. The following actions are prohibited regardless of whether actual conflicts of interest or potential conflicts of interest are announced or disclosed pursuant to ORS 244.120:
- (1)(a) No public official shall use or attempt to use official position or office to obtain financial gain or avoidance of financial detriment that would not otherwise be available but for the public official's holding of the official position or office, other than official salary, honoraria, except as prohibited in paragraphs (b) and (c) of this subsection, reimbursement of expenses or an unsolicited award for professional achievement for the public official or the public official's relative, or for any business with which the public official or a relative of the public official is associated.
- (b) No statewide official shall solicit or receive, whether directly or indirectly, honoraria for the statewide official or for any member of the household of the official. No candidate for statewide office shall solicit or receive, whether directly or indirectly,

honoraria for the candidate or for any member of the household of the candidate.

- (c) No legislative official shall solicit or receive, whether directly or indirectly honoraria in an amount in excess of \$1,500 or in any amount for an appearance within the state or for an appearance during a legislative session, regardless of location, for the legislative official or for any member of the household of the official, except that a legislative official may solicit or receive honoraria for services performed in relation to the private profession or occupation of the legislative official. No candidate for legislative office shall solicit or receive, whether or indirectly, honoraria in an amount in excess of \$1,500 or in any amount for an appearance within the state for the candidate or for any member of the household of the candidate, except that a candidate for legislative office may solicit or receive honoraria for services performed in relation to the private profession or occupation of the legislative official.
- (d) Any public official not described in paragraph (b) or (c) of this subsection or a member of the public official's household may receive honoraria.
- (2) No public official or candidate for office or a relative of the public official or candidate shall solicit or receive, whether directly or indirectly, during any calendar year, any gift or gifts with an aggregate value in excess of \$100 from any single source who could reasonably be known to have a legislative or administrative interest in any governmental agency in which the official has or the candidate if elected would have any official position or over which the official exercises or the candidate if elected would exercise any authority.
- (3) No public official shall solicit or receive, either directly or indirectly, and no person shall offer or give to any public official any pledge or promise of future employment, based on any understanding that such public official's vote, official action or judgment would be influenced thereby.
- (4) No public official shall attempt to further or further the personal gain of the public official through the use of confidential information gained in the course of or by reason of the official position or activities of the public official in any way.
- (5) No person shall offer during any calendar year any gifts with an aggregate value in excess of \$100 to any public official or candidate therefor or a relative of the public official or candidate if the person has a legislative or administrative interest in a governmental agency in which the official has or the candidate if elected would have any

- official position or over which the official exercises or the candidate if elected would exercise any authority.
- (6) No person shall attempt to represent or represent a client for a fee before the governing body of a public body of which the person is a member. This subsection does not apply to the person's employer, business partner or other associate. [1974 c.72 §3; 1975 c.543 §2; 1987 c.566 §9; 1989 c.340 §3; 1991 c.146 §1; 1991 c.770 §6; 1991 c.911 §4; 1993 c.743 §9]
- 244.045 Regulation of subsequent employment of public officials. (1) A person who has been a Public Utility Commissioner, the Director of the Department of Consumer and Business Services, the Administrator of the Division of Finance and Corporate Securities, the Administrator of the Insurance Division, the Administrator of the Oregon Liquor Control Commission or the Director of the Oregon State Lottery shall not:
- (a) Within one year after the public official ceases to hold the position become an employee of or receive any financial gain, other than reimbursement of expenses, from any private employer engaged in the activity, occupation or industry over which the former public official had authority; or
- (b) Within two years after the public official ceases to hold the position:
- (A) Be a lobbyist for or appear as a representative before the agency over which the person exercised authority as a public official;
- (B) Influence or try to influence the actions of the agency; or
- (C) Disclose any confidential information gained as a public official.
- (2) A person who has been a Deputy Attorney General or an assistant attorney general shall not, within two years after the person ceases to hold the position, lobby or appear before an agency that the person represented while employed by the Department of Justice.
- (3) A person who has been the State Treasurer or the Chief Deputy State Treasurer shall not, within one year after ceasing to hold office:
- (a) Accept employment from or be retained by any private entity with whom the office of the State Treasurer or the Oregon Investment Council negotiated or to whom either awarded a contract providing for payment by the state of at least \$25,000 in any single year during the term of office of the treasurer;
- (b) Accept employment from or be retained by any private entity with whom the office of the State Treasurer or the Oregon Investment Council placed at least \$50,000

- f investment moneys in any single year uring the term of office of the treasurer; or
- (c) Be a lobbyist for an investment instintion, manager or consultant, or appear bere the office of the State Treasurer or Oregon Investment Council as a representative of an investment institution, manager consultant.
- (4) A public official who as part of the official's duties invested public funds shall not within two years after the public official ases to hold the position:
- (a) Be a lobbyist or appear as a representative before the agency, board or commission for which the former public official vested public funds;
- (b) Influence or try to influence the agency, board or commission; or
- (c) Disclose any confidential information ined as a public official.
- (5)(a) A person who has been a member the Department of State Police, who has ld a position with the department with the esponsibility for supervising, directing or administering programs relating to gaming a Native American tribe or the Oregon ate Lottery and who has been designated by the Superintendent of State Police by rule hall not, within one year after the member the Department of State Police ceases to ld the position:
- (A) Accept employment from or be reained by or receive any financial gain reded to gaming from the Oregon State stery or any Native American tribe;
- (B) Accept employment from or be remed by or receive any financial gain from private employer selling or offering to gaming products or services;
- (C) Influence or try to influence the ac-
- (D) Disclose any confidential information ained as a member of the Department of tate Police.
 - (b) This subsection does not apply to:
- (A) Appointment or employment of a erson as an Oregon State Lottery Commissioner or as a Tribal Gaming Commissioner regulatory agent thereof;
- (B) Contracting with the Oregon State attery as a lottery game retailer;
- (C) Financial gain received from personal ming activities conducted as a private citer; or
- (D) Subsequent employment in any caty by the Department of State Police.
- (c) As used in this subsection, "Native regican tribe" means any recognized Na-American tribe or band of tribes au-

thorized by the Indian Gaming Regulatory Act of October 17, 1988 (Public Law 100-497), 25 U.S.C. 2701 et seq., to conduct gambling operations on tribal land. [1987 c.360 §1; 1993 c.743 §10; 1995 c.79 §86; 1997 c.750 §1]

REPORTING

244.050 Persons required to file statement of economic interest; filing deadline; civil penalty. (1) On or before April 15 of each year the following persons shall file with the Oregon Government Standards and Practices Commission a verified statement of economic interest as required under this chapter:

- (a) The Governor, Secretary of State, State Treasurer, Attorney General, Commissioner of the Bureau of Labor and Industries, Superintendent of Public Instruction, district attorneys and members of the Legislative Assembly.
- (b) Any judicial officer, including justices of the peace and municipal judges, except municipal judges in those cities where a majority of the votes cast in the subject city in the 1974 general election was in opposition to the ballot measure provided for in section 10, chapter 68, Oregon Laws 1974 (special session), and except any pro tem judicial officer who does not otherwise serve as a judicial officer.
- (c) Any candidate for an office designated in paragraph (a) or (b) of this subsection.
 - (d) The Deputy Attorney General.
- (e) The Legislative Administrator, the Legislative Counsel, the Legislative Fiscal Officer, the Secretary of the Senate and the Chief Clerk of the House of Representatives.
- (f) The Chancellor and Vice Chancellors of the State System of Higher Education and the President and Vice Presidents, or their administrative equivalents, in each institution under the jurisdiction of the State Board of Higher Education.
 - (g) The following state officers:
 - (A) Adjutant General.
 - (B) Director of Agriculture.
- (C) Manager of State Accident Insurance Fund Corporation.
 - (D) Water Resources Director.
- (E) Director of Department of Environmental Quality.
- (F) Director of Oregon Department of Administrative Services.
- (G) Director of the Oregon State Fair and Exposition Center.
 - (H) State Fish and Wildlife Director.
 - (I) State Forester.
 - (J) State Geologist.

- (j) Every member of a city or county planning, zoning or development commission except such members in those cities or counties where a majority of votes cast in the subject city or county at any election on the issue of filing statements of economic interest under this chapter was in opposition to the ballot measure provided for in section 10, chapter 68, Oregon Laws 1974 (special session).
- (k) The chief executive officer of a city or county who performs the duties of manager or principal administrator of the city or county except such employees in those cities or counties where a majority of votes cast in the subject city or county in an election on the issue of filing statements of economic interest under this chapter was in opposition.
- (L) Members of local government boundary commissions formed under ORS 199.410 to 199.519.
- (m) Every member of a governing body of a metropolitan service district and the executive officer thereof.
- (n) Each member of the board of directors of the State Accident Insurance Fund Corporation.

- (0) The chief administrative officer and the financial officer of each common and union high school district, education service district and community college district.
- (p) Every member of the following state boards and commissions:
 - (A) Capitol Planning Commission.
- (B) Board of Geologic and Mineral Industries.
- (C) Oregon Economic and Community Development Commission.
 - (D) State Board of Education.
 - (E) Environmental Quality Commission.
- (F) Fish and Wildlife Commission of the State of Oregon.
 - (G) State Board of Forestry.
- (H) Oregon Government Standards and Practices Commission.
 - (I) Oregon Health Council.
 - (J) State Board of Higher Education.
 - (K) Oregon Investment Council.

- (q) The following officers of the State Treasury:
 - (A) Chief Deputy State Treasurer.
- (B) Executive Assistant to the State Treasurer.
 - (C) Director of the Investment Division.
- (2) By April 15 next after the date an appointment takes effect, every appointed

public official on a board or commission listed in subsection (1) of this section shall file with the commission a statement of economic interest as required under ORS 244.060, 244.070 and 244.090.

- (3) By April 15 next after the filing date for the biennial primary election, each candidate for elective public office described in subsection (1) of this section shall file with the commission a statement of economic interest as required under ORS 244.060, 244.070 and 244.090.
- (4) Within 30 days after the filing date for the general election, each candidate for elective public office described in subsection (1) of this section who was not a candidate in the preceding biennial primary election shall file with the commission a statement of economic interest as required under ORS 244.060, 244.070 and 244.090.
- (5) The Legislative Assembly shall maintain a continuing review of the operation of this chapter and from time to time may add to or delete from the list of boards and commissions in subsections (1) to (3) of this section as in the judgment of the Legislative Assembly is consistent with the purposes of this chapter.
- (6) Subsections (1) to (5) of this section apply .nly to persons who are incumbent, elected or appointed officials as of April 15 and to persons who are candidates for office on April 15. Those sections also apply to persons who do not become candidates until 30 days after the filing date for the statewide general election.
- (7)(a) Failure to file the statement required by this section subjects a person to a civil penalty that may be imposed as specified in ORS 183.090, but the enforcement of this subsection does not require the Oregon Government Standards and Practices Commission to follow the procedures in ORS 244.260 before finding that a violation of this section has occurred.
 - (b) Failure to file the required statement in timely fashion shall be prima facie evidence of a violation of this section.
 - (c) If within five days after the date on which the statement is to be filed under this section the statement has not been received by the commission, the commission shall notify the public official and give the public official not less than 15 days to comply with the requirements of this section. If the public official fails to comply by the date set by the commission, the commission may impose a civil penalty of \$5 for each day the statement is late beyond the date fixed by the commission. The maximum penalty that may be accrued under this section is \$1,000.

- (d) A civil penalty imposed under this subsection is in addition to and not in lieu of sanctions that may be imposed under ORS 244.380. - 244.055 Additional reporting requirements for State Treasury; confidentiality; effect of failure to comply with requirements. (1) In addition to the statement required by ORS 244.050, the State Treasurer and any person listed under ORS 244.050 (1)(q) and this subsection shall file quarterly at a time fixed by the State Treasurer a trading statement listing all stocks, bonds and other types of securities purchased or sold during the preceding quarter:
- (a) Directors of the Cash Management Division and the Debt Management Division.
- (b) Equities, fixed income, short term fund, real estate, equities real estate and commercial and mortgage real estate investment officers and assistant investment officers.
- (c) Fixed income and short term fund investment analysts.
- (2) The statement required by subsection (1) of this section shall be filed for review with the State Treasurer, the Attorney General and the Division of Audits of the office of the Secretary of State. The content of the statement is confidential.
- (3) If the State Treasurer or the Chief Deputy State Treasurer determines that a conflict of interest exists for an officer or employee, the State Treasurer shall subject the person to appropriate discipline, including dismissal or termination of the contract, or both, pursuant to rule. If the State Treasurer has cause to believe that a violation of this chapter has occurred, the State Treasurer shall file a complaint with the Oregon Government Standards and Practices Commission under ORS 244.260.
- (4) If the State Treasurer fails to act on an apparent conflict of interest under subsection (3) of this section or if the statement of the State Treasurer or the Chief Deputy State Treasurer appears to contain a conflict of interest, the Director of the Division of Audits shall report the failure or apparent conflict to the Attorney General, who may file a complaint with the commission.
- (5) A person filing the statement required by subsection (1) of this section must verify that the statement is complete and accurate. A person who intentionally fails to file a complete and accurate statement commits a

Class C felony and may also be subject to ORS 162.075. [1993 c.743 §26]

- 244.060 Form of statement of economic interest. The statement of economic interest filed under ORS 244.050, shall be on a form prescribed by the Oregon Government Standards and Practices Commission, and the person filing the statement shall supply the information required by this section and ORS 244.090, as follows:
- (1) The name of all positions as officer of a business and business directorships held by the person or a member of the household of the person during the preceding calendar year.
- (2) All names under which the person and members of the household of the person do business.
- (3) Sources of income received at any time during the preceding calendar year by the person or a member of the household of the person that produce 10 percent or more of the total annual household income.
- (4) The name, principal address and brief description of the source of income from which 50 percent or more of the total annual income of the person and members of the household of the person was received during the preceding calendar year and whether the source existed during the preceding year, and whether the source is derived from an entity that now does business or could reasonably be expected to do business or has legislative or administrative interest in the governmental agency of which the public official is or the candidate if elected would be a member or over which the public official has or the candidate if elected would have authority.
- (5)(a) The listing of all real property in which the public official or candidate therefor or a member of the household of the public official or candidate has or has had any personal, beneficial ownership interest during the preceding calendar year, any options to purchase or sell real property, including a land sales contract, and any other rights of any kind in real property located within the geographic boundaries of the governmental agency of which the public official is or the candidate if elected would be a member or over which the public official has or the candidate if elected would have authority.
- (b) This subsection does not require the listing of the principal residence of the public official or candidate.
- (6)(a) Notwithstanding ORS 244.020 (8)(c), if a public official has received food, lodging and payment of travel expenses exceeding \$100 when participating in an event which bears a relationship to the public official's

- office and when appearing in an official capacity, the name, nature and business address of the organization paying the expenses and the date and amount of that expenditure.
- (b) Beginning on July 1, 1992, the dollar amount specified in paragraph (a) of this subsection shall be adjusted annually by the commission based upon the change in the Portland Consumer Price Index for All Urban Consumers for All Items as prepared by the Bureau of Labor Statistics of the United States Department of Labor or its successor during the preceding 12-month period. The amount determined under this paragraph shall be rounded to the nearest dollar.
- (7) Any honoraria exceeding \$50 received during the preceding calendar year by the person or a member of the household of the person, the payer of the honoraria and the date and time of the event for which the honoraria was received. [1974 c.72 §5; 1975 c.543 §4; 1987 c.566 §11; 1991 c.770 §7; 1993 c.743 §12]
- 244.070 When additional statement of economic interest required. The following additional economic interest shall be reported for the preceding calendar year only if the source of that interest is derived from an individual or business which has been doing business, does business or could reasonably be expected to do business with or has legislative or administrative interest in the governmental agency of which the public official is or the candidate if elected would be a member or over which the public official has or the candidate if elected would have authority:
- (1) Each source of income over \$1,000, other than a source of income disclosed under ORS 244.060, whether or not taxable, received by the public official or candidate therefor or a member of the household of the public official or candidate.
- (2) Each person to whom the public official or candidate therefor or a member of the household of the public official or candidate owes or has owed money in excess of \$1,000, the interest rate thereon and the date of the loan, except for debts owed to any federal or state regulated financial institution or retail contracts.
- (3) Each business, principal address, and brief description of its nature, in which the public official or candidate therefor or a member of the household of the public official or candidate has or has had a personal, beneficial interest or investment, including stocks or other securities, in excess of \$1,000, except for individual items involved in a mutual fund or a blind trust, or a time or demand deposit in a financial institution, shares in a credit union, or the cash surrender value of life insurance.

(4) Each person for whom the public official or candidate has performed services for a fee in excess of \$1,000 except for any disclosure otherwise prohibited by law or by a professional code of ethics. [1974 c.72 §6; 1975 c.543 §5; 1987 c.566 §12]

244.080 Filing of different form allowed by rule. The Oregon Government Standards and Practices Commission by rule may accept the filing of a form containing less than the information required under ORS 244.060 and 244.070 if the public official certifies thereon that the information contained on the form previously filed is unchanged. If any portion of the information contained in the filing is changed, the public official may certify only as to the changed material. [Subsection (1) enacted as 1974 c.72 §8; subsection (2) enacted as 1975 c.543 §7(1); 1977 c.588 §4; 1987 c.566 §13]

244.090 Report on association with compensated lobbyist. (1) Each public official of this state or candidate required to make a statement of economic interest shall report by name any compensated lobbyist who, during the preceding calendar year, was associated with a business with which the public official or candidate or a member of the household of the public official or candidate was also associated. Holding stock in a publicly traded corporation in which the lobbyi. also holds stock is not a relationship for which a statement is required.

- (2) As used in this section "lobbyist" has the meaning set forth in ORS 171.725. [1974 c.72 §7; 1975 c.543 §6; 1987 c.566 §14]
- 244.100 Disclosure of gifts or other compensation; exemptions from gift limitation. (1) The Oregon Government Standards and Practices Commission by rule may require the disclosure and reporting of gifts or other compensation made to or received by a public official or candidate for elective office.
- (2) The commission by rule may exempt rom the gift limitation contained in ORS 244.040, any gift of food or beverage but may require that when gifts of food or beverage exceed a dollar amount fixed by the commission, the source thereof shall be disclosed on a form prescribed by the commission.
- (3) In addition to any disclosures or reports required under subsections (1) and (2) of this section, any person or organization that provides a public official with food, odging or travel expenses exceeding \$50, as lescribed in ORS 244.060 (6), shall notify the public official in writing of the amount of the expense. The notice shall be sent to the public official within 10 days from the date such expenses are incurred. [1975 c.543 §11; 1991 c.677 §1]

244.110 Required statements subject to penalty for false swearing. (1) Any statement of economic interest required to be filed by ORS 244.050, 244.060, 244.070, 244.080, 244.090 or 244.100 shall contain or be verified by a written declaration that it is made under the penalties of false swearing. Such declaration shall be in lieu of any oath otherwise required.

(2) No person shall willfully make and subscribe any return statement or other document which contains or is verified by a written declaration that it is made under penalties for false swearing, which the person does not believe to be true and correct to every matter. [1974 c.72 §22; 1977 c.588 §5]

244.115 Filing required for member of Congress or candidate; filing date. Each member of Congress from this state and each candidate for a seat in Congress from this state shall file with the Oregon Government Standards and Practices Commission a copy of the federal ethics filing required under federal law or by congressional rule within 30 days after the filing date required under federal law or congressional rule. If the filing is not made in a timely manner, the commission shall obtain copies of the filing and indicate thereon that the filing was not made with the commission by the member of Congress or candidate. All such filings are public records available for public inspection. [1991

METHOD OF HANDLING ACTUAL OR POTENTIAL CONFLICTS

244.120 Methods of handling conflicts; generally; application to elected officials or members of boards. (1) Except as provided in subsection (2) of this section, when met with an actual or potential conflict of interest, a public official shall:

- (a) If the public official is a member of the Legislative Assembly, announce publicly, pursuant to rules of the house of which the public official is a member, the nature of the conflict before taking any action thereon in the capacity of a public official.
- (b) If the public official is a judge, remove the judge from the case giving rise to the conflict or advise the parties of the nature of the conflict.
- (c) If the public official is any other appointed official subject to this chapter, notify in writing the person who appointed the public official to office of the nature of the conflict, and request that the appointing authority dispose of the matter giving rise to the conflict. Upon receipt of the request, the appointing authority shall designate within a reasonable time an alternate to dispose of the matter, or shall direct the official to dis-

pose of the matter in a manner specified by the appointing authority.

- (2) An elected public official, other than a member of the Legislative Assembly, or an appointed public official serving on a board or commission, shall:
- (a) When met with a potential conflict of interest, announce publicly the nature of the potential conflict prior to taking any action thereon in the capacity of a public official; or
- (b) When met with an actual conflict of interest, announce publicly the nature of the actual conflict and:
- (A) Except as provided in subparagraph (B) of this paragraph, refrain from participating as a public official in any discussion or debate on the issue out of which the actual conflict arises or from voting on the issue.
- (B) If any public official's vote is necessary to meet a requirement of a minimum number of votes to take official action, be eligible to vote, but not to participate as a public official in any discussion or debate on the issue out of which the actual conflict arises.
- (3) Nothing in subsection (1) or (2) of this section requires any public official to announce a conflict of interest more than once on the occasion which the matter out of which the conflict arises is discussed or debated.
- (4) Nothing in this section authorizes a public official to vote if the official is otherwise prohibited from doing so. [1974 c.72 §10; 1975 c.543 §7; 1987 c.566 §15; 1993 c.743 §15]
- 244.130 Recording of notice of conflict; effect of failure to disclose conflict. (1) When a public official gives notice of an actual or potential conflict of interest, the actual or potential conflict shall be recorded in the official records of the public body, and a notice of the actual or potential conflict and how it was disposed of may in the discretion of the public body be provided the Oregon Government Standards and Practices Commission within a reasonable period of time. The commission may by rule establish criteria for cases in which such information shall, shall not, or may be provided to it.
- (2) No decision or action of any public official or any board or commission on which the public official serves or agency by which the public official is employed shall be voided by any court solely by reason of the failure of the public official to disclose an actual or potential conflict of interest. [1974 c.72 §11; 1975 c.543 §8; 1993 c.743 §16]

244.135 Method of handling conflicts by planning commission members. (1) A member of a city or county planning commission shall not participate in any commission proceeding or action in which any of the following has a direct or substantial financial interest:

- (a) The member or the spouse, brother, sister, child, parent, father-in-law, mother-in-law of the member;
- (b) Any business in which the member is then serving or has served within the previous two years; or
- (c) Any business with which the member is negotiating for or has an arrangement or understanding concerning prospective partnership or employment.
- (2) Any actual or potential interest shall be disclosed at the meeting of the commission where the action is being taken. [Formerly 215.035 and 227.035]

APPLICATION OF REPORTING REQUIREMENTS TO LOCAL GOVERNMENTS

244.160 Application to political subdivisions except cities and counties. Any political subdivision in this state other than a city or county by resolution may require any public official of the subdivision to file a verified statement of economic interest. The filing shall be made with the Oregon Government Standards and Practices Commission. A copy of the ordinance shall be filed with the commission. [1974 c.72 §9]

244.170 "Statement of economic interest" defined. As used in this chapter, "statement of economic interest" means a statement as described by ORS 244.060 to 244.080. [1975 c.216 §1a]

244.180 When city officials required to file statement. (1) As used in this section, "public officials of a city" means each person holding an elective city office; each member of a city planning, zoning or development commission; and the chief executive officer of the city who performs the duties of manager or a principal administrator of the city.

(2) Public officials of a city are required to file a statement of economic interest with the Oregon Government Standards and Practices Commission if a majority of the votes cast by the electors of the city voting at the election as provided for in ORS 244.201 is in favor thereof. 244.190 When county officials required to file statement. (1) As used in this section, "public officials of a county" means each person holding an elective county office; each member of a county planning, zoning or development commission; and the
