BACKGROUND

Below is the report presented to the Skate Park Committee, and an insert to the Parks & Recreations Commission. There was plenty of discussion at both meetings among members and the audience. The Skate Park Committee voted unanimously to recommend to the Parks & Rec Commission Dreamland to construct the skate park. The Parks & Rec Commission by a vote of 4-2 to approve and forward to City Council the Committee's recommendation. It is now up to City Council of how to proceed with the project.

Also included in the council packet is a letter of recommendation from the City Administrator of Aumsville.

RECOMMENDATION

The Skate Park Committee and the Parks and Rec Commission recommend hiring members of Dream Land as city employees to construct the Skate Park.

Staff did not make a recommendation to the Committee or the Commission, however staff supports their decisions.

Provided for Parks & Recreations Commission

The following is a report that was provided to the Skate Park Committee on June 20, 2001. There was extensive discussion by the committee and audience regarding the advantages and disadvantages of the available options. The Committee determined that the project is unique and needs a unique team to design and construct the skate park. The Skate Park Committee recommended that Dreamland be hired as city employees to build the park. They also decided the corner of Hasset and Third Street is the best location for the park.

The Park & Recreation Commission's recommendation, along with the recommendation of the Skate Park Committee, will be taken to the City Council on July 9, 2001.

BACKGROUND

We have received information from Dreamland (Mark Scott) and Purkiss-Rose. Dreamland has built skate parks in Aumsville, Lincoln City, Newport, Redmond and others. Purkiss-Rose has designed skate parks in Oregon City, Tualatin, LaGrand and others in California and Washington.

Dreamland designs and constructs skate parks. Because they do not have the capability to provide performance bonding, they often become city employees instead of independent contractors. This avoids the requirements of performance bonding, Davis Bacon Act and other reporting. By hiring them as employees the requirement of the public bidding process is avoided. The design of the park is done on-site as it is being constructed.

Purkiss-Rose provides detailed design and bidding documents. They require an outside contractor to provide performance bond and meet all federal, state and local public contracting laws.

It is time to make a decision on how to proceed. The options are to hire the Dreamland group as employees or contract with someone like Purkiss-Rose. Each option has its advantages and disadvantages. Hiring Dreamland as employees has some risks, but may be less expensive. Contracting with Purkiss-Rose eliminates the risk factors, but the costs increase. I have attempted to explain the disadvantages and advantages below:

DREAMLAND

DISADVANTAGES/RISKS

As employees, they can file for unemployment, if weather or other conditions cause delays preventing them from working.

If someone is injured, the City's insurance will be liable. This could cause an increase in the City's insurance premium, now or later.

There is no guarantee that the park will be finished, because there is no contract or performance bond. As employees, they can quit whenever they wish.

Although they have promised to work within the budget, there is not a solid price for the finished product or a known design before starting. In other words, we are not sure exactly what it will look like or what it will cost until it is completed. Additionally, without a contract there is no completion date stipulation.

They have indicated they would start the park in October and finish in approximately sevenweeks. However, without a contract and performance bond there is no guarantee when it will begin or if it will be finished, nor is there any avenue in which to address problems after the project is completed.

The cost estimates they provided for labor would actually be about 30% more due to the cost of benefits such as workman's comp, social security, etc.

ADVANTAGES

The most significant advantage is the cost. It is likely that the park would be less expensive by avoiding some of the bonding, insurance and reporting requirements. The savings could be used to expand the size of the park or to add features such as parking, landscaping or fencing.

PURKISS-ROSE (or a similar firm)

DISADVANTAGES – RISKS

The most significant disadvantage is the opposite of the above advantages. By complying with all public contracting laws, the cost will increase, but those costs will be factored into their bid.

ADVANTAGES

Meeting all the requirements for public contracting eliminates most of the risk factors.

The City gets a quality skate park without the liability or risk.

A performance bond will guarantee the completion and will guarantee the quality for one year after completion.

With an adequate design, it may be possible to use local contractors for all or part of the construction.

CONCLUSION

I am not comfortable with making a recommendation as to which way to proceed with the project. If left to my discretion, I would have no option but to choose the one with the least risk in order to protect the City. I will support whatever decision is made, but the appointed committees and elected officials need to decide the level of risk they are willing to take.

I am confident that Dreamland would provide a quality skate park at a reasonable expense. However, we have no guarantee.

The City of Aumsville hired the Dreamland Skateparks team to construct a 100'X100' skatepark in Aumsville on August 9, 2001. The team worked diligently to complete the concrete work by October 18, 2001. They used their excellent design, concrete, and skating skills to create a worldclass park.

The development of the Aumsville skatepark has been a partnership project and the Dreamland Skateparks team was an integral part of its success. The city hired this team for the concrete portion of the project only. The Oregon National Guard donated the initial excavation work and city staff has performed the project management, financing, and project completion work, with the help of volunteers. The skatepark has been open since last November, although the final fill work, ADA pathway, landscaping, lighting, and bleacher work is still underway.

- The analysis will include the areas north of the river served by the city and south of the river served the Harbor Water District.

The Chetco fishery is an important part of the community's economy and the salmon fishery, coast and state wide, is of great concern. The city is dedicated to protecting this resource while still providing the services needed to accommodate 20 years growth potential within the UGB.

Issue:

Acceptance Of Federal Fire Grant

Background Some time back the Fire Chief submitted an application for a grant proposal to the Oregon Department of Forestry for the purchase of a slide-in pump/ water tank unit to better equip the Fire Department's first response vehicle. The slide-in pump/tank would be a 190 Gallon tank with a 10 gallon foam tank incorporated into the main tank and would pump 300 gallons per minute of water. This would provide the first response vehicle with the ability to initiate some level of knockdown or extinguishment of small fires. We received notification this week, the City of Brookings Fire Department had been awarded a grant in the amount of \$11,857 to be used towards the purchase of equipment for the first response vehicle. The City would be required to copay 10% of the total cost. This expense would be covered by the 2001-2002 Fire Department budget. We requested and received three quotes from equipment providers for this specific equipment. The quotes were for approximately \$13,000.

Recommendation: Staff recommends the City Council accept the grant and authorize the purchase of a slide-in pump/tank unit for an amount not to exceed \$13,043.00 (grant plus 10%)

review at City Hall.) The study recently completed has provided the first complete analysis of our water system since 1976 and the first comprehensive layout of water service level boundaries. He noted service level boundaries are important to assure adequate water pressure to all residents of Brookings. After important background issues were presented to Council, Nored continued the review of the plan, which included detailed information and maps of the current system needs and two phases for improvements projecting to the year 2025. This included the projected combined costs for these needs and Phase I improvements - totaling \$9,004,350 to \$12,361,925: raw water transmission, treated water pumping, water filtration for Chetco River, Ferry Creek improvements, reservoir storage, and distribution and booster pumping. Engineer Nored recapped and provided grant suggestions and opportunities available for financing.

Nored reviewed the Water Conservation Plan, which included working with others to assess unaccounted water usage, adopting curtailment ordinance for during low river flow periods, adopting programs to reduce unaccounted water usage, and considering rationing during drought years.

Mayor Hagbom informed Council we would be working closely with the County's plan, however we will not wait for their process completion in order to implement our City's plan. Hagbom noted the City's last rate increase on water was in 1980 (not sewer). Some discussion ensued regarding water issues throughout Curry County and our cities of same, with Council agreeing the importance of similar plans on both sides of the river and within the County. Nored and Hagbom stated the next six months of water usage will help us determine the impact of the City's ability to take in water for the future.

 - The Chamber is required to keep a "Promotions Ledger" that is separate for their general operations ledger
 - A copy of the "Promotions Ledger" will be provided to the City on a monthly basis and will become public information.
 - Termination of the Agreement can be by either party for any reason for a notice sixty (60) days prior to the anniversary date (July 1) of the Agreement.

And except for some minor language changes, the remainder of the Agreement was presented essentially the same as before. Representatives of the Chamber requested that the City provide an additional 25% of the Transient Room Tax received, above the amount budgeted by the City, for downtown banners, lights and improvements. This requirement was not in the Agreement, according to Blodgett. However, he stated it maybe a good idea to meet with the Chamber near the end of each fiscal year to discuss use of additional funds. Blodgett presented staff's recommendations to approve the promotions contract.

Chamber President Peter Spratt advised there was one small typographical correction - "ledger" not leger. Minimal discussion ensued.

Planning Commission Chair and Chamber member Richard Gyuro was acknowledged as the outgoing Chamber of Commerce President. He spoke on the successful partnership between the City and the Chamber, which in his opinion, was the only way to get things done between the private and public sector with all looking in the same direction.

Blodgett explained the Bargain and Sale Deed from Coos-Curry Electric Cooperative, Inc. presented for sale to the City of Brookings to be used for public purposes and at a cost of \$1.00. He further detailed this was at the edge of our City's park known as Bud Cross Park. Blodgett recommended Council's approval. There were no questions.

Councilor Kuhn moved, Councilor Curry seconded, and the Council voted unanimously to authorize purchase of said property at the end of Hassett from Coos-Curry Electric Cooperative, Inc. for the amount of \$1.00.

Blodgett reminded Council and audience of the 2001 Fire Season in effect and read the notice presented to media by Brookings Fire Chief William J. Sharp, noting fire permits are now required. City Staff had provided samples of five other cities' definitions of vacation rentals, their ordinances, and other pertinent materials for their review. Dentino noted these five cities were similar in size to Brookings. The group discussed many options and will continue their discussion by asking for public input at an open meeting to be held on July 2, 2001, at 7:00 p.m. in the Council Chambers of City Hall. They are hopeful there will be representation from vacation rental businesses in the community.

B. Community Development Department

1. Approval of local fund exchange program agreement with the League of Oregon Cities

Community Development Director Leo Lightle explained the Local Fund Exchange Fund Program, formerly called the Special Cities Allotment Program (SCA), and why it was previously eliminated. He stated the City would have received \$31,328 under the old program. The League of Oregon Cities (LOC), Oregon Association of Counties (OAC) and Tri-Met have succeeded in securing a partial reinstatement of the program. The new program will be administered by Tri-Met with an exchange rate of 92¢ on the dollar. The City, by signing the agreement and participating in the new program, would receive \$29,448, so it seems reasonable to enter into the agreement. Lightle declared the City would need to respond by July 1, 2001, so staff arbitrarily picked Railroad Avenue as a project. They can change the project at a later date subject to the limitations of the Local Fund Exchange Agreement. Lightle recommended Council enter into the agreement.

Councilor Johns moved, Councilor Dentino seconded, and the Council voted unanimously to authorize the Mayor to sign the Local Fund Exchange Agreement and to enter into an intergovernmental agreement with the League of Oregon Cities for distribution of those funds subject to terms specified in the agreement.

2. Closure of Easy Street

Community Development Director Lightle provided the background to Council in regards to the necessary closing of Easy Street between Pioneer Road and Fern Street during the 17-C School District's storm drainage project. Once the School District awards the contract, City Staff will secure a scheduled time for the closure and notify the City Council and news agencies accordingly. Staff recommended Council authorize the closure. Lightle told Council he would be coming back later this summer for the closure of Fern Street, also due to 17-C's construction project. Minimal discussion ensued.

This deed provides 5 feet of right-of-way to complete the required total of 50 feet along that portion of the street. Minimal discussion ensued.

Councilor Johns moved, Councilor Dentino seconded, and the Council voted unanimously to accept the deed as presented and direct staff to record the deed.

Minutes: Two corrections to the minutes were noted and corrected. Under Chetco Point, the second sentence should read, "The Porta Pot issue has been decided and the general fund will pay up to \$100 a month for the placement and upkeep." The minutes were then m/s/a.

Stout Park: Shute explained the grant that has been submitted to Oregon Department of Parks and Recreation is a \$15,000 total grant with a 60/40 split. There is a request of \$9,000, and Brookings will contribute \$6,000 for the construction of a sprinkler system and lighting.

There have been complaints regarding the lower section of Stout Park not being maintained. Barlow explained that this was a wetland, and it had been previously requested to be left alone and natural. The City will look this into.

Chetco Point: Mickelson reported that they now have a mechanical wheelbarrow to help with the maintenance and that the Eagle Scout project hopefully will be completed soon around the upper loop.

Soccer Fields: P&S Construction had not started groundwork yet. P&S will be contacted to see when or if they plan on doing the work. If they cannot start immediately, the City will start the work.

Master Park Plan: Nothing new to report.

Survey: Mickelson explained that he thought there would be no problem with an insert in the Pilot. The cost is around \$250 for 5000 copies. There was an unanswered question as if this could come from the General Fund. Fritz will ask Leroy Blodgett, City Manager, if this is possible.

Skate Park: Mickelson reported on the May 16 meeting. The presentation regarding the Dreamland Team was impressive with

completed parks in Redmond and Almsville, Oregon. The cites reported that the dealings with the Team were satisfactory. They were not hired under a contract, but as temporary employees of the cities. They also came in under budget in both cities. However, the City is still looking at other potential contractors to do the work. This is partly due to the fact that the Team will not be available until October of this year.

SAY: Nothing new to report.

Azalea Park: Williams reported on the picnic at Azalea park and the presentation of the Ben Andreson Memorial. Those in attendance were pleased with the presentation and videos of Ben.

Williams told of seeing a picture of a vine created trellis and knew of a location in the Park where she thought this could be created without much trouble. It was m/s/p to form a natural trellis-like structure on the left side of the stage behind the benches to form an intimate setting for such occasions as weddings. Barlow, with advice from Williams, will try to achieve this.

There had been some discussion regarding a May Pole in the park, but it was decided not to pursue the matter.

Canfield reported that Greg Shin mentioned that there was no trash can in the lower park, and it was needed. Barlow will investigate. There was also discussion on transplanting some azaleas and trimming and removing dead trees. Canfield and Barlow will walk the park to further determine the needs.

Williams talked about the possibility of a Collins Grant for new restroom facilities. She has obtained the plans for the Port of Brookings Harbor restrooms and needs further information for writing the grant. She will continue to pursue this.

Comments: Barlow reported that Lonnie Draheim has set up the dugouts and they will soon be poured with concrete. There is also additional electrical service at the fountain in front of Ray's. This will be helpful for events held in this area.
