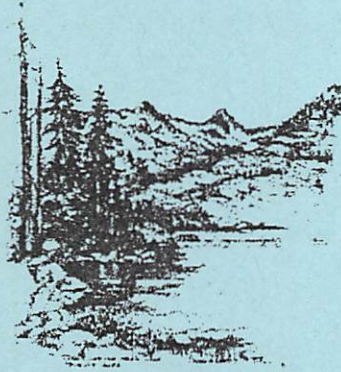

National Forest Counties & Schools Coalition

Talking Points

OVERVIEW

We are a Coalition of organizations concerned about National Forest and BLM Forest Land Management, and the relationship of these lands to the people in states and counties that have a heritage of common interests. Due to changes in forest land management over the last decade, the relationships have changed, negatively impacting a large number of local communities. The Coalition firmly believes that a cornerstone of our principles is the health and productivity of these federal lands which is of vital importance both now and in the future. In addition, the Coalition concurs in their belief that the creators of our National Forest and BLM timberland system expected: 1) that forest resources would be managed in such an environmentally responsible manner that they would produce long-term sustainable revenue to share with schools and counties as well as products for the nation; 2) that the revenue loss to counties because of this land removal from potential private development was to be mitigated by the Federal Government with the funds used for schools, roads, and other local purposes; and 3) that compensation to counties was to be equivalent to 25% of all gross receipts received from the National Forests, and/or 50% of gross receipts from the revested O&C lands, and/or 4% of the gross receipts from Public Domain Lands. Policy and practice have allowed these basic tenet to be eroded.

OVERALL GUIDING PRINCIPLES

1. Cover all National Forest counties nationwide and include O&C counties.*

(*O&C forest are those in the Pacific Northwest managed by the Bureau of Land Management under different statutes than the National Forest System.)

2. Make no changes to the Agricultural Reapportionment Act of 1908 as amended, and the O&C Act of 1937 & 1939 as amended, and the Department of Interior Appropriations Act, 1952 (65 Stat. 252), specifically no "decoupling" of payments from actual gross forest receipts. Provide an incentive that requires the Forest Service to produce receipts and be accountable for their basic responsibilities for active healthy management of the National Forests. The difference between actual receipts and safety net payments shall be paid by the Forest Service and BLM, but shall not be paid out of

revenue producing activities and budgets, including trust funds of the United States Forest Service.

DEFINITIONS

50 Percent Payments to Counties

- The term "50 percent payments to counties" means the 50 percent share otherwise paid to a county pursuant to Title II of the Act of August 28, 1937 (50 Stat. 875, chapter 876; 43 U.S.C. 1181f), and, if applicable, pursuant to the Act of May 24, 1939 (53 Stat. 753, chapter 144; 43 U.S.C. 1181f-1 et seq.), as in effect immediately before the date of the enactment of this section.

25 Percent Payments to States

- The term "25 percent payments to States" means the 25 percent payments authorized by the Act of May 23, 1908 (35 Stat. 260, chapter 192; 16 U.S.C. 500) for the benefit of county roads and schools in those counties in which national forests are situated, as in effect immediately before the date of the enactment of this section.

Owl Payments

- Title XIII of the Omnibus Budget Reconciliation Act of 1993 (Public Law 103-66) is amended by striking chapter 4 (107 Stat. 681-682).

SHORT-TERM PRINCIPLES

1. Require payments be guaranteed based on 100% of the highest three years since 1986.

• That corrective legislation should cover all National Forest counties nationwide and the counties in which revested O&C lands are located.

• In the last decade, Forest Service and BLM timber sale programs have declined drastically. The Northwest Forest Plan caused an 80 percent reduction in harvest and revenues. Other areas have similar or more drastic reductions, without any safety net protection.

2. Require either or language which provides for the above payment, or the actual 25% forest reserve receipts, and/or 50% receipts for O&C counties, and/or 14% receipts for the Public Domain Lands, whichever is greater.

• It must maintain the intent of the original compact between the people of counties having National Forests or O&C timberlands within their boundaries and the Federal Government as that intent is reflected in the Agricultural Reapportionment Act of 1908 and the O&C Acts of 1937 & 1939.

• It must insure that the original intent for specific uses of shared receipts be maintained.

• To provide for increased stability in funding of county government and schools that

share in federal forest receipts. Current "owl region" safety net runs out in 2003. Other areas have no safety net and need one.

- Either/or means counties and schools get either the safety net amount or the 25/50 percent share of receipts which ever is greater.
- It assures the counties and schools that, should Congress ever decide in the future that safety net payments should be discontinued, at least payments based on the 25/50 percent sharing formulas would remain available.
- Decoupling or delinking is not a substitute for a "safety net." The Administration has substituted the word "decouple/delink" for the words "safety net." The issue under consideration is stabilization and expanding the existing safety net. Decoupling/delinking is one of many components being discussed under the broad heading safety net. Do not let anyone substitute the word "decouple/delink" for "safety net."

3. Provide for indexing of the payments to a CPI.

- All payments referred to in this proposal shall be adjusted each fiscal year beginning in the fiscal year following passage of corrective legislation to reflect changes in the consumer price index for urban areas (as published by the Bureau of Labor Statistics).

LONG-TERM PRINCIPLES

PROVIDE A PROCESS FOR DEVELOPING A LONG-TERM SOLUTION TO ENSURE LONG-TERM FOREST MANAGEMENT AND A RETURN TO ACTUAL GROSS RECEIPTS

1. PROMOTE LOCAL GOVERNMENT COORDINATION AND COMMUNITY BASED PARTNERSHIPS

- The "compact with the people" when the National Forests were established assumed a continuing direct link with the local people and their government.
- At a minimum there must be an assurance that counties, schools and local communities will play a central role in federal land management planning so that local concerns are adequately addressed.
- Local government has an intense interest in the manner in which public lands are managed. Public lands decisions impact local government decisions on fire protection, law enforcement, development, schools, roads, and other local services.
- Existing examples of programs which do this include at least:
 - the forest land trusts in some states
 - management systems such as the Tillamook State Forest in Oregon
 - the Quincy Library Group in California which brings together representatives from government, industry, local environmental groups as well as other interested citizens to build consensus on local forest management issues and long-term

planning

- It appears that many forest management decisions are increasingly influenced at the regional or national level rather than by local forest personnel who have a full understanding of the ecological, economic, and social factors that must be considered in multiple use forest management.
- Closer coordination between the community and trained locally based Forest Service personnel can reduce the current process of "management by litigation and administrative regulation" which is forced on local communities and the Forest Service by the current fragmented approach to management. (Revision of the "Citizen Attorney General Statute")

2. RECOGNIZE THE NEED FOR SUSTAINABLE ECONOMIC SELF-SUFFICIENCY OF RURAL COMMUNITIES THROUGH THE BEST USE OF NATURAL RESOURCES WHETHER FOR FARMING, GRAZING, MINING, TIMBER HARVEST, RECREATION OR AESTHETICS

- Maintains the vision of the creators of our system of National Forests who expected that these lands would produce both revenues and products for the nation on a perpetually sustainable basis
- Gives continuing recognition of the need for the establishment and maintenance of infrastructure in forest communities. Funds were specifically provided in early legislation for schools and roads to enable forest communities to thrive and support the forests
- Continues the expectation that the USFS will recognize best and historic use, science, community well-being, and sustainability among other things in making wise land use decisions
- Acknowledges that the continuance of economically and socially healthy communities is vital and that these must be balanced with other systemic elements of the forest community

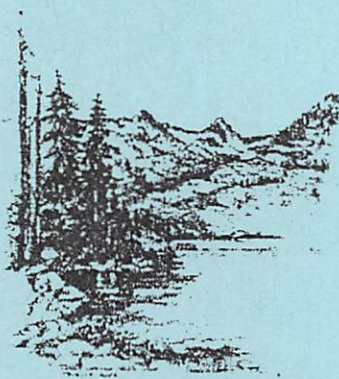
3. BE IN ACCORD WITH A DEFINITION OF SUSTAINABLE FOREST MANAGEMENT, WHEREIN ECOLOGICAL, ECONOMIC, AND SOCIAL FACTORS WILL RECEIVE EQUAL CONSIDERATION IN THE MANAGEMENT OF THE NATIONAL FORESTS

- Encourages active forest management practices which are low impact and sustainable over long periods of time.
- Uses practices which promote safe and healthy forest ecosystems with policy input from local stewardship planning groups.
- Promotes legislative & administrative policy changes which enhance long-term stability and mitigate local adverse social, economic, and forest health consequences of current federal forest management practices.

- Acknowledges the scientific, cultural, and historical connections between counties and the use and management of federal lands.

4. PROVIDE FOR TOTAL FOREST MANAGEMENT WHICH CONSIDERS THE PRINCIPLE OF MULTIPLE USE AND OTHER FACTORS AS THEY RELATE TO TOTAL SYSTEMIC AND SUSTAINABLE FOREST HEALTH, BASED ON CURRENT BEST SCIENCE, USING INDEPENDENT CRITICAL PEER REVIEW

- Maintains the intent of the original compact between the people of counties in National Forests and the Federal government which was developed in 1908 before and during the formative years of the National Forest system. Reaffirms the coupling of Forest Lands and their multiple uses with the economic & social life of the community.
- Recognizes the importance of economic, social, and environmental values in a multiple use land management approach.
- Mandates critical peer review to ensure that best science is applied to active forest management rather than ideology masked as science.

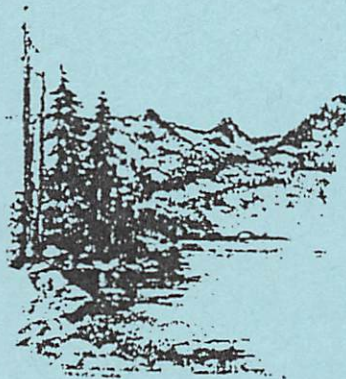
Statement of Support for the National Forest Counties and Schools Coalition (NFCSC) Principles



RECOMMENDATION:

The City Council return the deed to Assessor's Map 41-13-6DD Tax Lot 3400 to Curry County.

BACKGROUND:

The City of Brookings was offered by Curry County a couple of small pieces of property which the city accepted in 1992. There was a restriction that the land would be used and continue to be used for a public purpose.

We have previously been asked to sell one of the properties to an adjoining property owner. More recently, we've been asked by a different property owner to have the city lease the land to the property owner. Both requests are not consistent with the public purposes clause in transferring the ownership to the City of Brookings.

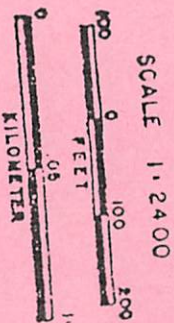
The property, due to its location and width—30 feet, does not have a public use for the City of Brookings. Staff therefore recommends that the property be returned to Curry County. If Curry County would sell the property, it would be put on the tax rolls.

RECOMMENDATION: The City Council find that an emergency did exist and approve the expenditures for repairing the slides on Marina Heights adjacent to Assessor's Map 40-13-32C, Tax Lots 308 and 401.

BACKGROUND: During the heavy rains on the evening of January 13 and the early morning hours of January 14, there were two slides on Marina Heights.

The first slide was minor in size but blocked the drainage ditch forcing the water across the road.

The second slide, caused by the water forced across the road, removed the road shoulder and the supporting fill material leaving a near-vertical drop off.

The city had to get repairs underway quickly as more rain was forecast and there was the possibility we could lose all of Marina Heights Road, losing all access and substantially increasing cost.

Staff found that an emergency existed and that we did not have time to go to formal bids. We also had a recent slide repair and knowledge of approximate cost and equipment available locally for immediate repairs.

Staff was aware that in an earlier bid on a nearby slide that Tidewater Contractors, Inc. was substantially the lowest bidder on the project. In the earlier bid the Council questioned why Tidewater's bid was so much lower than the next bidder. The reason was the close proximity of their rock quarry and spoils site to the slides and that the trucking costs therefore were tremendously lower. Tidewater also had many large trucks as well as trained personnel to do the job.

Staff therefore authorized Tidewater Contractors, Inc. to do the work and continue working through the weekend.

- A. *In the matter of Planning Commission File No. LDC-7-99, Application for an amendment to Section 88, Sign Regulations, of the Land Development Code to reword Sub-section 88.040.B to read "Temporary political signs provided the signs are removed within seven (7) days following the election for which they are intended; City initiated and applicant*
- Council President Larry Curry opened the public hearing at 7:14PM, by reading the nature of the proceeding and case number from the agenda. Weldon proceeded to explain the request background and stated he was advised by City Attorney John Trew, the current wording of sub-section 88.040.B, may be unconstitutional in that the City cannot regulate the length of time a political sign can be displayed prior to an election date. In response to this advice, staff recommends the wording of this paragraph be amended as indicated in the staff report. Weldon noted the Planning Commission considered this change at their December 21, 1999, meeting and also made a favorable recommendation to the Council.

Council President Larry Curry asked if any member of the Council had an ex parte contact to declare and there was none. He asked if any member had a potential or actual conflict of interest and there was none. He asked if anyone objected to the jurisdiction of the Council to hear the matter. There was none. Curry continued by announcing the guidelines for presenting testimony & participating in the hearing and asked if there was any relevant testimony in support or in opposition to the proposal. There was none.

SCHEDULED PUBLIC APPEARANCES

A. *Lee Sparks - ODOT District 7/ Assistant District Manager*

Weldon mentioned the City had been informed approximately ten days ago that the Brookings couplet was on the Oregon Transportation Commission staff recommended list of \$600 Million projects. a meeting tomorrow evening regarding the list and the gas tax revenue, however, he did not see it as favorable that Brookings would be on the list.

B. Rebecca Olsen - Musser & Associates/1998-99 Comprehensive Annual Financial Report

Rebecca Olsen, CPA from Musser & Associates, having previously provided the annual audit concluded December 10, 1999, summarized the report and verifications for the fiscal year ending June 30, 1999. She confirmed the City's compliance with regulations on the use of any federal funds, as well as other city funds and that the results of their tests on the City's accounting records resulted in no findings of non-compliance. She gave high praise to the Finance Department on specific savings accomplished due to the City's refinancing of bonds. Olsen also informed the Council of upcoming changes in state and federal reporting of financial records, which will require a set of financial records more like business statements vs. municipality financial statements. She noted preparing for these changes in reporting will not be an easy, task time wise or financially. Olsen concluded by thanking Finance Director Hedding and City Manager Weldon for their assistance in completing the audit. Questions and discussion ensued from the Council with Olsen responding. She introduced Stacy Phillips, another CPA and employee of Musser & Associates, who also worked on the audit.

Curry explained the absence of Mayor Bob Hagbom, and that he is currently in the Rogue Valley Medical Hospital, with expectations of being released tomorrow, Tuesday, January 11th. Curry noted Hagbom is doing fine

Lightle continued by presenting the Council with written results from that call for bid opened on January 6, 2000. Lightle recommended the Council award the bid for a new pickup truck for the Waste/Water Treatment Divisions to Siegrist Ford, Brookings in the amount of \$19,561.40.

Councilor Pepper moved, Councilor Johns seconded and the Council voted unanimously to accept the Siegrist Ford bid in the amount of \$19,561.40 for purchasing a new pickup truck for the Waste/Water Treatment Divisions.

Lightle explained bids on the bed will follow, as they were dependent on the type of vehicle. Three different companies have indicated an interest in bidding on the bed.

D. Police Department

1. Authorize calling for bids on new police patrol vehicle

City Manager Weldon reported Police Chief Ken Lewis was requesting authorization from the Council to call for bids on a new police patrol vehicle. He noted the current budget includes \$20,900 for a vehicle plus additional money for equipment.

Councilor Johns moved, Councilor Ciapusci seconded and the Council voted unanimously to direct Police Chief Ken Lewis to request bids on a new police patrol vehicle.
