C. Planning Commission Announcements

Planning Director Richard Ullian invited the Council and the audience to attend the CAC meeting on January 21, 1988 at 7:00 p.m. in the Council Chambers.

D. City Manager Announcements

1. 1988 Special City Allotment Program

Mr. Rainey presented the Council with a letter from the Oregon Highway Division, denying the city's request for monies for the purpose of extending Fifth Street out to U.S. 101. The reason given for the denial was that the monies are designated for repair of existing streets and the city's request was for a new connection.

2. Presentation of proposed budget calendar for fiscal year 1988-89

Mr. Rainey presented the Council with a proposed budget calendar for fiscal year 1988-89.

3. Appointment of budget officer for fiscal year 1988-89

Mr. Rainey requested that the Council appoint Beverly S. Shields, City Recorder, as the budget officer for the fiscal year 1988-89. Mr. Rainey pointed out that Mrs. Shields has been working very closely with the budget in the past year and understands the entire process.

Councilman Batty made a MOTION, seconded by Councilman Peterson, to appoint Beverly Shields as budget officer for fiscal year 1988-89; MOTION carried unanimously.

4. Chief of Police Kent Owens

Chief of Police Kent Owens advised the Council that due to the fact that allegations were made against the police department regarding the "tearing up of citations for political reasons", by a former officer who was dismissed by the department, he felt that he should briefly explain the process followed by the Brookings Police Department and all other police departments across the state concerning the dismissal of any citation. Chief Owens denied all allegations made by the former officer.

1. Glenwood PUD Appeal

Mayor Kerr requested that City Attorney John Babin defer this item until a later time, due to a recent meeting with the owner of the Glenwood PUD. Mr. Babin agreed.

Councilman Batty made a MOTION, seconded by Councilman Nidiffer, to defer this matter; MOTION carried unanimously.

X. PUBLIC HEARINGS

1. Remand Hearing - Comprehensive Plan Amendment and Zone Change Application for Chetco Point Property/Agnew Company Applicant

Hearings Officer John Babin introduced this agenda item by explaining the purpose of the hearing. As advertised, the evidentiary hearing is being conducted to reconsider a request for a comprehensive plan map amendment to redesignate from industrial to residential, and rezone from Industrial General (M-G) to Residential Medium Density (R-MD) approximately 41.70 acres of property, (exclusive of land deeded to city for wastewater treatment plant expansion), located between Center Street and the Pacific Ocean, and the west side of the southerly extension of Wharf

Street western right-of-way line. The subject parcels are described as Tax Lots 300, 310, 500 and 600, Assessor's Parcel Map No. 41-13-6D, and a portion of Tax Lot 400, Map 41-13-7A.

Mr. Babin further explained that the purpose of the evidentiary hearing is to consider those matters remanded to the city in the LUBA Final Opinion and Order No. 87-026, dated August 25, 1987. This hearing, before the Brookings City Council, is to consider evidence pertaining to:

1. That there are at least 116 acres of industrial land within the city of Brookings Urban Growth Boundary area that are suitable for industrial sites in accordance with statewide land use planning Goal 9. To be suitable or adequate, the following specific criteria must be addressed:

- (a) Vacant vs. developed land,
- (b) Topography or slope of the land,
- (c) Size and location of the land,
- (d) Level of services available to the property.

2. The adequacy of public facilities and services covered by Goal 11 at the remaining industrial sites.

3. The applicant must show compliance with Goal 14, Policy 2 of the city of Brookings Comprehensive Plan, which provides:

"City shall encourage the orderly outward growth of the community in order to maintain costs of construction, maintenance and public facilities at the lowest possible level."

It was also pointed out by Mr. Babin that this remand, evidentiary hearing before the City Council shall be limited to comments on the specific issues and criteria set forth above, and pursuant to Section 15, Oregon Laws 1987, Chapter 729.

Mr. Babin explained that this process is a reconsideration of a previously conducted, quasi-judicial procedure and therefore certain rules of conduct must be followed. These were outlined to the Council and the audience. Mr. Babin opened the public hearing at approximately 7:45 p.m.

Mr. Babin asked for testimony from the proponents.

Mr. Dan Hughes, Attorney at Law with the law firm of Brown, Hughes, Bird, Lane and Simcoe, 612 N.W. Fifth Street, Grants Pass, Oregon, representing the Agnew Company, presented opening remarks on the request and introduced the document entitled "Remand Hearing - Comprehensive Plan Amendment and Zone Change Application for Chetco Point Property/Agnew Company, Applicant" and requested it be made a part of the record, (Exhibit P-8). Mr. Hughes also introduced and offered for the record additional findings document supplementing the document prepared and submitted by Mr. Hughes and Mr. Lyle Stewart, Planning Consultant, on behalf of their client, the Agnew Company, (Exhibit P-9).

Mr. Lyle A. Stewart, A.I.A., A.I.C.P., a partner in the architectural and planning firm of Patterson, Stewart and Associates, 45 Hawthorne St., Medford, Oregon, presented a detailed summary of the information and data contained in the submitted documents. In addition, all maps, charts, aerial photographs and other exhibits were entered into the record of the proceedings (Exhibits P-10, P-11, P-12, P-13, P-14, P-15, P-16, P-17, P-18).

Mr. Babin asked for testimony from any other proponents to the request. There was no response from the audience.

Mr. Babin then asked for opponents to present their testimony.

Mr. Fred Hummel, 202 Alder St., Brookings, Oregon, presented testimony opposing the request and submitted a written document to the Council responding to the written testimony presented by the proponents, (Exhibit O-C). Mr. Hummel summarized the document stating that the

applicant's representatives failed to present substantial evidence responding to the proposal's compliance with Goal 9, vacant or developed land available, topography and slope, size and location, and level of services available; and Goal 11 relative to adequacy of services available to serve the remaining industrial sites. Also, he presented opposing testimony relative to the applicant's representatives' response to the Goal 14 compliance issue. Mr. Hughes requested that the meeting be continued to provide the applicant time to review the testimony offered by Mr. Hummel and to prepare a rebuttal.

In order for both the proponents and opponent to review in more detail documents and testimony presented by each to formulate rebuttal presentations, Mr. Babin, upon the concurrence of the Mayor and City Council, declared the public hearing be continued and reconvened to a special meeting of council on February 1, 1988, at 7:00 p.m., in the Council Chambers of Brookings City Hall.

IV. PUBLIC HEARING - CONTINUED

1. Remand Hearing - Comprehensive Plan Amendment and Zone Change Application for Chetco Point Property/Agnew Company Applicant

Hearings Officer John Babin reconvened this continued remand hearing and again reminded the audience of the rules of procedure for the conduct of the hearing and the fact that the purpose is to



hear rebuttal of testimony from the proponents and opponent presented at the January 11, 1988 meeting of the Brookings City Council.

Mr. Lyle Stewart presented a detailed summary of a document previously distributed to the city council, entitled "Rebuttal to Fred Hummel's Presentation Objecting to the Agnew Company's Application on Chetco Point Property". He also requested that it be entered into and made a part of the record of the proceedings, (Exhibit P-19). Following Mr. Stewart's presentation, Mr. Dan Hughes summarized the proponent's position relative to the evidence thus far submitted to the council on the remanded issues.

Mr. Bill Cunningham, 325 Mill Beach Road, Brookings, Oregon, wished to ask Mr. Stewart a question regarding a map exhibit.

Mr. Babin then allowed Mr. Fred Hummel to present rebuttal to the rebuttal testimony presented by the applicant's representatives. It was requested by Mr. Hummel that his written documents be entered into and made a part of the record of these proceedings, (Exhibits O-D and O-E). He then summarized the material to the council. Following Mr. Hummel's presentation, Mr. Babin offered him a copy of the response prepared by City Manager Roy G. Rainey and city staff, to review. A recess was declared to allow Mr. Hummel the opportunity to read the document. The meeting was reconvened and Mr. Babin asked if there was any further rebuttal testimony to be presented. Mr. Hughes requested that the staff reports for both the January 11, 1988 and February 1, 1988 meetings be entered into and made a part of the record to the proceedings, (Exhibits P-20 and P-21).

There being no further public testimony, the public hearing was closed and the meeting was turned over to Vice Mayor Batty and opened to council discussion.

Councilor Hoselton made a MOTION, seconded by Councilor Peterson, that the proponents to the request presented substantial evidence to support the requisite findings relative to the sufficiency of suitable remaining industrial sites, sized, located and serviced so that they are suitable;


that there will be the orderly provision of services and urbanization to the remaining sites with timely, orderly and efficient arrangement of public facilities and services; and, that the Policy 2 of Goal 14 of the city comprehensive plan will not be violated by redesignating and rezoning the Agnew Chetco Point Property from industrial to residential, and M-G to R-MD, respectively. The MOTION to approve the request and to direct staff to present the Final ORDER and Findings of Fact Document at the regularly scheduled February 8, 1988 meeting for final action, carried unanimously.

**X. ADJOURNMENT**

Vice Mayor Batty adjourned the meeting at approximately 9:30 p.m. and the Council went into Executive Session.
