1. **Chuck and Nancy Brendlinger - Appeal of engineering decision concerning water hook-up at 935 Marina Heights Road**

Engineering Technician Leo Lightle advised the Council that Mr. and Mrs. Brendlinger have requested an exemption from the city standard which requires that a water main be extended to serve properties which do not front on an already existing water main.

Mrs. Brendlinger advised the Council that she and her husband were appealing the decision of the engineering department and stated that when they purchased the property from Ed Roszel, they were under the impression that a 3/4" to 1" water line was all that was required from Marina Heights Road to their lot. A letter from Mr. Roszel concurred with this assumption.

City Manager Roy Rainey presented a report on the traffic study done by Gary Dyer, P.E., for the city and requested authority to implement the cited minimum distances for curbside parking prohibition. Mr. Rainey also presented the Council with a request from U.S. National Bank to restrict parking in front of the bank.

After discussion, the City Council agreed to approve the request of U.S. National Bank and to defer action on the curbside parking prohibition until the parking study is completed.

5. **Paul Strader - President, South Coast Chapter of the American Water Works Association**

Mr. Rainey advised the Council that Paul Strader, Treatment Plants Operator, has been elected President of the South Coast Chapter of the American Water Works Association. Paul's term begins in July, 1988 and runs for one year.

The Order sets out the requirements and schedule for construction of wastewater treatment plant improvements and sets interim operating levels for the plant.

Mr. Rainey recommended that the City Council award the design contract to Brown and Caldwell and withhold the Notice to Proceed until D.E.Q. has approved the grant application and made an award.


