Engineering Technician Leo Lightle advised the Council that the project has been completed in satisfactory conformance with the approved plans and specifications and requested that the Council accept the waterline improvements on Moore Street (Pacific Cliffs Cove) and authorize staff to issue the certificate of final acceptance to the owner.

City Manager Roy Rainey apprised the Council of the new census figures for 1988. The figures show a rise from 3,615 in July of 1987 to 4,185 in July, 1988.

5. **EPA Clean Water Act Grant**

City Manager Roy Rainey advised the Council that with the help of Representative Walt Shroeder and through DEQ, Dawson Tract and Oregon Driftwood Shores have been approved for consideration for a 55% grant from the EPA Clean Water Act for the installation of the sewer trunk lines to their area.

1. **Condemnation of existing roadway easement for the purpose of dedicating same as a public right-of-way for a fully improved City street to serve the proposed Allen Subdivision**

VIII. CALL FOR BIDS

1. Water Distribution - hot water washer

Engineering Technician Leo Lightle advised the Council that monies for this item of equipment (\$4,000) were budgeted for in the 1988-89 budget. Staff is requesting authority to call for bids for a hot water washer which will be used to clean up City equipment to minimize body repair and painting and the machine will also facilitate normal maintenance by removing grime and dirt from grease fittings and areas to be repaired or disassembled.

Following discussion, Councilor Peterson moved to authorize staff to call for bids for a hot water washer, which motion was duly seconded by Councilor Hoselton. A vote was taken with the following results:

Staff is requesting authority to call for bids for a vibratory compactor which will allow the City to use approved construction standards for all trenches that need compaction.

Chief Owens recommended the purchase of the 1989 Chevrolet Caprice in the amount of \$13,549 from Coast Auto Center.

Following discussion, Councilor Batty moved to authorize the purchase of the 1989 Chevrolet Caprice from Coast Auto Center in the amount of \$13,549, which motion was duly seconded by Councilor Peterson. A vote was taken with the following results:

Mr. Strader added that this bid amount was within the budgeted amount and recommended the purchase of the flow meter from the American Sigma Company.

Following discussion, Councilor Peterson moved to authorize the purchase of a portable flow measuring device from American Sigma in the amount of \$2,702, which motion was duly seconded by Councilor Batty. A vote was taken with the following results:

**1. Automatic Sampling Equipment - Wastewater**

Mr. Strader recommended that, although it is not the low bid, the Council award the bid to American Sigma in the amount of \$2,090 instead of the low bid from American Sigma of \$1,786 due to the fact that the \$2,090 unit is waterproof.

Following discussion, Councilor Batty moved to authorize the purchase of the automatic sampling equipment from American Sigma in the amount of \$2,090, which motion was duly seconded by Councilor Hoselton. A vote was taken with the following results:


