Financial & Utility Billing System Computer Software Selection

Issue:

Which Financial & Utility Billing Computer Software System best meets the needs of the City of Brookings at a reasonable price?

Background:

- 1. The City of Brookings must replace the current Financial and Utility Billing systems. The existing systems are not Year 2000 compliant and do not interface with each other. This could mean system failure and shutdown on January 1, 2000. In addition, one of the vendors of our existing collection of systems is no longer in business and therefore, the software is not adequately supported. Technology has advanced significantly in the past five years and many efficiencies can be achieved with a fully integrated system.
- 2. An inquiry of Finance Directors in other cities, information obtained at trade shows and products advertised on the Internet resulted in the identification of nine vendors for consideration. Those vendors were initially screened as potential providers of the Financial and Utility Billing systems.
- 3. The criteria applied in the initial assessment was price, hardware requirements and application modules available. The City of Brookings needs to replace all financial and utility billing systems and desires a system that will function on its existing hardware (NT Personal Computer network in a windows environment 32 bit program). A system priced in the \$10,000-50,000 range should provide the City with the functions necessary to conduct business efficiently. Five of the vendors under consideration were eliminated based upon price and hardware requirements alone.
- 4. The remaining four vendors were examined throughly. Each vendor was given the opportunity to provide a demonstration of the features of their products. The four vendors reviewed were Caselle, Springbrook, USTI-Asyst and DR Frey. Both DR Frey and USTI-Asyst products lacked functionally in some necessary areas. DR Frey did not offer a grant/project accounting or business license module to its products and Asyst did not offer a grant/project accounting component and the payroll

module was not interfaced with the General Ledger, a significant shortcoming.

5. To further refine the selection decision, calls were made to current users of the systems. The following cities were contacted:

Caselle Milton-Freewater, OR
Pleasant Grove City, UT
Clinton City, UT
Bandon, OR

Springbrook Tigard, OR Coquille, OR Tillamook, OR Albany, OR

USTI-Asyst Jerome, ID Layfayette, OR

DR Frey None Provided

- 6. Our computer consultant, Jeffery Martin, has reviewed the hardware requirements of the vendors and concurs that our current equipment will support the applications.
- 7. Two of the vendors, DR Frey and USTI Asyst, were eliminated from further consideration. Asyst's client base is mainly cities with a population from 200-1000. After some investigation, I concluded their product was not the best match for Brookings due to our size and desire to purchase a system that will grow with us over the next 5-10 years. DR Frey was eliminated due to the fact they do not have a couple of the desired software modules and the system did not function as required, based upon the system demonstration.
- 8. In reviewing the costs, I attempted to normalize the components across vendors. The major costs categories are software application costs, annual maintenance costs, training costs and conversion costs. Both training and conversion costs are difficult to estimate as they can vary from client to client and are dependent upon the skills of the people and the nature of the data one is attempting to transfer. The only ongoing cost after the system is installed is the annual maintenance cost; the remaining three categories are initial one time fees only. Springbrook was the most expensive at \$49,911, followed by Caselle at \$34,070. The cost breakdown is as follows:

Recommendation:

I recommend the City of Brookings purchase the Caselle package of products to serve the finance and utility billing system needs and staff be authorized to enter into a contract for the purchase after approval by the City Attorney. Caselle has demonstrated stability in the governmental software market since 1977 with over 450 installations. I feel the system functionality combined with their approach to customer service makes Caselle the best match for the City of Brookings. Improvements offered by a truly integrated financial/utility billing computer software system will be felt immediately.

Issue:

The west side of U.S. 101 - Ransom to Harris Beach State Park entrance road

Background: 1.

- 1. The city has been contacted by volunteers offering to remove underbrush vegetation and trees to create an ocean viewshed on ODOT right-of-way between Ransom Avenue and Parkview Drive. We reviewed the project with the volunteer co-ordinator Cliff Misener and an ODOT representative. During the discussion City Staff stated that the project, if approved, must be done in a manner that does not create erosion problems, should not resemble clear cutting, brush removal be consistent with what we expect of developers and that we want to maintain the evergreen trees in the public right-of-way.
- 2. ODOT has issued a permit, subject to any conditions the City imposes, for us to sign making the City the responsible party to work with, supervise, and insure the volunteers. This permit would allow cutting of trees and vegetation, in ODOT right-of-way, but not in the riparian zone, to open a view of the ocean.
- 3. The "DRAFT" Curry County State Parks Master Plan refers to this issue in our State Parks. In the Master Plan Summary it says "View preservation needs are related to the young forest issue: Many traditional views are being quickly screened by young trees. These areas need to be kept open over the years. OPRD will work with ODOT to ensure the proper placement of tree thinning for view restoration." This same group of local volunteers has already done some of this thinning in some of our local State Parks.
- 4. There is some concern that doing the proposed work will create a dangerous traffic situation. Opening ocean views on a sometimes very busy road, could lead to traffic accidents as people look at the ocean instead of paying attention to their driving. However, ODOT has issued a permit knowing exactly what is proposed and why, so they must not be very concerned about this issue.
- 5. The Scenic Byway Report recommends a vegetation control plan be developed for U.S. 101. Such a plan and its implementation would help keep ocean views unobstructed by vegetation.
- 6. This proposed work would also open ocean views for a few homes on the other side of U.S. 101.

After ODOT issued their permit, they received an offer to buy some of the right-of-way property that is under consideration for clearing. ODOT has sent us a letter (attached) asking what we would like them to do regarding this purchase offer. Mr. Rich Johnson, the party making the purchase offer, told me he would clean the property up but generally keep it as it is now. See his attached letter about why he wishes to purchase this property. On attached map the pink property is what he owns now and the yellow indicates property he wishes to purchase.

Recommendation:

- 1. Deny this request by volunteers. This removal project will adversely affect adjacent property owners and would create a traffic hazard. There are many potentially more scenic areas outside the City that should be cleaned up.
- 2. Ask ODOT to not sell this property. They should hold on to it so they have the ability to do something with it in the future, if they or the City need or want to.
- 3. If Council wishes to allow this work they should impose the following conditions:
 - ► No removal of conifers (fir, spruce, cedar, et.). There can be selective thinning of lower branches of the conifers with approval by the City.
 - ► Removal of some deciduous trees (alder, etc.) but not all.
 - Underbrush removal.
 - ► All limbs over 3" removed or chipped.
 - After brushed, area to be cleaned up and left aesthetically pleasing.
 - City will set parameters on the project.
 - ► Each sub-area cleaned up and finished before doing next sub-area.

Dear Persons:

When I first heard that a homeowner on the other side of the highway wanted to get a better ocean view and so had petitioned the city to remove the trees in our driveway that blocked his view, I thought it was a joke. Apparantly not. I thought that if someone wanted beach-front or ocean-view property it was something you had to pay for. Maybe not.

If Cliff Misner has his way he'll get the city to remove the trees and Camilia bushes that line our beautiful driveway. It is axiomatic that view is a factor of lot cost. If Mr. Misner wanted a view he should have bought it, not planned for the city to arrange it for him.

Rather than emphasizing the apparent real reasons for his proposal, he has stressed other "good" reasons. He suggests that a more open view to the drivers on the road would be desirable. Distracting drivers on the highway right where four lanes compress into two with a 35 mile an hour restriction taking effect, where deer cross the highway daily is such a good idea. Viewing is provided at the spectacular Harris Beach wayside.

Beach Avenue is a private road, aesthetically perfect. When Archie Anderson put in all this landscaping fifty years ago, he included allowed-room for a bike path and a calming meandering pleasant tree-lined drive. I bought my lot on Beach Avenue partly because of this landscaped Driveway.

Our reason for deciding to buy and build in Brookings was the very positive experience of staying at Holmes B&B. Now that Beach Avenue has the Goetze B&B how many more people will be influenced by the beauty of this special area.

When Chetco Avenue was resurfaced it was not "feathered" into meet Beach Avenue. We were told that Beach Avenue was a private road and that we'd have to do our own resurfacing. So there is a bump up where Beach Avenue meets Chetco Avenue. Well we know it is a private drive, we rake the leaves, prune the trees and mow the lawn of that drive as a cooperative effort. It is by this fifty five years of maintainance that we own a right to control its destiny.

I wonder how many other people in Brookings would like to cut down their neighbors trees in order to improve their own view of the ocean.



We would like to express our strongest possible opposition to Cliff Fisher's crusade to "selectively cut" or "thin" the vegetation adjacent to our property.

This vegetation provides a natural berm for privacy and to minimize road noise. If for some reason this natural berm is removed, we would promote a plan to replace it with a concrete wall or a hedge of some sort as have the other property owners toward town.

The Beach Avenue common access road, that crosses this property, is aesthetically perfect. Alder trees on one side provide an archway over the roadway. Mature camelias (10 to 15 feet) line the other side providing year-round blossoms.

The bike path separates our property from the property in question is used by thousands of people per year: bikers, joggers, walkers, strollers. Many of these are local people that enjoy a nature trail close to home and yet quiet, secluded, safe and pristeen. The way things are right now represents an ideal scenic bi-way. What if the vegetation is removed? You don't see many people enjoying a path next to a freeway, do you?

Then there is the safety issue. Do you want the driver of the car behind you, or worse yet the driver of the car coming toward you, looking at the ocean? Of course not. That is why scenic viewpoints were created. There is no shortage of scenic viewpoints in Oregon.

My wife and I enjoy the privacy, the seclusion, the beauty of the view and the close proximity to town. She walks the bike path regularly for the same reasons that everyone else does: it is perfect just the way it is. We bought our property thinking that the only real hazard might be that digheay 101 might be widened.

Now, we need to get down to the real issue of why Cliff Misner wants to "improve" the scenic bi-way view from Highway 101. As benevolent as this may appear, the reality is that there are some trees that are limiting his view from his home.

So, if somehow he gets ocrmission to "selectively cut" or thin trees along the coastline, it is reasonable to predict that the property adjacent to ours would be the least selective and most extensively thinned. One percent is selective. Unfortunately, ninety nine percent is also selective.

We strongly disapprove of Mr. Misner's project.

Schutt said the project has at least another year of studies to complete. She felt that ultimately, local approval of the project would be needed, whether from the county commissioners or a vote of the people.

When one citizen suggested the county was only acting as a pass-through agency for grant funds, she said she believed it was involved in more ways.

Of the three proposed state parks sites for the Discovery Center part of the Canopy Project, the parks staff has the most concerns over Otter Point, four miles north of Gold Beach.

Once viewed as a site with, great potential for the Canopy Project, Otter Point was withdrawn from consideration when the Division of State Lands classified it as a Natural Heritage site because of rare shrubs.:

The original plans drawn for Otter Point by the Portico Group, architecture and engineering consultants, put the visitors center and parking lot right on top of. the shrubs.

The state parks staff were able to come up with their own design! for Otter Point, however, that moves the visitors center and parking spaces away from the shrubs.

The parks people also found the Canopy board a potential substitute site near the Geisel Monument, three miles farther north.

State parks and the Oregon Department of Transportation ets a '' owns some of the land needed at side! that site. The rest would have to be purchased from the Nature Conservancy for \$2.5 million.

The third site, near Lone. Ranch Beach north of Brookings, requires no changes to the plans drawn up by the Portico Group to make it work as a visitors center attached to the

A tiny corner of land at Loeb State Park would also be needed as part of a potential site for the Canopy walkway. Schutt said it is not being used for anything else.

The second hot topic, vegetation clearing, was raised by Clifford Misener.

Misener would like to create a new version of the "adopt-a-highway" plan. Instead of clearing litter, volunteers would thin trees and underbrush to open up ocean vistas along U.S. Highway 101. He said all that is needed is an

agreement between state parks and the transportation department, which is already on board. He asked that state parks take charge and get the project off the

ground, Schutt said state parks and the state forester are very aware of the problem. She said most of the trees are not part of the original ecosystem. At one time stretches of the south coast were

more grassy and open. Van Leer agreed. He said tho state has allowed about half of its ocean views to disappear.

Schutt said the state would react, and in fact the transportation department has already done some thinning in Boardman State Park.

The solution, however, is not as simple as turning volunteers with chainsaws loose along the highways.

Schutt said the transportation department has raised safety issues. It prefers filtered views with some trees because open vistas are too distracting to drivers and cause accidents.

There are also environmental concerns. Thinning too many trees could accelerate erosion in some spots.

One citizen put in a plug for the trees and said riparian zones along rivers should be enhanced; not depleted.

The parks department also has liability issues with volunteers. There are restrictions on the types of equipment they can operate.

Schutt believes there will be a place for volunteers in the final solution, but many factors have to be ironed out first. She assured Misener that vegetation clearing is becoming a high pri-

It may be too high a priority for one citizen. He wondered if state parks was overcommitting to automobile traffic, given high gas prices and the cost of maintaining the highway against alides.

Schutt said state parks has been looking at the world oil supply, which may be very questionable in 80 years.

A RESOLUTION ADOPTING A POLICY ON VOLUNTEER PROJECTS AND/OR SERVICES SPONSORED BY THE CITY.

WHEREAS, the Brookings volunteer City Council is elected to oversee City assets and City provided services; and

WHEREAS, Brookings has a wealth of volunteers and volunteer groups. Hundreds of these individuals and many groups have been associated with the city and have provided wonderful things-projects and services the citizens of this community would not have enjoyed without these volunteers; and

WHEREAS, the City of Brookings' insurance covers volunteers working on City property and those volunteers working under the name of the City of Brookings while providing services; and

WHEREAS, all City-related volunteer projects/services take some City staff time, as volunteer efforts need to be coordinated with other City activities; and

WHEREAS, before new projects or services are implemented, potential future resource requirements must be addressed. Projects or services provided by volunteers oftentimes become a permanent part of what the City does. Volunteer efforts are not always permanent as funding or volunteer worker time may stop. This may put the City in the difficult position of having to continue the service/maintain the project improvements or discontinue funding maintenance of a project or providing a service the community likes and assumed was permanent.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BROOKINGS THAT:

- 1. Volunteer projects on city-owned property or services provided in the name of the City must be approved by the City before work begins. This includes changes to existing projects or services and projects or services funded by grants or donations.

Comments on "DRAFT" Curry County State Parks Master Plan - 1999

Background:

- 1. Oregon State parks and Recreation Department (OPRD) is doing this Master Plan on all 17 of their properties in Curry County.
- Between Councilor Pepper, Planning Director Bischoff, and I, someone from the City has attended all of the steering committee meetings in Gold Beach on this plan.
- 3. OPRD has issued this draft plan and we have until June 11, 1999, to submit any written comments we want to make.
- 4. Parts of this plan will ultimately come back to Council for review before it is officially adopted by OPRD.
- 5. The complete "DRAFT" Plan is available for review in the City Manager's office.
- 6. Suggested comments for us to make in writing to OPRD are listed below:

A. SUGGESTED GENERAL COMMENTS:

We appreciate OPRD making this project a priority NOW, devoting considerable staff resources to it and giving us the opportunity to be involved in developing this important plan.

- ★ Generally, we agree with "Recreation Needs" and "Goals" and "Development Concepts" for OPRD parks/areas in central and southern Curry County.
- ★ OPRD should not go further into direct competition with private business - NO additional RV sites - NO store in Harris Beach State Park unless it is a privately run concession.
- ★ Insert the word "sometimes" in last sentence on page 17 so it would read "Sometimes in July, the hottest month inland, cold off-shore currents result in fog along the coast."
- ★ Replace the word "tremendously" with the word "steadily" in last sentence of page 20 so it would read "The Brookings area has grown steadily in recent years creating an increased demand for access to natural places, for recreation and for interpretation of the areas natural

and cultural history."

- ★ We agree it is important to complete the Coast Trail and provide better identification signs, trail improvements, and improved mapping.
- ★ We agree it is important to retain existing ocean views and to create a few more.
- ★ We agree it is important to provide better and expanded river access for fishing.
- ★ We agree it is important to expand parking at beach accesses
- ★ We would like to see the plan include acquiring more access sites to more beaches.

B. <u>SUGGESTED COMMENTS ON SPECIFIC PARKS/AREAS IN THE</u> CENTRAL AND SOUTH PART OF CURRY COUNTY:

- ★ Page 200 How would you "Limit effects of Borax Development on east side of 101"?
- ★ We support the Canopy Project and urge you to work with all other appropriate entities to site the Discovery Center portion of this project at your Twin Rocks location.
- ★ We urge you to overcome the obstacles and move the Welcome Center at Harris Beach Wayside to Crissey Field. Use the new facility as a showcase for new environment friendly technologies (solar, etc) as well as for touting the attributes of this section of Oregon and, assuming other agencies partner to build this facility, California.
- ★ Kill the gorse (not only here, but in all Curry County State Parks)
- ★ We're pleased to see it publicly acknowledged, in writing, the department has long had a "desire to relocate the Harris Beach Welcome Center to a place closer to the Oregon/California border".
- ★ Please continue to work with ODOT on access issues to the Crissey Field Welcome Center. If they require a "ramp interchange structure", it is appropriate they (using our gas tax dollars) pay for it!
- ★ We think the comment about using the Orick, California facility as a model of architectural style for the Crissey Field Welcome Center is a great idea.

IV. PROPERTY PURCHASE

Mayor Hagbom asked Community Development Director Leo Lightle to present a status report. Lightle reviewed information clarifying negotiations of the purchase of property for city yard, city shops and city equipment storage from John and Pat Curry. He detailed specific changes in the purchase contract since the Council had last reviewed it, including the standard specifications.

Finance Director Gail Hedding discussed the particulars of the finance arrangements, making clear the purchase price of \$305,000, payment date and amounts to reflect a payment of \$200,000 on May 12, 1999, which would close escrow, if a clear title report is furnished. She also indicated there would be a final payment on July 15, 1999, of \$105,000 plus interest (\$1,605.20). Borrowing from within would generate a savings of \$1,846. Hedding advised she had discussed all these arrangements with City Auditor Lee Musser and he concurred.

Discussion ensued with questions, including parking and rental costs, being fielded by City Manager Weldon and Department Heads Hedding and Lightle. Weldon thanked both Department Heads for their good work putting this sale and the financing together. The Council concurred.

Councilor Pepper moved, Councilor Johns seconded, and the Council voted unanimously to authorize the Mayor to sign the Real Estate Agreement for the purchase of the property (Assessor's Map 40-13-6DD TL800) under the terms and conditions listed in the Real Estate

Agreement presented.

V. RESOLUTIONS

A. Approval of Resolution No. 99-R-658 - Approval of interfund loan for the purchase of property

Councilor Pepper moved, Councilor Johns seconded, and the Council voted unanimously to approve Resolution No. 99-R-658, for approval of interfund loan for the purchase of property for city yard, city shops and city equipment storage area.

Mayor Hagbom recommended sending get well flowers/arrangements to Curry County Commissioner Bill Roberts and ex-County Commissioner TV Skinner. The Council concurred.

Councilor Keith Pepper provided an update on the post office project, indicating the project was going to bid this month with construction hopefully beginning in June or July. Architect Hillard stated a letter would be forthcoming. City Manager Weldon advised the Council the manufactured home on said property will be moved soon to Gold Beach and CTR will remove any debris remaining after the building is torn down for a cost of \$200.

Councilor Ciapusci informed the Council he had discussed with Brookings-Harbor 17C School District Superintendent Paul Prevenas regarding the summer educational program targeted for June 1, 1999. Prevenas had asked for the community's and the Council's support.

City Manager Weldon informed the Council that HOPE had received a \$10,000 grant, of which \$500 had been donated to the Senior Class' Safe & Sober Graduation Party and monies were still available for high school dances, training for youth association boards, etc. Mayor Hagbom informed the Council he and Weldon would be meeting with the Claverans and State Land Department Director Paul Cleary relative to the golf course later this week.

V. <u>ADJOURN</u>

Councilor Curry moved, Councilor Pepper seconded, and the council voted unanimously to adjourn the meeting at 12:28 PM.

Also to amend Section 176, Land Division, of the Land Development Code, to reflect the new wording and provisions of

Section 100, city initiated. Mayor Hagbom explained the procedural requirements for this change and the appeals process. He asked for any objections to the jurisdiction of the Council to hear this matter; if any Councilor wished to abstain from participating because of a conflict of interest or bias; and if any Councilor needed to declare an ex parte contact due to contact with the applicant, any other party involved in the proceedings or any other source of information regarding the subject of the hearing. There being no comment on any of these, City Planning Director John Bischoff presented the subject amendment. He continued his report regarding the change request with reference to diagrams and written reports, including the chronology of the request. Bischoff then offered the staff recommendations for the changes to Sections 100 and 176, to the Council.

Discussion ensued. Bischoff and City Manager Tom Weldon answered questions put forth from the Council. New Councilor George Ciapusci commented on the request and his involvement from his prior Planning Commission membership.

He informed the Council of the next festival meeting set for Saturday May 15th at 9:00 AM at Sandy's Country Kitchen. He thanked Coos Curry Electric for putting up the banners across U.S. 101, and reminded everyone parade applications were still available until May 21st. Cohen advised this Thursday, May 13th at Noon, the monthly forum would be held at the Best Western Brookings Inn Conference Center. Brookings-Harbor 17C School District Superintendent Dr. Paul Prevenas would be speaking on safe & drug free schools.

2. Businesses for a Better Brookings

Vice President Augie Kofoet reported six crab pot trash cans had been purchased and placed on Chetco Avenue, and that their organization was in the process of completing the necessary permit requests from ODOT through Community Development Director Leo Lightle to allow additional trash cans and benches. Kofoet also thanked the City for placing the organization's recent flyer in the City employees' paychecks. • Building permits were issued for 2 single family dwellings; 4 single family additions; 4 single family garages or carports; 1 manufactured home and its garage; and 6 commercial changes. Total value of the new construction was \$946,085.39. One building was removed

We thought you'd want to know

- The engineers are working on the design for the slide on Old County Road which is presenting some challenges in draining the footing for the rip rap that will need to be placed. We'll keep you posted.
- Remodeling is continuing at South Coast Lumber's Railroad Avenue facility. A new peaked roof is being built over the existing rounded roof.
- Two restaurants on Chetco Avenue are increasing their serving capacity. Rancho Viejo is adding additional dining space. Pasta Pasta will be opening in the old BJ's Video spot next door to the Mexican eatery. Rick and Carla Jackson of Chives will be operating Pasta Pasta as a fast food pasta restaurant for lunches only, reopening Chives for the dinner hour.
- If all goes according to plans, tenants will be moving into Azalea Reach on Lundeen Lane July 1.
- Interviews for two treatment plants assistant operators will be held May 3. Seven candidates will be interviewing for the two positions. A total of fifty applications were received.

Projects in Progress

WWTP Expansion

Wildish Building, the general contractor for the construction on the Wastewater Treatment Plant, has arrived in Brookings and set up their offices. The demolition of the old abandoned trickling filter is complete, and the contractor is locating all underground lines in preparation of major excavation for the construction. Lewis Gray, our inspector from Brown and Caldwell, is on site.

The city was able to get a temporary easement so that Chetco Point Park can remain accessible to the public during construction. Yvonne Dunn of Premier Properties was able to secure the easement from Dan Agnew, owner of the property. A sign has been placed directing the public to the easement which is between "the berm" and the fence on the eastern boundary of the WWTP.

 Ransom Street Pedestrian Walkway construction is underway, and if the rain will stop, the project will be completed by the time you read this article. Tidewater Contractors are making excellent progress and are meeting the challenge of working with existing conditions including steep grades and drainage to contend with in completing the project.

Coming Up

• We'll soon be able to put together the specifications to go out to bid on the fencing for the new city yard. Before we fence the yard we need to cut the slope back to install sidewalk and donate to the City of Brookings 10 feet of right-of-way on Cove Road to accommodate additional width needed for sidewalk and street area. We aren't going to appeal the asking for additional right-of-way as the City Planner has this ethical ideal of treating everyone the same (obviously I'm kidding about the appeal).

I was phoned by Clifford Misener about 10 months ago because he thought I owned property bordering the West side of Highway 101. He said that the trees on the West side of 101 obstructed the view of the ocean and asked for permission for him and some friends to cut down some of these trees. At that time I viewed it as a crank call and dismissed it from my mind.

My neighbors and I live in a Subdivision on Beach Avenue which was developed in the 1940's by Archie Anderson. The entrance is from 101 and is between Ransom and Parkview. Archie landscaped the entrance with alders, camellias and conifers to provide a natural barrier against road noise and exhaust pollution. This area has been carefully and lovingly maintained by him and by his successors, Rich and Linda Johnson, for more than 50 years.

A peaceful and beautiful walking/bicycle path lies between this natural barrier and homes to the West.

The trees associated with this entrance are Mr. Misener's principal target. His home is on the East side of 101. The trees he objects to are obstructing his ocean view.

At this point there is already a traffic hazard along this stretch. From the North, traffic moves from 50 miles an hour to a fast slowdown to 35MPH at Ransom. That is not a place for distraction by an ocean view. It's r end collisions waiting to happen. There's now additional turning in and out traffic from the new Nazarene Lurch right there. From the South, at Ransom, Highway 101 changes to 2 lanes suddenly and the speed limit moves up. Cars heading North step on the gas immediately. It's scary now trying to slow down to get into the Beach Avenue entrance without being hit from behind. We certainly don't need the additional hazard of an

Just at the area we're discussing, Highway 101 crosses Ransom Creek. This flows year round and passes a number of homes on its way to the ocean. Some of the trees offending Mr. Misener are rooted along the banks of this river. Trees and vegetation associated with the river should not be disturbed. Erosion problems can damage these homes. A study must be made to determine the effect of removing trees, vegetation and trampling along the river banks.

There are many wonderful ocean view points in this stretch between Gold Beach and Brookings. In fact one of the best views is from the viewpoint at the entrance to Harris Beach State park. This is .1 mile North of Ransom. There is ample parking and people can get out of there cars, stretch and give their full attention to the magnificent view. This is the way to enjoy the ocean. Not by a quick and dangerous glance from a speeding car.

I hereby express my total disapproval of this idea. I hope the council recognizes dissimulation when it arises and concurs. Cel Bernhand Jerua Seruhard
