

## **PROCLAMATION**

WHEREAS, Brookings is committed to providing each member of it's community an environment free from intimidation, fear and violence; and

WHEREAS, all Brookings residents, regardless of membership or perceived membership in a particular group should feel safe from intimidation, fear and violence; and

WHEREAS, our community is aware of and horrified by the beating death of Matthew Shepard in Laramie, Wyoming, the shooting death of Oumar Dia in Denver, Colorado, the dragging death of James Byrd in Jasper, Texas, and numerous other crimes of hate and intimidation; and

WHEREAS, our community wishes to take a proactive stance by denouncing crimes of hate that may incubate when good people remain silent; and

WHEREAS, when any one person is assaulted, threatened or their property damaged because of their membership, or perceived membership, in a particular group, every member of our community is affected and our values of freedom and fairness are trampled upon.

NOW, THEREFORE, I, Nancy Brendlinger, Mayor of the City of Brookings, Oregon, do hereby proclaim the week of November 23 through 27, 1998 as

## "HATE CRIMES AWARENESS WEEK"

in Brookings and proclaim that crimes motivated by hate will not be tolerated in our community. We hope that our community will teach others a lesson of peace, and be used as an example of the unity of all people.

## PROCLAMATION

WHEREAS, the global spread of the HIV infection and AIDS necessitates a worldwide effort to increase communication, education and action to stop the spread of HIV/AIDS; and

WHEREAS, the Joint United Nations Programme on HIV/AIDS (UNAIDS) observes December 1 of each year as World AIDS Day, a day to expand and strengthen the worldwide effort to stop the spread of HIV/AIDS; and

WHEREAS, UNAIDS now estimates that 30.6 million people are currently living with HIV/AIDS, with young people under the age of 25 accounting for at least half of all new infections; and

WHEREAS, the American Association for World Health is encouraging a better understanding of the challenge of HIV/AIDS nationally as it recognizes that the number of people diagnosed with HIV and AIDS in the United States continues to increase, with over 641,086 AIDS cases reported (as of December 31, 1997); and

WHEREAS, World AIDS Day provides an opportunity to focus on HIV infection and AIDS, caring for people with HIV infection and AIDS, and learning about HIV/AIDS; and

WHEREAS, the 1998 World AIDS Day theme "Be a Force for Change" [a] challenges young people around the world to recognize the crucial role they play in the ever-changing course of the AIDS pandemic, [b] aims to motivate young people to get involved in reducing the spread of HIV; and [c] encourages them to have compassion for and lend support to those affected by HIV/AIDS;

NOW, THEREFORE, I, Nancy Brendlinger, Mayor of the City of Brookings, do hereby declare December 1, 1998 as

# "WORLD AIDS DAY"

in Brookings and invite all citizens to take part in a candlelight vigil December 1, 1998 from 6:00 p.m. to 6:30 p.m. at Chetco Avenue and Fifth Street in Brookings (City fountain near Ray's Food Place). This vigil is designed to increase awareness and understanding of HIV/AIDS as a global challenge and to join the global effort to prevent the further spread of HIV/AIDS.

Extension of City's cable TV franchise with Falcon Cable

Background:

- 1. Our franchise with Falcon expired November 10<sup>th</sup>, 1998.
- 2. The Mayor and I have been working with Curry County officials and our joint consultant on this matter in developing a proposed new franchise.
- 3. That proposed new franchise is still a "work in progress" that is, it is not finished and has not been officially negotiated with Falcon Cable.
- 4. Falcon Cable has asked us to extend the franchise 6 months.
- 5. Curry County has also been asked and has approved extending their franchise.

Recommendation:

Extend Falcon Cable's franchise 6 months by authorizing Mayor to sign attached extension form.

# AGREEMENT TO EXTEND THE FALCON CABLE TV FRANCHISE IN THE CITY OF BROOKINGS

This agreement is entered into by and between the City of Brookings, a Political Subdivision of the State of Oregon, and Falcon Cable TV, as follows:

WHEREAS, the non-exclusive franchise agreement granted by the City of Brookings to Falcon Cable TV for cable television installation, construction, operation, and maintenance of a cable television system in the City of Brookings expires November 10, 1998; and

WHEREAS, by letter dated November 3, 1998, Falcon Cable TV has requested that the City extend the present franchise for a six month period while the new franchise is being negotiated; and

WHEREAS, to allow additional time for the negotiation for a new franchise, the Council deems it in the public interest to extend the current franchise for a period of six months;

NOW, THEREFORE, IT IS HEREBY AGREED by and between the parties that the franchise agreement between them embodied by Ordinance No. 83-O-380 as amended by Ordinance No. 420, a copy of which is attached, be continued on the same terms and conditions until May 10, 1999.

CHILDREN PLAYING sign.

Issue: Deferred Improvement Agreement program.

Synopsis: The Council, Planning Commission and staff have been studying the issue of

DIAs and how to proceed with a program that is not working as intended.

Background: Currently, under Section 172, Street Improvement, Deferred, Subsection 070.A. of the Land Development Code, deferred improvement agreements may be allowed under the following conditions:

> A. Street improvements may be deferred when the project site complies with the following criteria:

1. If more than 50 percent of the street segment's frontage and area having frontage on the segment is unimproved; or,

2. If more than 50 percent of the area having frontage on the street segment is developed and less than 50 percent of the street segment is improved.

Under these conditions, virtually every street in the city qualifies to be deferred and the result is that we have streets fully developed with houses and recorded DIAs but no street improvements. Although staff has issued 143 DIAs since the program started, the related development is rather evenly distributed throughout the city. Also many of the new single family homes, which would also generate a DIA, are constructed in subdivisions where street improvements already exist. Thus few streets or street segments have accumulated enough DIAs to qualify to be ordered into a local improvement district.

Recommendation: Staff is therefore making four recommendations:

- 1. Reverse existing policy. The Land Development Code does not state that DIAs must be given-it states that they may be given under the conditions listed above. Deferred Improvement Agreement in the future would be allowed only when it is not feasible to require street improvements at the time of development.
- 2. Form a local improvement district for the segment of Ransom Ave. between Third and Sixth Streets to at least provide sidewalks. This section qualifies (26 DIAs out of 39 property owners) and is also one where improvements are badly needed.

- 3. Prioritize qualifying streets for future local improvement districts and incorporate them into the Capital Improvement Plan.
- 4. Prioritize a list of needed sidewalks and incorporate this list into the Capital Improvement Plan which will be adopted by the Council at their January 11<sup>th</sup> meeting.

### Options/Alternatives:

Listed Below are the options we have reviewed and do not recommend.

- 1. Continue under the current DIA program.
- 2. Eliminate the DIA program entirely.

ISSUE:

Authorization to sign the Special Cities Allotment Grant agreement.

SYNOPSIS:

The City Council authorized applying for a Special Cities Allotment Grant last April. This grant provides \$25,000 towards a street improvement project. We submitted the continuation of the Oak Street Improvement Project as our 1999 project and were successful in getting the grant. The Oak Street Project or portions of the project are listed in the City of Brookings Capital Improvements/Expenditure Plan 1996-2001 (CIP/EP) with funding possible from both System Development Charges (SDC) and System Replacement Fees (SRF).

The recommended continuation project is estimated to cost \$40,000 with the city paying the \$15,000 over the state's \$25,000 share. Forty-five percent (45%) of the city's portion will come from SDC funds (\$6,750) with the remaining fifty-five percent (55%) from SRFs (\$8,250).

We are required to have the agreement authorized during a regularly scheduled meeting of the City Council.

RECOMMENDATION:

The City Council authorize the agreement and the signing of the agreement by the City Manager for the Special Cities Allotment Project: Oak Street Improvements.

## 1999 SPECIAL CITY ALLOTMENT AGREEMENT Oak St. (Spruce St. – Railroad St.)

THIS AGREEMENT is made and entered into by and between THE STATE OF OREGON, acting by and through its Department of Transportation, hereinafter referred to as "State"; and the CITY OF BROOKINGS, a municipal corporation of the State of Oregon, acting by and through its City Officials, hereinafter referred to as "City".

#### WITNESSETH

#### RECITALS

1. By the authority granted in ORS 366.800 and 366.805, there has been withdrawn from State Highway Funds appropriated for allocation to cities of the State of Oregon the sum of \$500,000 and an additional \$500,000 available to the Department of Transportation from the State Highway Fund. These sums have been set up in a separate account to be administered by the Department of Transportation. The \$1,000,000 shall be allotted each year by the Transportation Commission for use upon city streets that are not a part of the state highway system, that are within cities with populations of 5,000 or fewer persons, and that are inadequate for the capacity they serve or are in a condition detrimental to safety. No one project can receive more than \$25,000.

**NOW THEREFORE**, the premises being in general as stated in the foregoing RECITALS, it is agreed by and between the parties hereto as follows:

#### TERMS OF AGREEMENT

- 1. By the authority granted in ORS 366.805(2), City has requested moneys from this account for the improvement of Oak Street, from Spruce Street to Railroad Street, hereinafter referred to as "project. The total estimated cost of this project is \$40,000. Attached hereto, marked "Exhibit A" and by this reference made a part hereof, is a sketch map showing the location and approximate limits of the project.
- 2. State has considered City's request for the project and has determined that this project is eligible for funding under the Special City Allotment Program.
- 3. The parties hereto mutually agree and understand that the cost of said project shall be paid for by Special City Allotment funds and by City as follows: Special City Allotment funds will pay for eligible project costs up to an amount not to exceed \$25,000, and City shall pay any costs in excess of \$25,000. State shall issue payments after January 1, 1999.

- 4. Documented cost of preliminary engineering and construction engineering services performed by the City or the City's consultant are eligible project costs.
- 5. This agreement shall become effective upon execution of this agreement by all parties and shall terminate on December 31, 2000 unless an amendment is executed extending said termination date.

#### STATE OBLIGATIONS

- 1. State shall administer the funds in the Special City Allotment Account in the following manner:
  - (a) After January 1, 1999, State shall, upon execution of this agreement, and concurrence on the plans and specifications, advance City one-half (50%) of the estimated cost of the project, not to exceed \$12,500.
  - (b) State shall, upon satisfactory final inspection by State and certification of acceptance of work by the City, accompanied by documentation of all project costs, make final payment to City. Total payments to City, including advance payment, shall not exceed a total of \$25,000.

#### CITY OBLIGATIONS

- City shall provide all right-of-way at its sole expense. The acquisition of real property must comply with current Oregon law, including, but not limited to ORS 281.045 through ORS 281.105.
- 2. City shall relocate or reconstruct, or cause to be relocated or reconstructed, all privately or publicly owned utility conduits, lines, poles, mains, pipes and all other facilities of every kind and nature where such relocation or reconstruction is made necessary by the plans of the project in order to conform the utilities and other facilities with the plans and the ultimate requirements of the project.
- 3. City shall prepare, or cause to be prepared, the plans and specifications for said project and advertise the project, contract the work, do the construction engineering, and make the necessary contract payments, unless otherwise agreed upon.
- 4. City shall submit a set of the plans and specifications to State for review and concurrence, prior to advertising the project for bids.

- 5. City shall, during the course of the work, accumulate and retain documentation for all project costs.
- 6. Upon completion of the project, City shall certify to State that the project is complete and in substantial conformance with the plans and controlling specifications. City shall submit a billing for the remaining cost of the project which, when added to the amount previously advanced by State, shall not exceed the actual total cost of the project or \$25,000, whichever is the lesser.
- 7. Upon completion of the project, City shall provide maintenance at its sole expense.
- 8. City understands those streets or portions of streets, upon which SCA funds have been expended, are not eligible for additional SCA funds for a period of 10 years following the approval for such funds.
- 9. City understands that if the project is canceled by City, or not completed within the time requirements or in accordance with the terms of this agreement, after City has received the advance of one-half (50%) of the estimated cost of the project or \$12,500, whichever is less, City shall immediately repay to State the full amount of the advance.
- 10. City, its consultants or subcontractors, if any, and all employers working under this agreement are subject employers under the Oregon Workers' Compensation Law and shall comply with ORS 656.017, which requires them to provide workers compensation coverage for all their subject workers.
- 11. City agrees to comply with all federal, state, and local laws, regulations, executive orders and ordinances applicable to the work under this agreement, including, without limitation, the provisions of ORS 279.312, 279.314, 279.316, 279.320, and 279.555, which hereby are incorporated by reference. Without limiting the generality of the foregoing, City expressly agrees to comply with (i) Title VI of Civil Rights Act of 1964; (ii) Section V of the Rehabilitation Act of 1973; (iii) the Americans with Disabilities Act of 1990 and ORS 659.425; (iv) all regulations and administrative rules established pursuant to the foregoing laws; and (v) all other applicable requirements of federal and state civil rights and rehabilitation statutes, rules and regulations.
- 12. City acknowledges and agrees that State, the Secretary of State's Office of the State of Oregon, the federal government, and their duly authorized representatives shall have access to the books, documents, papers, and records of City which are directly pertinent to the specific agreement for the purpose of making audit, examination, excerpts, and transcripts for a period of three years after final payment. Copies of applicable records shall be made available upon request. Payment for costs of copies is reimbursable by State.

13. City shall adopt an ordinance or resolution authorizing the Mayor and Recorder to enter into this agreement.

#### GENERAL PROVISIONS

1. This agreement may be terminated by mutual written consent of both parties.

State may terminate this agreement effective upon delivery of written notice to City, or at such later date as may be established by State, under any of the following conditions:

- A. If City fails to provide services called for by this agreement within the time specified herein or any extension thereof.
- B. If City fails to perform any of the other provisions of this agreement, or so fails to pursue the work as to endanger performance of this agreement in accordance with its terms, and after receipt of written notice from State fails to correct such failures within 10 days or such longer period as State may authorize.
- C. If State fails to receive funding, appropriations, limitations or other expenditure authority at levels sufficient to pay for the work provided in the agreement.
- D. If Federal or state laws, regulations or guidelines are modified or interpreted in such a way that either the work under this agreement is prohibited or State is prohibited from paying for such work from the planned funding source.

Any termination of this agreement shall not prejudice any rights or obligations accrued to the parties prior to termination.

- 2. City maintenance responsibilities in City Obligation No. 7 shall survive termination of this agreement if project is completed and accepted.
- 3. This agreement and attached exhibits constitute the entire agreement between the parties on the subject matter hereof. There are no understandings, agreements, or representations, oral or written, not specified herein regarding this agreement. No waiver, consent, modification or change of terms of this agreement shall bind either party unless in writing and signed by both parties and all necessary approvals have been obtained. Such waiver, consent, modification or change, if made, shall be effective only in the specific instance and for the specific purpose given. The failure of State to enforce any

provision of this agreement shall not constitute a waiver by State of that or any other provision.



ISSUE:

Ordinance 430 Amendment: sewer main frontage for connection

**BACKGROUND:** 

We have been notified that a property at the end of Center Street had its septic tank drain field fail and there is no room to construct another drain field and therefore the drain field could not be repaired. Subsequent to the county's letter we received a request from the property owner to hook to the sewer.

There is a sewer main that crossed this property. It is a pressure main used by high pressure, high volume pumps and the pressure and volume created by the pumps eliminates any other use of this pressure main.

Traditional new sewer main construction would require a pump station plus a pressure line and a gravity line to serve the area. It is not cost effective to have a municipal pump station that would have to be monitored daily to serve one home or even if all the homes connected in this area, five homes.

This ordinance amendment would allow connection with a private line to an existing manhole with a private individual pump station as we allow in areas identified as a geological hazard.

This amendment will allow the city to address a problem that occurred in the city that was not anticipated when the ordinance was written.

Issue:

Need for and the purchase of a Command Vehicle/Crime Scene/Search Warrant vehicle for the Brookings Police Department

Background:

- 1. We have budgeted monies for the Narcotics Unit to purchase equipment/vehicle for the budget year 1998-99. We are not able to find used vehicles at a price that we can handle, so we are requesting permission to buy from a single source.
- 2. I have checked with two recognized coach dealers in Oregon and Washington in regards to used Class III vehicles (a certain size and type of ambulance). I have been advised that the sales of the used vehicles is based on it's ability to be re-classified for ambulance use.
- 3. I have located two Class III vehicles, one in Oregon and one in Washington. The Washington vehicle is a 1984 Class III with 77,000 miles and priced at \$6,800. The Oregon vehicle is located in the Portland area and is a 1985 Class III with 84,000 miles and priced at \$3,900. This vehicle has four new tires and emergency lights.
- 4. This vehicle would be purchased from the drug forfeiture funds. These funds can only be used for certain items and the Emergency Response Vehicle would fall in that category. The only cost to the City of Brookings would be for maintenance and insurance.

The vehicle's primary use would be in narcotic investigations, serving search warrants and seizing methamphetamine laboratories. Currently we use several vehicles to transport an entry team to a search warrant location. Often times we operate during darkness and in rainy weather. This vehicle would also function as the mobile command post during law enforcement operations. This vehicle would be equipped with radio equipment that would enable the command officer to be in contact with all law enforcement agencies as well as fire and ambulance personnel.

This vehicle would provide a place for the search team to be out of the weather as well as suspects during their interviews. This vehicle would provide a safe place to secure all evidence. We would be able transport an outside light source (generator) for the Officer's use. In case of an officer being injured, we would be able to render first aid out of the weather. The vehicle would also be available for use by the Curry County Major Crimes Team.

Recommendation:

Council authorize the purchase of the 1985 Class III Coach from Wheel Coach, Inc. in the amount of \$3,900, using drug forfeiture funds.

### **RESOLUTION NO. 98-R-647**

# A RESOLUTION EXEMPTING FROM COMPETITIVE BIDDING THE PURCHASE OF A 1985 CRIME SCENE/SEARCH WARRANT VEHICLE.

THE COMMON COUNCIL OF THE CITY OF BROOKINGS FINDS AS FOLLOWS:

- 1. The City of Brookings needs to purchase a used vehicle for the Police Department to be used as a Crime Scene/Command and Search Warrant vehicle.
- 2. The City of Brookings has investigated the availability of vehicles to purchase. Cost savings can be realized by purchasing a 1985 unit instead of a new vehicle. The City has determined that Wheeled Coach is the only dealer with a 1985 or newer unit registered as a Class #3 vehicle within the budget constraints of the Brookings Police Department.
- 3. Because of limited availability of these types of vehicles and because cost savings can be realized through the purchase of this vehicle from a single source outside the City of Brookings, the Common Council finds that it is in the best interest of the City of Brookings to exempt the purchase of the 1985 search warrant vehicle for the Police Department from competitive bidding.
- 4. It is unlikely that an exemption from competitive bidding in this instance would encourage favoritism in the awarding of contracts or diminish competition.

NOW, THEREFORE BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BROOKINGS THAT:

The purchase of a 1985 vehicle for the City of Brookings Police Department, as identified above, is exempt from competitive bidding requirements set out in ORS Chapter 279 and the City of Brookings Resolution No. 92-R-539.

## RESOLUTION NO. 98-R-648

A RESOLUTION ADOPTING A POLICY ON VOLUNTEER PROJECTS AND/OR SERVICES SPONSORED BY THE CITY.

WHEREAS, the Brookings volunteer City Council is elected to oversee City assets and City provided services; and

WHEREAS, Brookings has a wealth of volunteers and volunteer groups. Hundreds of these individuals and many groups have been associated with the city and have provided wonderful things-projects and services the citizens of this community would not have enjoyed without these volunteers; and

WHEREAS, the City of Brookings' insurance covers volunteers working on City property and those volunteers working under the name of the City of Brookings while providing services; and

WHEREAS, all City-related volunteer projects/services take some City staff time, as volunteer efforts need to be coordinated with other City activities; and

WHEREAS, before new projects or services are implemented, potential future resource requirements must be addressed. Projects or services provided by volunteers oftentimes become a permanent part of what the City does. Volunteer efforts are not always permanent as funding or volunteer worker time may stop. This may put the City in the difficult position of having to continue the service/maintain the project improvements or discontinue funding maintenance of a project or providing a service the community likes and assumed was permanent.

# NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BROOKINGS THAT:

- 1. Volunteer projects on city-owned property or services provided in the name of the City must be approved by the City before work begins. This includes changes to existing projects or services and projects or services funded by grants or donations.
- 2. All grants must be approved by the City Council before they are applied for.

- 3. New minor projects or services or changes may be approved by the City Manager.
- 4. Other projects or services or changes must be approved by the City Council and this requires that volunteers work with the City Manager (or other designated staff) and any appropriate city volunteer advisory committee, such as the Planning Commission or Parks and Recreation Commission before being considered by the City Council.

The City of Brookings ordains as follows:

Section 1. Ordinance Identified. This ordinance amends Ordinance No. 88-O-430, enacted December 15, 1998, and entitled, "AN ORDINANCE REGULATING THE USE AND DISCHARGE OF WASTES INTO THE PUBLIC SEWERS OF THE CITY OF BROOKINGS, OREGON; PROMULGATING THE REGULATIONS; AND PROVIDING PENALTIES.

Section 2. Amendment to Article II Section 3. Ordinance No. 88-O-430, Article II Section 3 is amended by the addition of Subsection E which reads as follows:

Where a septic system is failing and the septic system cannot be repaired and the installation of a sewer main will require pumping of the sewer and due to limited use it is not practical to install a municipal pump station, the City may approve the installation of sewer service to properties which do not have frontage on a public sewer main in accordance with such terms and conditions as may be recommended by the City's engineer and such approval may specify conditions of approval which must be satisfied prior to connection to the City's sewer system. The City upon review of the facts at their sole discretion will decide if the connection is exempt from fronting on a public sewer main. Verification of a failing septic system must be received, in writing and from the Curry County Sanitarian before such installation will be considered by the City.
