Councilman Nidiffer made a MOTION, seconded by Councilman Howell, to approve the minutes of the April 13, 1987 Council Meeting; MOTION carried unanimously.

Councilman Howell made a MOTION, seconded by Councilman Peterson, to approve the minutes of the April 23, 1987 Special Council Meeting; MOTION carried unanimously.

B. Acceptance of Planning Commission Meeting Minutes

1. April 7, 1987 Regular Planning Commission Meeting

Councilman Nidiffer made a MOTION, seconded by Councilman Howell, to accept the minutes of the April 7, 1987 Regular Planning Commission Meeting; MOTION carried unanimously.

VI. SCHEDULED PUBLIC APPEARANCES

A. 1987-88 Budget - Public Hearing

Mayor Kerr opened the public hearing at 7:07 p.m. and turned the floor to Budget Officer Leo Lightle. Mr. Lightle presented a brief overview of the approved 1987-88 fiscal year budget, outlining for the Council and the audience the resources and expenditures proposed.

Mayor Kerr requested questions or comments from the general public or the Council. There being no response, Mayor Kerr closed the public hearing at 7:18 p.m.

Councilman Peterson made a MOTION, seconded by Councilman Nidiffer, to adopt the 1987-88 fiscal year budget; MOTION carried unanimously.

Mayor Kerr announced a public hearing at 7:19 p.m. for the purpose of discussing the 1987-88 Federal Revenue Sharing expenditures. Mr. Lightle indicated that there are no resources or expenditures for Federal Revenue Sharing in the 1987-88 budget. Mayor Kerr closed the hearing at 7:20 p.m.

B. . Alley Vacation - Pacific Avenue

Planning Director Richard Ullian explained to the Council that one of the stipulations for approving this alley vacation was that a quitclaim deed would be presented to the City for a portion of right-of-way on Pacific Avenue. Mr. Ullian indicated that the deed has not been received yet, due to the owner of that property being out of State. Mr. Ullian requested that this agenda item be continued to the June 8, 1987 Council meeting.

Councilman Peterson made a MOTION, seconded by Councilman Nidiffer to continue the public hearing to the June 8, 1987 Council meeting; MOTION carried unanimously.

VII. COMMUNICATIONS/ANNOUNCEMENTS

A. Mayor Announcements

Mayor Kerr read portions of a letter from the Pelican Bay Arts Association, requesting permission to utilize a portion of Stout Park for their gallery, the reason being that the State of Oregon is contemplating charging the Association \$100 per month for their land rent in Harbor. The Pelican Bay Arts Association is a non-profit organization and they have said that they cannot afford the rent requested.

Mayor Kerr indicated that since the Manley Arts Center is being used already for the arts he saw no problem in working with the Arts Association on their proposed project.

After a brief discussion, Councilman Nidiffer made a MOTION, seconded by Councilman Howell, to grant approval to the Arts Association to use a portion of the Stout Park property and to enter into negotiations with the Association for that purpose; MOTION carried unanimously.

B. Council Announcements

Councilman Howell announced that the Curry County Strategy Committee has submitted their final strategy proposal to the Governor and they have been told that the report is excellent.

C. Planning Commission Announcements

Chairman Leo Appel II announced that the next CAC meeting will be held in the City Manager's Office on February 21, at 7:00 p.m. and he invited all to attend.

D. Manager Announcements

City Manager Roy Rainey indicated that this is the time of year when the local vendors must renew liquor licenses and the Council, according to OLCC, must recommend granting or denial. Mr. Rainey indicated that the Police Department has reviewed the renewal applications and has no objections to the recommendation to grant the following renewals:

D. Manager Announcements (continued)

2. Insurance Proposal Update

Mr. Rainey indicated that Recorder/Treasurer Beverly Shields has been attempting to gather insurance quotes for fiscal 1987-88, but at this time the insurance carriers either do not have final quotes available or prefer not to give quotes this far in advance of the July 1 renewal date, primarily because of the possibility of rate changes between now and July 1.

Mr. Rainey indicated that staff should be able to present several insurance quotes at the June Council Meeting.

3. Irrigation Rate - 1987

Mr. Rainey indicated that staff recommends that the summer water irrigation rate be handled as it has in the past two years and the rates stay the same. Staff also recommends that the irrigation rate be in effect during the billing months of July, August and September.

Councilman Nidififer made a MOTION, seconded by Councilman Howell, to initiate the summer water irrigation rate for the summer months of 1987; MOTION carried unanimously.

4. Membership Fees - Coos-Curry Council of Governments

Mr. Rainey indicated that the dues for the 1987-88 membership in CCCOG are \$1,318 and requested Council rejection or approval for paying the dues.

Councilman Howell made a MOTION, seconded by Councilman Nidiffer to approve payment of \$1,318 in dues to the CCCOG for 1987-88; MOTION carried unanimously.

5. Bylaw Amendment Proposal - CCCOG

Mr. Rainey indicated that the City received a letter from Marlyn Schafer, Chairman of CCCOG, proposing to amend the bylaws of the CCCOG by enlarging the Executive Committee from 7 to 9 members, five of which will be elected from General Punpose members and 4 from Special Purpose members, and a quorum would consist of not fewer than 4 members.

Mr. Rainey presented a letter which he had written to Ms. Schafer, outlining some concerns about the proposed amendment. Mr. Rainey was concerned that the Executive Committee "could conceivably become totally representive of either General or Special Purpose Units of Government". Mr. Rainey indicated that this was not the intent or the purpose in establishing Councils of Government originally and makes little sense. Mr. Rainey indicated to Ms. Schafer that he would recommend to the Brookings City Council that the proposal be rejected.

After a brief discussion, Councilman Nidiffer made a MOTION, seconded by Councilman Peterson to hold this matter over for consideration. Councilman Howell asked about the problems of holding up payment of the dues. Ms. Shields informed the Council that the dues are not due until after July 1. Councilman Nidiffer amended his MOTION to say that the dues payment should be held over until the Council has objected to the bylaw amendment proposed to see the outcome of the proposed amendment. Councilman Howell seconded the amended MOTION; MOTION carried unanimously.

6. Audit Contract Proposal

Mr. Rainey presented the Council with a proposed contract from Gerald Burns, City Auditor. The proposed contract is for 3 years. City Attorney John Babin raised some questions concerning the wording of the contract. Mr. Rainey suggested a 1-year audit contract rather than the proposed 3 years.

Councilman Howell made a MOTION, seconded by Councilman Nidiffer, to table this agenda item until the June Council Meeting, thereby giving the City Attorney time to negotiate with the auditing firm; MOTION carried unanimously.

7. Harbor Sanitary District Letter

Mr. Rainey informed the Council that a letter has been drafted to the Harbor Sanitary District requesting a meeting with their Board of Directors regarding the proposed wastewater treatment facilities plan.

8. Golf Course Property Assessment

Mr. Rainey advised the Council that the Curry County Assessor, at a meeting of the Curry County Planning Commission in Gold Beach on Thursday, May 7, 1987, had indicated a possibility of reassessing the property taxes for the proposed golf course for the years preceding the date of the property being given to the City. Mr. Rainey quoted from the Oregon State Statutes that the assessment, under Oregon State Law, cannot be reassessed for prior years.

E. Attorney Announcements

1. Chetco Point Properties

City Attorney John Babin advised the Council that an objection to the record had been filed by Mr. Fred Hummel. Mr. Hummel wanted Exhibits P-6 and P-7 stricken from the record of the proceedings. During a conference call, the Land Use Board of Appeals overruled Mr. Hummel's objection and allowed the exhibits to be retained in the record of proceedings.
