Mayor Kerr called the meeting to order at 7:00 p.m.

IV. CEREMONIES/APPOINTMENTS

A. Proclamation - "Safe Boating Week in Brookings"

Mayor Kerr proclaimed the week of June 6 through 13, 1987 as "National Safe Boating Week in Brookings".

V. MINUTES FOR APPROVAL/ACCEPTANCE

- A. Approval of Council Meeting Minutes
 - 1. May 11, 1987 Regular Council Meeting Minutes

Councilman Howell made a MOTION, seconded by Councilman Peterson, to approve the minutes of the May 11, 1987 Regular Council Meeting; MOTION carried unanimously.

- B. Acceptance of Planning Commission Meeting Minutes
 - 1. May 5, 1987 Regular Planning Commission Meeting

Councilman Batty made a MOTION, seconded by Councilman Peterson, to accept the minutes of the May 5, 1987 Regular Planning Commission Meeting; MOTION carried unanimously.

VI. SCHEDULED PUBLIC APPEARANCES

A. Public Hearing - Wastewater Facilities Plan

Mayor Kerr announced that this agenda item is a public hearing and he opened the public hearing at 7:08 p.m. and turned the floor to Engineering Technician Leo Lightle.

Mr. Lightle briefed the Council on the background and history leading to the compilation of the Wastewater Facilities Plan by the engineering firm of Brown and Caldwell. Mr. Lightle introduced Terry Gould and Brian Paulson of Brown and Caldwell.

Mr. Gould discussed the elements involved in the Facilities Plan, which include the status of the existing wastewater treatment plant, the detail that is included in the scope of the work on the Facilities Plan, the previous public meetings which were held on the Facilities Plan, the public hearing process, the recommended project and the financing packages available.

Mr. Paulson further discussed the financing available for the project, including federal grant monies.

Mayor Kerr closed the public hearing at 8:25 p.m. and turned the meeting to the Council for discussion.

After a brief discussion, Councilman Peterson made a MOTION, seconded by Councilman Batty, to accept the Wastewater Facilities Plan as presented; MOTION carried unanimously.

B. Public Hearing - Alley Vacation, Pacific Avenue

Mayor Kerr opened the public hearing at 8:29 p.m. and indicated that this agenda item was continued from the May 11, 1987 Council Meeting.

Mr. Lightle indicated that the reason for the continuance was that the City was waiting for a deed to be delivered from Mr. Tiny Caudell, and at this time the deed has been received and the staff recommends the vacation of the alley, which is unopen and impassable.

There being no testimony, Mayor Kerr closed the public hearing at 8:31 p.m.

Councilman Batty made a MOTION, seconded by Councilman Peterson, to approve the vacation of the alley located between Pacific Avenue and Pine Street, East of Fern Avenue; MOTION carried unanimously.

VII. COMMUNICATIONS/ANNOUNCEMENTS

A. <u>Mayor Announcements</u>

B. Council Announcements

Councilman Howell announced that beginning with the month of June, he will be presenting awards to outstanding individuals and outstanding groups in the community, on a monthly basis.

Councilman Howell presented his first individual award to Brookings resident Virginia Manley for all of her service and dedication to the citizens of this area.

Councilman Howell presented the group award to the Chetco Senior Center for all of their efforts and dedication on behalf of the seniors of the community. Hazel Weeber, President of the Chetco Senior Center, accepted the award.

Councilman Howell indicated that he would like to see a review of the "Operation Bootstrap" program.

C. Planning Commission Announcements

None.

D. Manager Announcements

1. Liquor License Renewals

Mr. Rainey indicated that these are renewal applications for the following businesses:

Wendy L. Rogers, dba Pickle Barrel Sandwich and Seafood Co. Lawrence and Anne O'Neill, dba Chetco River House

Mr. Rainey indicated that the police department has reviewed the applications and has no objections to the granting of the renewal licenses.

Councilman Peterson made a MOTION, seconded by Councilman Howell, to approve the liquor licenses as presented; MOTION carried unanimously.

2. Insurance Quotes

Mr. Rainey presented the Council with the insurance quotes which were received concerning the Workers Compensation, liability coverage and health insurance. Staff recommended that the City accept the quotes from the League of Oregon Cities for all three coverages.

Councilman Batty made a MOTION, seconded by Councilman Howell, to accept the quotes from the League of Oregon Cities; MOTION carried unanimously.

3. Tanbark Subdivision Plan Approval

Mr. Lightle indicated that according to Sudivision Ordinance No. 217, the plans for the Tanbark Subdivision are presented to the Mayor and Council for approval. Mr. Lightle explained that the engineering firm of H.G. & E is currently reviewing the plans. Mr. Lightle requested that the Mayor and City Council approval the plans with the stipulations recommended by H.G. & E. regarding the storm drainage portion of the project, striking the 1½ shale gravel option of the specifications for the road bed, and subject to bonding cost for construction to be determined by H.G. & E.

Councilman Howell made a MOTION, seconded by Councilman Peterson, to approve the plans for the Tanbark Subdivision with the recommended stipulations; MOTION carried unanimously.

4. 1988 Special City Allotment Program

Mr. Lightle indicated that the City has applied for this project in the past and the project got high marks but has never been funded. Mr. Lightle explained that the project consists of funding for the installation of a connection of Fifth Street to U.S. 101 and requested that the Mayor and City Council authorize City staff to apply again for funding through the 1988 Special City Allotment Program.

Councilman Peterson made a MOTION, seconded by Councilman Howell, to approve the application for the 1988 Special City Allotment Program; MOTION carried unanimously.

5. 1986-87 and 1987-88 Audit Contract

Mr. Rainey indicated that Mr. Gerald Burns has submitted two audit contracts for fiscal years 1986-87 and 1987-88. Mr. Rainey and Mr. Babin indicated that they felt that there was a misunderstanding between themselves and Mr. Burns concerning the audit contract and requested that the matter be tabled until Mr. Burns could be contacted to confirm the contents of the contract.

Councilman Batty made a MOTION, seconded by Councilman Howell, to table the audit contract; MOTION carried unanimously.

E. Attorney Announcements

None.

F. Contract Review Board

A. Copy Machine Purchase

Mr. Rainey indicated that under Oregon Administrative Rules comptetitive bids are not required for this purchase. Mr. Rainey indicated that three quotes were received for the purchase of a copy machine from Mory's, Brookings

After a brief discussion, Councilman Peterson made a MOTION seconded by Councilman Batty, to lease/purchase the Toshiba BD-8412 from Brookings Office Supplies; MOTION carried unanimously.

VIII. CALL FOR BIDS

A. Computer System

Mr. Rainey indicated that according to Oregon Administrative Rules this item does not require competitive bids, but staff would request authority to seek proposals for the computer system which was approved in the 1987-88 budget. Mrs. Shields indicated that the acquisitions process would take approximately one month and staff hopes to have the prices available for Council approval at the July Council Meeting.

Councilman Peterson made a MOTION, seconded by Councilman Batty, to authorize staff to seek proposals on a new computer system; MOTION carried unanimously.

B. Roof Repairs

Mr. Lightle indicated that in September, 1985, the City Council awarded bids to repair a portion of the City Hall roof. The portion that was not repaired at that time is in dire need of repairs at this time. Mr. Lightle requested authorization to call for bids on the roof repairs at City Hall.

Councilman Howell made a MOTION, seconded by Councilman Batty to authorize staff to call for bids on the roof repairs; MOTION carried unanimously.

C. Janitorial Services

Mr. Rainey indicated that several janitorial services have inquired as to when the City is going to call for bids on janitorial services for the City. In reviewing the contract for janitorial services we find that the last time bids were taken for janitorial service was in November, 1981. Staff feels that it would be appropriate to ask for bids at this time.

Councilman Howell made a MOTION, seconded by Councilman Peterson, to authorize staff to call for bids for janitorial services for the City; MOTION carried unanimously.

Mayor Kerr indicated that he felt this matter should be taken up at an Executive Session. Councilman Batty concurred and said he felt that a full Council should be present during the discussion of this matter and indicated that he felt that this matter should be tabled due to the absence of Councilman Nidiffer.

Councilman Peterson made a MOTION, seconded by Councilman Batty, to table this agenda item; MOTION carried unanimously.

C. Ordinance No. 417 - Employee Classification Plan

Mayor Kerr again indicated that he felt this matter should be discussed in Executive Session.

Councilman Peterson made a MOTION, seconded by Councilman Howell, to table this agenda item; MOTION carried unanimously.

Mrs. Van Nest read Resolution No. 408 into the record. Councilman Batty made a MOTION, seconded by Councilman Howell, to adopt Resolution No. 408; MOTION carried unanimously.
