- D. <u>City Manager Announcements</u>
  - 1. Request for Authorization to Proceed -Brown and Caldwell Engineers Facilities Plan

City Manager Roy Rainey explained to the Council that as reported at the August 10, 1987 Council Meeting, extensive work has been completed on the Facilities Plan, but unanticipated, additional work needs to be performed. Mr. Rainey requested authorization to enter into an amended Agreement for Engineering Services with the firm of Brown and Caldwell.

Councilman Batty made a MOTION, seconded by Councilman Nidiffer, to authorize staff to enter into an amended Agreement for Engineering Services with the firm of Brown and Caldwell; MOTION carried unanimously.

#### 2. Cost Estimates for Publication of Agenda

Mr. Rainey advised the Council that the estimate for publication of the agenda received from the Curry Coastal Pilot is \$50.00, but the cost would depend on the length of the agenda.

Mr. and Mrs. Bill Cunningham requested that the Council publish the agenda.

The Council questioned the justification for the cost, due to the fact that there are so few people who have indicated any interest in attending the Council Meetings.

After a brief discussion, Councilman Batty made a MOTION, seconded by Councilman Nidiffer, to publish the agenda for a period of three months to see if there is more public participation and to direct the recorder to count the number of persons in attendance at the Council meetings; MOTION was denied with a yes vote from Councilmen Batty and Nidiffer and a no vote from Mayor Kerr and Councilman Peterson.

#### 3. Request for Acquisition of Tanbark Park Property-Ruby G. Taylor

Mr. Rainey explained that he had received a letter from Mrs. Taylor stating that she owns property adjoining the park property and would be interested in acquiring the park property for the purpose of improving it.

Mayor Kerr pointed out that the park has never been improved due to its size and location. It is next to a very busy street and the Council consensus was that it was too dangerous for children to play in the area.

Councilman Nidiffer made a MOTION, seconded by Councilman Peterson, to authorize staff to pursue the possibility of selling the property to Mrs. Taylor; MOTION carried unanimously.

### 4. Request for Authorization to Pursue Acquisition of Rights-of-Way for a Water Line to Connect Hassett Street to Sunshine Lane

Mr. Rainey advised the Council that the staff feels that it is the time to pursue the possibility of acquiring rights-of-way in the area in question due to the development of the area.

Councilman Peterson made a MOTION, seconded by Councilman Batty, to authorize staff to proceed with a study of the feasibility of acquiring rights-of-way for a water line to connect Hassett Street and Sunshine Lane; MOTION carried unanimously.

#### X. PUBLIC HEARINGS

1. Request for Annexation, Zone Change and Planned Development final approval of a 13.2 acre parcel of property on the North side of East Harris Heights Road within the Residential-Two (R-2) County zoning district (File No's. A-1-87; ZC-2-87; and PD-1-87); A & C Land Company, Applicant

#### NOTE: Councilman Howell arrived at 7:52 p.m.

Planning Director Richard Ullian advised the Council that this matter comes before the City Council to consider final action on a request for annexation, zone change, final plan approval and PD (Planned Development) designation for a 13.2 acre parcel of property generally located on the North side of East Harris Heights Road and the northernmost terminus of Seacrest Lane, contiguous to and northwest of the existing city limits.

hearings officer, City Attorney John Babin, determined that the proposed actions represented quasijudicial decisions and therefore outlined the formal rules of procedure for the conduct of the hearing, pursuant to Resolution No. 213. Following this presentation, the public hearing was opened at 7:54 p.m. and Hearings Officer John Babin requested that Planning Director Richard Ullian present the staff report, and City Engineer Richard Nored discuss the staff recommended conditions that were recommended for deletion by the Planning Commission at the public hearing held at the August 4, 1987 meeting. City staff strongly urged the City Council to re-instate the conditions pertaining to the requirement that the owner/developer provide for adequate water storage within Phase I of the proposed Glenwood PUD, and that the present booster pump station be moved to the existing low level reservoir to guarantee adequate volumes of water to the pump suction. Further, that storm drainage facilities be underground connected with underground facilities within Harris Beach PUD.

Following presentation of City staff, the following persons spoke in favor of the proposed project applications:

- (a) Larry Anderson, 1561 Seacrest Lane, representing A
  & C Land Company, applicant
- (b) Jim Helton, Cunningham Associates, consulting engineer for the applicant

And the following persons offered comments to the Council concerning the project proposal as it relates to and affects an adjoining property:

- (a) Alex Forrester, Design Professional Group, 303 N.E. "E" St., Grants Pass, Oregon 97526, representing property owned by Ed and Marilyn Hewitt (Tax Lot 1200, Assessor's Parcel Map 40-14-36). A letter was submitted into the record concerning recommendations offered relative to storm drainage being piped across Mr. Hewitt's property, objecting to the use of recharge trenches and daylighting of storm drainage waters onto Mr. Hewitt's property from the Glenwood PUD project site.
- (b) Milt Gowman, 96903 Gowman Lane, expressed concerns regarding the proposed storm drainage recharge trenches in the project as it might effect his property and well water source.

Following closure of the public hearing at 9:07 p.m., Councilman Batty made a MOTION, seconded by Councilman Nidiffer, to direct the City staff to prepare the Final ORDER and Findings of Fact Document to include the following additional conditions:

1. The existing water pump station in Harris Beach PUD is proposed to offer direct pressure to the Glenwood PUD with a constant pressure station and storage. The existing station presently runs constantly with its 100gpm pump throughout most days. The addition of 95 new homes proposed will create periods when adequate pressures will not be available for the Glenwood PUD. Therefore, adequate storage must be provided with Phase I of the Glenwood PUD to offer service for the entire high level service area. An alternative design proposal for the Harris Beach PUD booster pump is to be prepared by the owner/developer's engineer, and accepted and approved by the City Engineer.

 Proposed storm drainage facilities which have been approved by ODOT and the City Engineer, shall be underground and connected with underground facilities within Harris Beach PUD, and replace recharge trenches with a conventional surface storm drainage system.

The MOTION carried unanimously.

Mayor Kerr and the Council recessed consideration of the adoption of such Final ORDER, as well as the proposed Ordinance No's. 421, 422 and 423 to a reconvened meeting to be held on Friday, September 25, 1987, at 4:30 p.m. in the Council Chambers of City Hall.

Executive Secretary Donna Van Nest read Ordinance No. 418 into the record. Councilman Batty made a MOTION, seconded by Councilman Peterson, to adopt Ordinance No. 418 by first reading; MOTION carried with Mayor Kerr and Councilmen Batty, Nidiffer, Howell and Peterson voting yes.

Mrs. Van Nest read Ordinance No. 418 into the record by title only. Councilman Batty made a MOTION, seconded by Councilman Peterson, to adopt Ordinance No. 418 by second reading; MOTION carried with Mayor Kerr and Councilmen Batty, Nidiffer, Peterson and Howell voting yes

- 2. Ordinance No. 421, 422 and 423 were rescheduled to 4:30 p.m., September 25, 2987.
- 3. Ordinance No. 424 An ordinance amending the Comprehensive Plan map and zoning map of the City of Brookings by the redesignation and rezoning from residential to commercial and rezoning from residential (county) to residential (city) upon that certain real property below described, and declaring an emergency.

Mrs. Van Nest read Ordinance No. 424 into the record. Councilman Nidiffer made a MOTION, seconded by Councilmen Howell, to adopt Ordinance No. 424 by first reading; MOTION carried with Mayor Kerr and Councilmen Batty, Nidiffer and Howell voting yes. (Councilman Peterson was not on the bench.)

Mrs. Van Nest read Ordinance No. 424 into the record by title only. Councilman Nidiffer made a MOTION, seconded by Councilman Howell, to adopt Ordinance No. 424 by second reading; MOTION carried with Mayor Kerr and Councilmen Batty, Nidiffer and Howell voting yes. (Councilman Peterson was not on the bench.)

Mrs. Van Nest read Resolution No. 412 into the record. Councilman Batty made a MOTION, seconded by Councilman Peterson, to adopt Resolution No. 412; MOTION carried with Mayor Kerr and Councilmen Batty, Nidiffer, Howell and Peterson voting yes.

2. Resolution No. 413 - A resolution of the City Council of the City of Brookings establishing a procedure for the disbursement of funds.

Mrs. Van Nest read Resolution No. 413 into the record. Councilman Nidiffer made a MOTION, seconded by Councilman Howell, to adopt Resolution No. 413; MOTION carried with Mayor Kerr and Councilmen Batty, Nidiffer, Peterson and Howell voting yes.

For September, Councilman Howell presented the organization award to all of the volunteer fire departments in the area, including the Brookings Fire Department, Harbor Fire Department, Winchuck Fire Department, Upper Chetco Fire Department, and Cape Ferrello Fire Department. A special award for services was presented to former Brookings Fire Chief Tom Kerr.

For September, the individual award was presented to Ed Olsen.

For October, the organization award was presented to the Chetco Community Council and the individual award to Ann Ramp.

Councilman Howell then read a letter of resignation to the Mayor and Council stating that he has accepted a position in Bandon with the School District and is leaving the area.

Mayor Kerr and the Council thanked Rick Howell for his work during his time on the Council.

### To: Brookings City Council:

At a special 1:00 P.M. Council meeting held March 26, 1979 to discuss the potential sale of Brookings water to certain industrial users, the assembled group was cautioned that: overproduction of the city well in time of drought could suck the bottom out of the well, exhaust the wells' aquifer and or incur the production of saltwater, leaving the city in a mess.

On December 8, 1980 the following letter was mailed to:

Division of State Lands:

Subject - Waterway Project Permit Review 11/25/80

It is difficult to understand why you have not solicited opinions from the Harbor water District and the City of Brookings as well as from Tom McKenzie and me. They are the ones most likely to be adversely affected by further gravel removal from either the upper McKenzie property or other properties located in close upstream proximity to their intake wells on the Chetco River.

It is my considered opinion that continued gravel removal closer than three quarters of a mile on either side of the Harbor or Brookings wells can only lead to irreparable damage to their aquifers, the unpleasant possibilities of this being: a disastrous decline in the wells' deliverabilities if not in their ultimate abandonment as sources of potable drinking water. Septic contamination cannot be discounted.

Meanwhile, the people of the Brookings-Harbor area have a large financial stake in their Chetco River wells. The capacities of these wells have already been demonstrated. Let's not willingly place them in further jeopardy. Our increasing population will take care of that.

'On or about September 17, 1982 through September 20, 1982, our well produced and our water system carried foul tasting water which users contended was salty. This undoubtedly resulted from a combination of successive high tides and an extremely low Chetco River associated with the 1982 fall drought.

Either surface communication existed or our well's aquifer had been infiltrated. Salt water incursion could be attributed to either or both.

Now in 1987, a bit over five years later, we are encountering what appears to be the same water problem under nearly identical weather conditions.

Are we entering a cycle of five year droughts?

Should we be giving thought to water curtailment?

Meanwhile, the ill-advised modification of city ordinance #322 to permit large volumn water usage outside the city limits has done nothing to mitigate our ever worsening water problem.
