  - 1. Harris Beach P.U.D. Acceptance of Maintenance

City Manager Leo Lightle indicated that the Council had granted acceptance of the off-site improvements at the Harris Beach P.U.D. last year, with several stipulations attached to the acceptance. The stipulations included that the developer would be responsible for all defects in workmanship and materials. Mr. Lightle advised the Council that all of the stipulations had been met by the developer and any problems that had developed during the last year had been promptly corrected by the developer. Mr. Lightle requested that the Council approve the final acceptance of the off-site improvements.

Councilman Geraghty made a MOTION, seconded by Councilman Nidiffer, to approve the final acceptance of the Harris Beach P.U.D. off-site improvements; MOTION carried unanimously.

## D. Manager Announcements

# 21. Liquor License Request - Christmas Tree Restaurant

Mr. Lightle explained that this request is for a transfer of ownership from Omer Bourassa to Lawrence and Anne O'Neill. Mr. Lightle indicated that the police department has reviewed the application and has no objections to the granting of the liquor license.

Councilman Nidiffer made a MOTION, seconded by Councilman Geraghty, to approve the liquor license application for the Christmas Tree Restaurant; MOTION carried unanimously.

# 3. Enterprise Zone Designation Application

Mr. Lightle requested that Planning Director Richard Ullian present this agenda item.

Mr. Ullian advised the Council that the deadline for applying for the 1987 Enterprise Zone Designation is September 8, and that the City has been notified that the application was received by the Economic Development department prior to that deadline date. Mr. Ullian advised the Council that the application would be reviewed by the Economic Development Department within 60 days of the deadline of September 8.

# 4. Angler Access Project

Mr. Lightle advised the council that the grading and paving portion of the angler access project has been completed as designed, and that Lincoln Pearson of the Oregon Dept. of Fish and Wildlife will be arriving on September 11 to do the final inspection. Mr. Lightle indicated that the cost of the grading and paving was significantly lower than the engineer's estimate and staff is suggesting the addition of parking space striping and park benches at the project site, as phase 2 of the angler access project.

Councilman Nidiffer made a MOTION, seconded by Councilman Geraghty, to authorize staff to call for bids on Phase II of the angler access project; MOTION carried unanimously.

# E. Attorney Announcements

# 1. Sludge Truck Purchase

City Attorney John Coutrakon indicated that it is his understanding that the city is in need of purchasing a sludge truck for the wastewater treatment plant, and due to the urgency of this matter and the fact that funds will only allow for the purchase of a used truck, he felt that the purchase could be made by a MOTION of the council authorizing the city manager to purchase a vehicle.

Mr. Lightle explained that the private individual who has been hauling sludge for the city has sold his truck and will no longer be hauling sludge. Mr. Lightle indicated that the city staff has reviewed the options and are suggesting that the city purchase a used truck with a tank capacity of approx. 3500 gallons. Mr. Lightle indicated that this matter has surfaced since the budget process and this item is not in the 1986-87 budget. Mr. Lightle indicated that he has spoken with Gerald Burns, city auditor, and Mr. Burns has indicated that the funds for the purchase of the sludge truck should come from the Contingency Fund in the Wastewater Treatment Budget. The amount of funds available is \$15,000.

Mr. Coutrakon suggested that the Council make a MOTION to authorize the city manager to purchase the sludge truck from funds from the wastewater treatment contingency fund, as authorized by the Oregon Administrative Rules.

Councilman Nidiffer made a MOTION, seconded by Councilman Geraghty, to authorize the city manager to obtain three competitive bids for the purpose of purchasing a used truck for hauling sludge, in an amount not exceeding \$15,000; MOTION carried unanimously.

## VI. SCHEDULED PUBLIC APPEARANCES

# A. Hewitt Annexation - East Harris Hgts. Rd.

Mayor Kerr announced that this agenda item is a public hearing, and he opened the public hearing at 7:25 p.m. and turned the floor to Planning Director Richard Ullian for the staff report.

Mr. Ullian advised the Council that this proposed annexation area is located to the North of the Harris Beach Planned Unit Development, on the East side of U.S. Hwy. 101, Tax Lot 1200.

Mr. Ullian indicated that the proposal had been submitted to the Planning Commission at their July 1, 1986 meeting, and the Planning Commission had recommended that the City Council hold a public hearing on this matter, and also consider the Planning Commission preliminary findings regarding this proposal.

Mr. Ullian stated that it is the opinion of staff that this annexation petition represents a logical and appropriate extension of the corporate limits of the city, that the extension of urban services and facilities can economically and efficiently be provided to serve the area for urban density of development, and that the proposal is in conformance with the city Comprehensive Plan and policies dealing with urbanization and the Urban Growth Boundary.

Mr. Ullian indicated that staff recommends that the City Council adopt by reference the preliminary findings endorsed by the Planning Commission and enact Ordinance No. 405, annexing the subject property and withdrawing the property from the Dawson Rural Fire Protection District.

Mr. Ullian read a letter into the record from Mr. Larry Anderson of Harris Beach Properties, which letter contested the annexation. Mr. Ullian explained that he had just been handed this letter and was unsure of the reason for the contestment. He requested City Attorney John Coutrakon interpret the letter.

Mr. Coutrakon suggested that the city had an agreement with Anderson and Hewitt which resolved this matter. Mr. Hewitt concurred that there was such an agreement. Mayor Kerr questioned the fact that this matter has just surfaced, when it should have been considered during the Planning Commission review process.

Mr. Coutrakon stated that it was his opinion that the burden of proof for the contestment would be on Mr. Anderson, and unless there was a strong reason to believe that the property description presented by Mr. Hewitt was inaccurate, he saw no reason that the Council should not take action on the proposed annexation at this time.

Mayor Kerr asked for proponents of the proposed annexation to speak at this time. There being none, Mayor Kerr asked for opponents to speak. There still being no response, Mayor Kerr closed the public hearing at 7:39 p.m., and requested Council consideration of the proposal.

Vice Mayor Batty made a MOTION, seconded by Councilman Nidiffer, to adopt by reference the premiminary findings endorsed by the Planning Commission; MOTION carried unanimously.
