Mayor Kerr announced that the OCZMA meeting which had been scheduled to be in Brookings on July 11-12, 1985 has been rescheduled for August 8-9, 1985 in Brookings.

Chairman Appel announced that the Planning Commission Study Sessions are beginning again on July 11, 1985 and will continue on the 2nd and 4th Tuesday of each month, until further notice.

D. Manager Announcements

1. Storm Water Study

Mr. Stuart introduced Mr. Dick Nored, H.G.E., who conducted the Storm Water Study, as authorized by City Council.

Mr. Nored made a presentation to the Council, outlining the Storm Water Study. Mr. Nored advised the Council that this is not the final document, but with acceptance of this document the final document will be discussed in Council workshops, if the Council wished.

After a brief discussion, Councilman Geraghty made a MOTION, seconded by Councilman Rogers, to accept the content of the Storm Water Study for further discussion before adoption; MOTION carried unanimously.

D. Manager Announcements

2. Garcia vs. San Antonio

Mr. Stuart indicated that this item has to do with the Fair Labor Standards Act. Mr. Stuart explained the changes that have been made in the personnel policies of the City due to a Supreme Court decision in favor of Garcia and he also explained the new work period and pay period system that has been implemented, with the major change being in payroll, with 26 pay periods per year (every two weeks) versus the twice monthly pay days previously used.

3. 9-1-1

Mr. Stuart advised the Council that the 9-1-1 telephone lines are in place and operating at this time, in the Police dispatch center. The purpose of this Agenda item is to request that the City Council name the following people to the Budget Committee:

Cape Ferrelo Fire Dept. - Naomi Bradfield Southern Curry Ambulance Ass'n. - Fern Ponsford Winchuck Volunteer Fire Dept. - Bill Crooks Harbor Rural Fire Protection District - Frank Kelley Upper Chetco Volunteer Fire Dept. - Charles Sanders

Mr. Stuart also indicated that staff is requesting that the City Council set a public hearing date for the purpose of considering expenditures from the 9-1-1 Fund. Mr. Stuart suggested August 5, 1985 as a possible date for the public hearing.

Councilman Niddifer made a MOTION, seconded by Councilman Geraghty, to appoint the listed persons to the 9-1-1 Budget Committee; MOTION carried unanimously.

Councilman Rogers made a MOTION, seconded by Councilman Nidiffer to set August 5, 1985, at 7:00 p.m. in the Council Chambers of City Hall for a public hearing before the Budget Committee; MOTION carried unanimously.

D. Manager Announcements

4. Insurance Agent of Record

Mr. Stuart advised the Council that in accordance with Oregon Administrative Rules Chapter 125, Division 310, Paragraph 140, Subsection (a), the City staff is requesting City Council authority to pursue the renewal of the City's Agent of Record. Mr. Stuart indicated that the firm of Gerald Ross Insurance has been utilized as the Agent of Record for many years in the past, but under the new Oregon Administrative Rule this requirement does provide for renewal with a maximum of a three-year agreement. Mr. Stuart noted that, with the authority from the City Council, all potential agents would be requested to submit proposals to the City Council for final review.

Councilman Geraghty made a MOTION, seconded by Councilman Nidiffer, to authorize City staff to pursue an official Agent of Record; MOTION carried unanimously.

5. Chamber of Commerce Report

George King, Manager of the Brookings-Harbor Chamber of Commerce, reported that the Chamber information center had registered 1,162 visitors, and mailed out 939 answers to written inquiries. 6 new members joined the Chamber of Commerce.

6. <u>Liquor License Renewal - Thomas J. Whiteley</u>

Mr. Stuart indicated that this is a standard yearly renewal procedure, and the Police Department has no objections to the renewal.

Councilman Nidiffer made a MOTION, seconded by Councilman Rogers to approve the liquor license renewal for Thomas J. Whiteley, Inc. dba Brookings Shell; MOTION carried unanimously.

X. ORDINANCES

A. Ordinance No. 393 - Consent Annexation

Mr. Stuart indicated that the Planning Commission, at their regular meeting of July 2, 1985, had recommended to the City Council that a public hearing be set to consider annexation of a portion of a piece of property owned by George and Corinne Langley. The property is located at 1055 Marina Height Loop and the majority of the property is already inside the City limits. There is just one small portion that was left out of the City limits when the subdivision was created. Mr. Stuart suggested that if the Council agreed to set a public hearing date, the public hearing could be set for the August 13, 1985 Council meeting.

Mr. Stuart indicated that an election on the issue may be waived by the City Council, after adoption of an Ordinance, which has been drafted for Council consideration.

Mrs. Van Nest read Ordinance No. 393 into the record. Mr. Stuart pointed out that the Ordinance states that the public hearing be set for August 12, which is the regular Council Meeting date, but the August meeting has been rescheduled for August 13. Councilman Rogers made a MOTION, seconded by Councilman Geraghty, to correct Ordinance No. 393 by changing the date of public hearing from August 12 to August 13; MOTION carried unanimously.

Councilman Nidiffer made a MOTION, seconded by Councilman Rogers, to adopt Ordinance No. 393 by first reading; MOTION carried unanimously.

Mrs. Van Nest read Ordinance No. 393 into the record by title only. Councilman Rogers made a MOTION, seconded by Councilman Nidiffer, to adopt Ordinance No. 393 by second reading; MOTION carried unanimously.
