# V. MINUTES FOR APPROVAL/ACCEPTANCE

- A. Approval of Council Meeting Minutes
  - 1. May 8, 1984 Regular Council Meeting Minutes

There was a MOTION by Councilman Lovejoy, seconded by Vice Mayor Batty, to approve the minutes of the May 8, 1984 Regular Council Meeting Minutes; MOTION carried unanimously.

- B. Acceptance of Planning Commission Minutes
  - March 6, 1984 Regular Planning Commission Meeting Minutes
     May 9, 1984 Special Planning Commission Meeting Minutes

There was a MOTION by Vice Mayor Batty, seconded by Councilman Lovejoy, to accept the minutes of the March 6, 1984 Regular Planning Commission Meeting and the May 9, 1984 Special Planning Commission Meeting; MOTION carried unanimously.

# VI. SCHEDULED PUBLIC APPEARANCES

Mrs. Crystal Cole made a brief presentation to the Council concerning the Azalea Community Center, Inc., and their efforts to bring a community conference center to Brookings. Mrs. Cole introduced Burney Moore, who outlined for the Council the proposed plans for the center, and Mr. Jim Cole, who outlined for the Council the proposed land uses at Azalea State Park, the site of the proposed community center and golf course. Mrs. Cole requested the support of the City Council in this endeavor.

Councilman Geraghty made a MOTION, seconded by Vice Mayor Batty, to express the Council's support to the Azalea Community Center, Inc.; MOTION carried unanimously.

# VII. COMMUNICATIONS/ANNOUNCEMENTS

# A. Mayor Announcements

Mayor Kerr announced that he had attended the OCZMA meeting in Eugene this last week and briefed the Council and the audience on the contents of the meeting.

Mayor Kerr expressed his appreciation to the citizens of Brookings for the successful tax levy base election held on May 15, 1984.

# B. Council Announcements

Vice Mayor Batty also expressed his appreciation for the support shown to the City by the voters.

# C. Manager Announcements

# 1. Liquor License Renewal Applications

Mr. Stuart presented liquor license renewal requests from the Cliff House Restaurant, the Christmas Tree Restaurant, 2 from the Touch of the Past Restaurant, Pickle Barrel Deli and the Coast House Restaurant. Mr. Stuart explained that the police department has researched each of these requests and has found no objections to the granting of these luquor licenses and would recommend that these licenses be renewed.

A MOTION was made by Councilman Lovejoy, seconded by Councilman Geraghty, to grant the renewal of the liquor licenses; MOTION carried unanimously.

# VII. C. Manager Announcements

2. Liquor License Application - Thomas J. Whiteley, Inc.

Mr. Stuart explained that this application was reviewed by the Council at the May 8 meeting, and at that time the staff was directed to go back and review three issues.

- 1. The issue of parking Mr. Stuart presented a memo from Chuck Rhodaback, Planning Director, indicating that there would be no violation of any parking restrictions of the City of Brookings, but rather a concern due to the fact that there is a senior center facility directly behind the proposed "Mini-Mart", which could possibly cause some traffic congestion.
- 2. The issue of who was going to be running the operation a copy of the resume of the manager was enclosed in the packets.
- 3. The issue of a possible deed restriction Mr. Stuart explained that there is an apparent deed restriction on the property, which restricts the sale of alcoholic beverages on the property.

Mr. Coutrakon expressed concern due to the deed restriction, and concern that if the City granted this license that the City could be liable if this deed restriction was not removed prior to granting of the license.

Mr. Ernest Francis, Jr., manager of the Brookings Shell Station, spoke in favor of the proposed "Mini-Mart", and explained that the owner of the property, Mr. Thomas E. Whiteley, is at the present time attempting to have the deed restriction removed from the deed document in question.

Vice Mayor Batty, at this time abstained from any further participation in this matter due to a conflict of interest.

Mr. Mel Pyne, owner of the Local Market, spoke in opposition of the proposed liquor license. Mr. Pyne indicated that he felt that there were enough places in Brookings at this time selling alcoholic beverages.

Mayor Kerr stated that he felt that the matter of the deed restriction must be resolved before the City Council can take action on this liquor license.

Councilman Geraghty voiced his concern about the deed restrictions, and expressed concern about parking problems but primarily the many alcoholic beverage outlets already operating in the City.

A MOTION was made by Councilman Geraghty, seconded by Councilman Lovejoy to deny the liquor license application; MOTION passed with Vice Mayor Batty abstaining.

10. Liquor License Review Process

Mr. Stuart offered to move item No. 10 up to this time due to the fact that it has to do with liquor license review processes. Mr. Stuart pointed out that more and more the burden of reviewing and granting liquor licenses is becoming the responsibility of the municipalities rather than the State of Oregon. Mr. Stuart requested that the City Council direct the staff to prepare review process documents and then review them with an ad hoc committee. Mr. Stuart also requested that the Council name an ad hoc committee to review the documents.

A MOTION was made by Councilman Lovejoy, seconded by Councilman Geraghty to direct staff to prepare the criteria and the Mayor to name the ad hoc committee to do the review.

3. 1985 Special City Allotment Program

Mr. Stuart explained that this program is set up through the State of Oregon to be used for streets. This year the City has made application for this special allotment to be used to connect Highway 101 and Fifth Street directly. Mr. Stuart requested that The City Council authorize staff to submit the application for the Special City Allotment Program.

A MOTION was made by Councilman Lovejoy, seconded by Vice Mayor Batty, to resubmit the application for the 1985 Special City Allotment Program; MOTION carried unanimously.

4. Municipal Audit Contract

Mr. Stuart presented the Municipal Audit Contract proposal from Gerald Burns. There was a brief discussion concerning the low cost of present auditing services versus auditing services back in 1980.

Vice Mayor Batty made a MOTION, seconded by Councilman Lovejoy, to authorize the Mayor to execute the audit agreement; MOTION carried unanimously.

## State Parks Permit Requirements

Mr. Stuart explained the basic changes in the State Parks Permit Requirements to the Council, and advised that there was no action requested on this item.

# 6. Cable Franchise Fee Adjustment

Mr. Stuart presented a request from Skyline Cable for a rate increase adjustment. The following is the proposed rate changes:

Mr. Roy Garvin, representing Skyline Cable, Inc., briefly apprised the Council as to the reasons for the request for rate changes.

A MOTION was made by Councilman Lovejoy, seconded by Councilman Geraghty, to grant the rate changes to Skyline Cable, Inc., to be effective August 1, 1984; MOTION carried unanimously.

# 7. Bicycle Path Acceptance - Railroad Avenue

Mr. Stuart presented a map showing the completed bicycle path on Railroad Avenue from Wharf Street to Oak Street. Mr. Stuart indicated that the project has been constructed to the standards and within the confines of the agreement, and stated that the total cost that the City can receive refund on is \$13,314.65, of which 50% is reimbursible from the State Parks and Recreation Department from an approved grant.

Mayor Kerr explained that the other monies involved are monies which the City receives from gasoline taxes and the City is required to spend a percentage of this money on bicycle paths.

Councilman Lovejoy made a MOTION, seconded by Vice Mayor Batty, to accept the bicycle path on Railroad Avenue; MOTION carried unanimously.

# 8. Worker Compensation Insurance

Mr. Stuart indicated that the City Recorder had sent out 3 requests for insurance coverage for fiscal year 1984-85, and had received 2 proposals, are from the SAIF Corporation of Oregon and from Liberty Northwest. City staff recommended that the City accept the proposal from Liberty Northwest. The total premium from SAIF was \$21,932.10, and from Liberty Northwest was \$19,466.00.

Vice Mayor Batty made a MOTION, seconded by Councilman Batty, to accept the proposal for 1984-85 Worker Compensation Insurance coverage from Liberty Northwest; MOTION carried unanimously.

# 9. Oregon Downtown Development Association

Mr. Stuart presented a brief overview of a seminar which he attended in Eugene, Oregon, which was sponsored by the Oregon Downtown Development Association. He spoke of two programs which were presented at the seminar, one of which is "Main Street '84" and the other is "Small Towns '84". Mr. Stuart indicated that there is no action requested; that this is only for informational purposes.

#### D. ATTORNEY ANNOUNCEMENTS

Mr. Coutrakon explained that the City Manager Ordinance which is being presented tonight is necessary only to correct a situation which was created in 1980 by creating the positions of City Administrator and City Finance Officer.

Mr. Stuart also explained that this ordinance, if adopted by the City Council, will make the City eligible for membership in the International City Management Association.

Mr. Coutrakon then outlined the Taxicab ordinance which is being presented tonight.

Ordinance No. 387 was read into the record by Donna Van Nest. The words "in the City Jail" were deleted from Section 12, lines 6 and 7. Councilman Lovejoy made a MOTION, seconded by Vice Mayor Batty, to adopt Ordinance No. 387 by first reading; MOTION carried unanimously.

Ordinance No. 387 was then read into the record by Donna Van Nest by title only. Councilman Lovejoy made a MOTION, seconded by Councilman Geraghty, to adopt Ordinance No. 387 by second reading; MOTION carried unanimously.
