V. MINUTES FOR APPROVAL/ACCEPTANCE

- A. Approval of Council Meeting Minutes
 - 1. June 12, 1984 Regular Council Meeting Minutes

There was a MOTION by Vice Mayor Batty, seconded by Councilman Geraghty, to approve the minutes of the June 12, 1984 Regular Council Meeting Minutes; MOTION carried unanimously.

B. Acceptance of Planning Commission Meeting Minutes

1. June 5, 1984 Regular Planning Commission Meeting Minutes

There was a MOTION by Vice Mayor Batty, seconded by Councilman Geraghty, to accept the minutes of the June 5, 1984 Regular Planning Commission meeting minutes; MOTION carried unanimously.

VI. SCHEDULED PUBLIC APPEARANCES

1. CU-2-84 APPEAL (LARRY ANDERSON)

Mayor Kerr turned the floor to Mr. Stuart to bring the Council up to date on this matter. Mr. Stuart indicated that Chuck Rhodaback, Planning Director, would make the presentation.

Mr. Rhodaback gave a staff report explaining the Planning Commission findings and final Planning Commission decision, which was a denial of the request for a portable rock crusher at the construction site on East Harris Heights Road.

Mr. Rhodaback explained that Mr. Anderson chose to appeal the decision of the Planning Commission to the City Council.

Mr. Rhodaback then read a piece of testimony from Mr. and Mrs. Leon Burgess, 96753 E. Harris Heights Road, Brookings. Mrs. Burgess explained that they were unable to attend the Council Meeting due to Mr. Burgess being scheduled for surgery on this date. Mrs. Burgess explained that they would be the closest neighbors affected and Mr. Burgess sleeps mornings, but that they do not object to the rock crusher.

Mr. Rhodaback then read a letter from Mr. and Mrs. Charles Bell, 4934 Ardlsey Drive, Temple City, California. The letter stated that they did not object to the rock crusher so long as it did not disturb the natural environment in any commercial way.

Mr. Larry Anderson, P.O. Box 1746, Brookings, Oregon, owner of the construction site on East Harris Heights Road, presented testimony pertaining to the D.E.Q. permits required for the use of the portable rock crusher and indicated that this use is compatible with D.E.Q. requirements. He also indicated that there are no objections from the Oregon Division of Parks or the Oregon State Highway Division.

Mr. Howard Cronk, general contractor for the construction project, requested that the City Council approve the permit for the rock crusher.

The sub-contractor (owner of the rock crusher) indicated that the rock crusher meets all standards and requirements for this project.

Mr. Ed Hewitt, adjoining property owner, indicated that he had no objections to the portable rock crusher.

Mayor Kerr then asked for statements in opposition to the portable rock crusher.

Mr. Mike Curry stated that while he did oppose the use of the portable rock crusher at the time of the Planning Commission decision, he now objects only to the six-month permit period, and feels that the time period should be shorter.

Mrs. Lorna Curry, Stafford Road, indicated that she also opposes the six-month permit period. She stated that she would not object to the rock crusher for a period of 30 days at most.

After a brief discussion, Vice Mayor Batty made a MOTION, seconded by Councilman Geraghty, to approve the permit for the portable rock crusher for a period of 90 days from the date of permit issuance from D.E.Q.; MOTION carried unanimously.

Mr. Coutrakon requested that Mr. Anderson state, for the record, that he would also abide by the other conditions recommended by the Planning Commission. Hours of operation for the portable rock crusher will be limited to 9:00 a.m. to 4:00 p.m., Monday through Friday, and the gravel resources from the site will be used solely for the construction project and will not be sold commercially. Mr. Anderson stated that he would abide by these terms.

VII. COMMUNICATIONS/ANNOUNCEMENTS

A. Mayor Announcements

Mayor Kerr announced that he had brought a newspaper article to Mr. Stuart concerning the timber harvest in Lane County which is affecting the sawmill industry in that area.

B. Council Announcements

C. Manager Announcements

1. General Telephone Grant to Library

Mr. Stuart announced that Mr. Jack Ross, a long-time employee of General Telephone Company, has received a grant from General Telephone Company in the amount of \$100 to be used by the library for the purpose of purchasing books on electronics and computers. Mr. Stuart stated that he wished to publicly thank Mr. Ross for his efforts in this matter.

2. Fire Truck Delivery Notice

Mr. Stuart informed the Council that the new fire truck will be delivered on Monday, July 16, 1984, and invited the Council to come to the Fire Department to see the new truck when it is delivered.

3. Comprehensive Plan Acknowledgement Update

Mr. Stuart asked Mr. Rhodaback to present the proposed shedule for the Comprehensive Plan Acknowledgement. Mr. Rhodaback indicated that the Curry County Commissioners had held their second public hearing on this matter on Monday, July 9, 1984. The proposed date for the Plan Acknowledgement is set for approximately September 13 and 14, 1984.

4. Liquor License Application - Dean's Alliance

Mr. Stuart stated that the applicants had requested, at approximately 4:00 p.m., this date, that their application be deleted from the Agenda.

5. 9-1-1 Update

Mr. Stuart indicated that he had attended a Curry County Commission meeting and at that time the Curry County Commissioners had signed the 9-1-1 Plan and the Plan has been sent to the Salem headquarters. Mr. Stuart stated that he had received a telephone call this afternoon from Mr. David Yandell, Emergency Services Coordinator, saying that the Plan has been approved by the State and the written approval will be received shortly, at which time the official notification will be sent to General Telephone Company to begin the retrofit in the switching station which will bring us up to standard for the 9-1-1 system.

6. Employee Group Insurance

Mr. Stuart presented the three proposals received for the 1984-85 fiscal year group employee insurance, from Abel & Swank, Gerald Ross Insurance and the League of Oregon Cities. The staff recommended that the Council approve the proposal from the League of Oregon Cities, which is the group insurance now being utilized for all City employees. Mr. Stuart indicated that the increase in the insurance costs would be approximately 9 per cent.

There was a MOTION by Councilman Nidiffer, seconded by Councilman Geraghty, to accept the League of Oregon Cities proposal and authorize the City Manager to enter into the League of Oregon Cities Plan III insurance coverage; MOTION carried unanimously.

7. Taxi Rate Schedule Review

Mr. Stuart explained that this review is in accordance with Ordinance No. 387, Section 10. Mr. Stuart explained, that according to the Ordinance, a meter must be installed inside the cab of the taxi and be visible to the rider. The Chetco Taxi and Delivery has instead established a set rate for different areas of the City and outlying areas.

Mr. Lee Schley, manager of Chetco Taxi and Delivery, requested that the City Council approve the rate schedule.

After a brief discussion, a MOTION was made by Councilman Nidiffer, seconded by Councilman Geraghty, to approve the rate schedule as presented; MOTION carried unanimously.

Mr. Stuart asked that the record show that this is not the issuance of the license, but is only the approval of the rate schedule.

IX. REPORT ON BIDS

1. Surplus Fire Equipment

Mr. Stuart explained that some months ago the Council had authorized the staff to call for bids on a 1952 International truck. The minimum bid advertised was \$3,000. Mr. Stuart indicated that the only bid received was for \$2,500 from the Sixes Volunteer Fire Department.

The officers of the Brookings Fire Department reveiwed the bid, and authorized the City Manager to request the approval of the sale from the City Council. Proceeds from the sale would be used to improve existing fire equipment.

There was a MOTION by Councilman Nidiffer, seconded by Vice Mayor Batty, to accept the bid of \$2,500 from the Sixes Fire Department; MOTION carried unanimously.

1. Land Use Decision Criteria

Mr. Stuart informed the Council that the purpose of this Resolution is to provide Staff, Planning Commission and City Council with criteria for all decision making in the land use area. Mr. Stuart noted that this information has be presented to the Planning Commission and it is the recommendation of the Planning Commission that the City Council adopt Resolution No. 356.

Mrs. Van Nest read Resolution No. 356 into the record. There was a MOTION by Councilman Geraghty, seconded by Councilman Nidiffer, to adopt Resolution No. 356; MOTION carried unanimously.

XII. UNSCHEDULED PUBLIC APPEARANCES

XIII. PAYMENT OF VOUCHERS

There was a MOTION by Vice Mayor Batty, seconded by Councilman-Nidiffer, to pay the vouchers in the amount of \$78,434.87; MOTION carried unanimously.
