- V. MINUTES FOR APPROVAL/ACCEPTANCE
 - A. Approval of Council Meeting Minutes
 - 1. July 10, 1984 Regular Council Meeting Minutes

Councilman Lovejoy made a MOTION, seconded by Councilman Geraghty, to approve the minutes of the July 10, 1984 Regular Council Meeting; MOTION carried unanimously.

- B. Acceptance of Planning Commission Meeting Minutes
 - 1. July 3, 1984 Regular Planning Commission Meeting Minutes

Councilman Geraghty made a MOTION, seconded by Councilman Lovejoy, to accept the minutes of the July 3, 1984 Regular Planning Commission Meeting; MOTION carried unanimously.

VI. SCHEDULED PUBLIC APPEARANCES

A. Comprehensive Plan - Goal 16

Mayor Kerr announced that this is a joint public hearing between the City Council and the Planning Commission.

Mr. Rhodaback gave a brief presentation on the background information of Goal 16.

Mr. Fred Hummel, 202 Alder St., asked for clarification on a point concerning Ferry Creek. Mayor Kerr responded that he was not referring to Ferry Creek itself but to a point in the river near Ferry Creek.

Mayor Kerr requested any further public testimony. There being none, he asked that the Planning Commission MOVE to either accept or reject Gaols 16, 17 and 18 of the Brookings Comprehensive Plan.

Commissioner Hagen made a MOTION, seconded by Vice Chairman Breuer, to accept Goals 16, 17 and 18 of the Brookings Comprehensive Plan; MOTION carried unanimously.

Mayor Kerr asked that the Council MOVE to either accept or reject Goals 16, 17 and 18 of the Brookings Comprehensive Plan.

Councilman Nidiffer made a MOTION, seconded by Councilman Geraghty, to accept Goals 16, 17 and 18 of the Brookings Comprehensive Plan; MOTION carried unanimously.

City Manager Lynn Stuart asked if, for the sake of continuity, the City Council would like to consider Ordinance No. 388 at this point.

X. ORDINANCES

A. Ordinance No. 388 - Coastal Goals

Mrs. Van Nest read Ordinance No. 388 into the record. A MOTION was made by Vice Mayor Batty, seconded by Councilman Lovejoy, to adopt Ordinance No. 388 by first reading; MOTION carried unanimously.

Mrs. Van Nest read Ordinance No. 388 into the record by title only. Vice Mayor Batty made a MOTION, seconded by Councilman Nidiffer, to adopt Ordinance No. 388 by second reading; MOTION carried unanimously.

VI. SCHEDULED PUBLIC APPEARANCES

B. League of Women Voters

Ms. Joyce Reynolds, representing the League of Women Voters, asked that the City Council reaffirm their position regarding the request by the League of Women Voters to the Curry County Clerk for a deputy voting registrar in the Brookings area.

Mayor Kerr expressed his feelings that a deputy voting registrar is very much needed in Brookings.

Vice Mayor Batty made a MOTION, seconded by Councilman Geraghty, to give the League of Women Voters a vote of confidence; MOTION carried unanimously.

VII. COMMUNICATIONS/ANNOUNCEMENTS

A. <u>Mayor Announcements</u>

Mayor Kerr read a letter of resignation from Planning Commission member Richard Swigert, who has left the Brookings area.

Mayor Kerr announced that the Planning Commission had approved the appointment of Mel Pyne to the Planning Commission to fill the vacancy. Mayor Kerr asked that the City Council approve this appointment.

There was a MOTION by Councilman Nidiffer, seconded by Vice Mayor Batty, to accept the resignation of Richard Swigert from the Planning Commission and approve the appointment of Mel Pyne to the Planning Commission; MOTION carried unanimously.

Mayor Kerr expressed disappointment with the defeat of the school district levy, and expressed a vote of confidence for the new school superintendent.

C. Manager Announcements

1. Anderson Appeal Findings

Mr. Rhodaback indicated that at the Regular Council Meeting of July 10, 1984, the City Council had approved a conditional use permit for Larry Anderson to operate a portable rock crusher. The "Findings of Fact Document" is for Council review and adoption, which will complete the decision making process.

VII. COMMUNICATIONS/ANNOUNCEMENTS

C. Manager Announcements

1. Anderson Appeal Findings

There was a MOTION by Councilman Lovejoy, seconded by Councilman Geraghty, to adopt the "Findings of Fact" document on the Larry Anderson Conditional Use Permit; MOTION carried unanimously.

2. Signs - Spruce Street

Mr. Lightle explained the request for "Slow, Children Playing" signs on Spruce Drive. He explained that the street is very narrow and there are parked cars along the curb and there are small children playing near the street.

After a brief discussion, Vice Mayor Batty suggested speed bumps as a possible alternative to the signs, and the possibility of a 15 m.p.h. speed zone in the area.

There was a MOTION by Councilman Geraghty, seconded by Councilman Nidiffer, to place 15 m.p.h. speed signs, along with "Slow, Children Playing" signs on Spruce Drive; MOTION carried unanimously.

3. Moon - Water Request

Mr. Lightle indicated that this is an outside the City limits water hookup request and that according to Ordinance No. 322, there can be no approval of this request unless there is a hardship involved. Mr. Lightle explained that both Mr. and Mrs. Moon suffer from health problems and that the hookup to City water would appear to be their only alternative, since their spring dried up in July.

After a discussion by the Council, there was a MOTION by Vice Mayor Batty, seconded by Councilman Lovejoy, to approve the request for an outside City limits water hookup for the Moon property contingent upon presentation of a recorded easement to place the meter and contingent upon any other staff recommendations which seem appropriate; MOTION carried unanimously.

VII. COMMUNICATIONS/ANNOUNCEMENTS

C. Manager Announcements

4. Liquor License Application - Siskiyou Vineyards/Studio-S

Mr. Stuart stated that he has abstained from participating in the processing of this application and will continue to abstain due to a possible conflict of interest on this item.

Mrs. Louise Stuart, Studio-S, indicated that this is not a new request for a liquor license but is actually a request for a second location license for an already existing winery license. The current license is issued to Siskiyou Vineyards of Cave Junction, Oregon, and they are proposing a second location license for the purpose of a wine-tasting room at Studio-S. Mrs. Stuart presented plans for the expansion of Studio-S, which will include a gallery and space for the proposed wine-tasting.

There was a MOTION by Councilman Geraghty to table this application until the proposed criteria for the issuance of liquor licenses is established.

Councilman Nidiffer stated that he had talked with the Oregon Liquor Control Commission regarding the moratorium on liquor licenses approved by the Council. Mr. Nidiffer indicated that the OLCC opinion was that this was not a new liquor license, but was an extension of an existing license and would not fall under the criteria that is being established for the issuance of package liquor licenses, in Brookings.

The MOTION by Councilman Geraghty died for lack of a second.

Vice Mayor Batty declared that he would abstain from voting due to a possible conflict of interest on this application and also on the next issue of altransfer of a license.

There was a MOTION by Councilman Nidiffer, seconded by Councilman Lovejoy, to approve the liquor license application, second location, for Siskiyou Vineyards/Studio-S. The MOTION carried 3-0 with Vice Mayor Batty abstaining.

VII. COMMUNICATIONS/ANNOUNCEMENTS

C. Manager Announcements

5. Liquor License Application (Transfer) - Taco Ole'

Mr. Stuart explained that this is a transfer of ownership application. The Taco Ole' is changing ownership from Mr. and Mrs. John Wheeler to Mr. and Mrs. Bob Rogers and the liquor license is already existing.

There was a MOTION by Councilman Lovejoy, seconded by Councilman Geraghty, to approve the transfer of the liquor license from Mr. and Mrs. John Wheeler to Mr. and Mrs. Bob Rogers; MOTION carried 3-0 with Vice Mayor Batty abstaining.

VIII. CALL FOR BIDS

A. Surplus Equipment Sale

Mr. Stuart requested that the City Council authorize the City staff to call for bids on the following surplus equipment now in storage at the City shops.

Mr. Stuart indicated that sealed bids will be accepted and opened on September 7, 1984 at 10:00 a.m. in the Council Chambers, and subsequently the bids will be reviewed at the Council Meeting on September 11, 1984.

Mayor Kerr requested that City staff research the costs of the saddle tanks for a possible different minimum bid on that item.

There was a MOTION by Councilman Lovejoy, seconded by Councilman Geraghty, to authorize City staff to call for bids on the surplus equipment; MOTION carried unanimously.

VIII. CALL FOR BIDS

B. Copy Machine - Request for Proposals

Mr. Stuart indicated that the lease agreement on the Toshiba copy machine runs out in October, 1984, and requested that City Council authorize City staff to call for proposals on a similar lease agreement for a new copy machine, not specifying any particular brand name, but based on the specifications provided in the Council packet. Mr. Stuart indicated that this would be for sealed bids with the opening of bids to be on Friday, Setpember 7, 1984, at 10:00 a.m. in the Council Chambers and the review by the Council on September 11, 1984.

Mayor Kerr requested that Mr. Stuart find out the amount of the balloon payment to purchase the Toshiba now in City Hall, for the possibility of recouping some of the City expenses incurred during the lease agreement.

There was a MOTION by Councilman Nidiffer, seconded by Councilman Lovejoy, to authorize City staff to call for bids on a copy machine; MOTION carried unanimously.

C. Electronic Typewriter

Mr. Stuart advised the Council that this request is to replace a typewriter in the police department which was transferred recently to the Administrative offices. Mr. Stuart explained that the City staff is attempting to replace some of the older Adler machines with new electronic machines. Mr. Stuart indicated that the bid opening would be September 7, 1984 at 10:00 a.m. in the Council Chambers with review by the City Council on September 11, 1984.

There was a MOTION by Councilman Lovejoy, seconded by Vice Mayor Batty, to call for bids on an electronic typewriter; MOTION carried unanimously.
