# MINUTES SPECIAL COUNCIL MEETING CITY OF BROOKINGS April 19, 1982

## I. CALL TO ORDER

Acting Chairman Councilman Nidiffer called the meeting to order at 7:35 p.m.

#### III. ROLL CALL

Council members present: Councilmen Ray Nidiffer, John Geraghty and Walt Lovejoy.

Council members absent: Mayor Bob Kerr; Councilman Gil Batty

Staff present: City Manager Lynn R. Stuart, Recorder/Treasurer Naomi Bradfield, Administrative Assistant Georgia Shirilla and Police Chief Bob Babb.

#### IV. BUDGET HEARING

Mr. Stuart reviewed the steps in the budget process, which was followed by Councilman Nidiffer announcing a public hearing to review the Federal Revenue Sharing revenues as follows:

Mr. Stuart then reviewed the Federal Revenue Sharing expenditures as follows:

Councilman Nidiffer then asked for any input from the Council or audience regarding the Federal Revenue Sharing program. There were no comments and Councilman Nidiffer declared the hearing closed.

MOTION by Councilman Lovejoy, seconded by Councilman Geraghty to approve the Federal Revenue Sharing hearing. Motion carried unanimously.

Councilman Nidiffer announced a State Revenue Sharing hearing.

Mr. Stuart then outlined the State Revenue Sharing revenues as follows:

State Revenue Sharing \$ 16,400.00

Councilman Nidiffer then asked for any input from the Council or addience regarding the State Revenue Sharing program. Mr. Don Hurd felt that the State Revenue Sharing was only local tax money and should be called by that name. The City Manager explained that State statutes require the cities to hold these hearings and that taxes were paid by everyone and placed in the Federal and State programs and then sent back to the communities.

There were no further comments and Councilman Nidiffer declared the hearing closed.

MOTION by Councilman Lovejoy, seconded by Councilman Geraghty to approve the State Revenue Sharing hearing. Motion carried unanimously.

# Page 2 - Special Council Meeting Minutes April 19, 1982

Mr. Stuart indicated that the fiscal year 1981-82 Budget was \$1,875,741 and for fiscal year 1982-83 the sum of \$1,855,538 or an over-all decrease of 1.08%. The City of Brookings was proposing a tax base of \$505,392 which was to be voted on by the taxpayers.

Councilman Nidiffer requested further input from the Council or audience and Mr. Don Hurd felt that it was not necessary to request this large amount of money and requesting a new tax base, as there was a poor economic situation at the present time. Councilman Nidiffer assured Mr. Hurd that the City had been very conservative in preparing the Budget, and Councilman Geraghty stated that the Budget had been heavily scrutinized by the Budget Committee. After further discussion by Mr. Hurd concerning City fire equipment, Councilman Nidiffer requested any further input and there was none.

MOTION by Councilman Geraghty, seconded by Councilman Lovejoy to present the proposed Budget to the voters of the City of Brookings. Motion carried unanimously.

At the request of Councilman Nidiffer, Mr. Stuart gave a short review of the present status of the Comprehensive Plan, and noted those Goals which needed to be addressed further. He stated that the City of Brookings could not receive compliance until Curry County had submitted their Plan.

### V. ADJOURNMENT

MOTION by Councilman Lovejoy, seconded by Councilman Geraghty to adjourn the meeting. Motion carried unanimously.

The meeting was adjourned at 8:26 p.m.
