MOTION by Councilman Cheney, seconded by Councilman Brimm that Resolution No. 260 be adopted. Motion carried unanimously.


Mayor Hitchcock, with the concurrence of the Council, appointed Councilman Brimm as Mayor Pro-tem.

MOTION by Councilman Cheney, seconded by Councilman Brimm that the meeting be adjourned. Motion carried unanimously.


The meeting was adjourned at 1:16 p.m.
