MINUTES

BROOKINGS COMMON COUNCIL CITY OF BROOKINGS November 20, 1979

The meeting was called to order at 8:00 p.m. by Mayor Elmer Hitchcock.

I. PLEDGE OF ALLEGIANCE

II. ROLL CALL

Members present were: Councilmen Darrel Allsup, Ralph C. Cheney, Jack Lowrie and Ray Lockman.

Staff present were: City Manager, Frank Freeman and Recorder, Marge McKernan. Also present was Assistant City Attorney George Hoselton.

III. APPROVAL OF MINUTES

MOTION by Councilman Cheney, seconded by Councilman Lowrie that the October 9, 11; November 1 and 6th, 1979 minutes be approved.

IV. COMMUNICATIONS

- 1. Mr. Freeman read resignation from Ellis Watkins of the Parks and Recreation Commission.
- 2. Recorder read letter from C. A. Mike Page concerning the Brookings Cemetery. Staff was instructed to send a letter to the County.

V. LEGISLATIVE ACTION

1. Presentation by Mr. Roy Fietz, Yergen & Meyer Certified Municipal Accountants on City's 1978-79 Audit. Mr. Fietz read a letter written by him to the Council dated October 4, 1979. He stated that there was insufficient internal control in various areas. That the negative opinion they had issued in the audit report would not cause the City any problem as far as the Division of Audits was concerned. If corrective measures were not taken and these conditions corrected in the next year they would then be criticized by the Division of Audits and it could result in withholding of some State funds for the City. It was necessary for the City to take action in these matters. Councilman Cheney suggested setting up a study session to straighten out these policies as soon as possible. November 26, 1979 at

9:00 a.m. was set for a study session. Mr. Freeman stated that with the auditor's assistance we should prepare a supplemental budget for the Council's consideration. It was noted that the City's fund balances were quite satisfactory and no deficits except the water construction fund.

- Request from Persons Endeavoring to Acquire the Chetco Hotel for Seniors (PEACHES) for City to apply for a \$460,000 H.U.D. Community Development Grant. Resolution for City Council approval. There was discussion about who would operate it and pay the bills. After 18 to 24 months it would be turned over to a non-profit organization. Another additional grant could be obtained from the Oregon State Housing Authority to make additional renovations. The organization would pay its own expenses. MOTION was made by Councilman Cheney to authorize the City Manager to apply for a grant. After discussion Councilman Cheney withdrew his motion. MOTION by Councilman Cheney, seconded by Councilman Allsup that we approve this resolution which does not obligate us in any way, but it does let us go ahead with the grant. Motion carried unanimously.
- 3. Resolution establishing stop signs on Tanbark Road at its intersection with Railroad Avenue and Memory Lane; and on Third Street at Ransom Avenue.

 MOTION by Councilman Cheney, seconded by Councilman Lowrie that we adopt this resolution. Motion carried unanimously.
- Previous requirements by the Council to review Smugglers! Cove construction plans prior to issuance of building permit. Bud Jones, builder, stated that they would like to complete the project within one year. MOTION by Councilman Allsup, seconded by Councilman Cheney that we issue a permit on Smugglers' Cove with the requirements that Marshall has here in our possession. Motion carried unanimously. Requirements were: Developer to install approximately 370 lineal feet of 8 inch water line along Del Norte Lane between Musser Street and the North property line, connecting to existing 4 inch and 2 inch water lines. Install one fire hydrant at the entrance to complex and one hydrant within the complex grounds to a 6 inch water line. Install a fence along Del Norte Lane to screen parking areas. Four hour area separation fire walls are required between each unit to reduce the fire flow requirement of the Fire Department. All of these requirements are to be completed before any

units are sold or occupied. Water line and fire hydrant specifications are to be approved by the City.

- 5. Bid opening on new Police vehicle. One bid from Coast Chrysler of \$6,936.22. Only \$6,500 budgeted so City Manager and Police Chief were to check with the State and report back to the Council.
- 6. Bid opening on City fuel purchasing. One bid submitted from Shell Station.

 MOTION by Councilman Allsup, seconded by Councilman Lowrie to accept bid. Motion carried unanimously.
- 7. Request from Azalea Community Center, Inc., for Council adoption of a resolution of endorsement of the proposed Southern Curry Parks and Recreation District. It was stated that the lines had been redrawn and included all of Districts 17C and 23 which is from the State border to about Whaleshead. Rick Sterry explained that the purpose was to allow for development of additional parks and recreation facilities and to maintain what facilities we have.

 MOTION by Councilman Cheney, seconded by Councilman Lowrie that we accept the resolution. Motion carried unanimously.

VI. CITY ATTORNEY REPORTS

Request from Lee and Fern Van Duzee for formation of Local Improvement District. There was discussion on this matter. Attorney William Mansfield, representing the Van Duzee's stated that this district would provide water and sewer service for five lots. There were two easements that needed to be acquired. There would be no cost to the City and it would be assessed back to the property owners. MOTION by Councilman Allsup, seconded by Councilman Cheney to accept Resolution No. 231. After discussion as to whom would pay the Engineering costs if the district should fail, Councilman Cheney and Councilman Allsup withdrew their motion. Attorney Mansfield wanted the Council's assurance that it is favorable and will go forward and enact the project. City Attorney made amendment to the resolution as follows: Section 4: petitioners Lee and Fern Van Duzee have agreed to pay all reasonable expenses of creating this special benefit assessment district should it not be created. Attorney Mansfield was agreeable to this addition.

MOTION by Councilman Allsup, seconded by Councilman Lowrie that we enter Section 4 into the resolution. Motion carried unanimously.

MOTION by Councilman Allsup, seconded by Councilman Lowrie that we accept the full resolution with the amendment. Motion carried unanimously.

VII. CITY MANAGER'S REPORTS

- 1. Request from Barbara Ashworth, Brookings-Harbor Little
 League Soft Ball Vice President, to plant a tree as a
 memorial at Bud Cross Park.
 MOTION by Councilman Cheney, seconded by Councilman
 Lockman that we accept the proposal but with the
 restrictions that we consult the Parks Commission
 before the tree is planted. Motion carried.
- 2. Request from Peggy E. Gould for reimbursment from the City resulting from sewer assessment and not having sewer hook-up Staff recommended that this item be referred to City Attorney for review and recommendation.
- 3. Request from the Church of Jesus Christ of Latter Day
 Saints to again reconsider negotiating a deed of rightof-way across church property. Mr. Freeman stated that
 the church had requested that this item be placed on the
 next Council Agenda.

VIII. PAYMENT OF VOUCHERS

1. The total amount of bills was \$25,127.78.

MOTION by Councilman Cheney, seconded by Councilman Allsup to pay bills. Motion carried unanimously.

MOTION by Councilman Cheney, seconded by Councilman Lowrie to continue the meeting until 9:00 a.m., November 21, 1979.

Meeting was adjourned at approximately 10:40 p.m.
