# MINUTES BROOKINGS COMMON COUNCIL CITY OF BROOKINGS APRIL 17, 1979

#### I. PLEDGE OF ALLEGIANCE

Mayor Elmer Hitchcock called the meeting to order at 8 p.m.

#### II. ROLL CALL

Members present were Councilmen C.Dwight Allen, Bill Canet. Darrell Allsup and Ray Lockman.

Staff present were: City Manager Frank Freeman, Chief of Police Robert E. Babb, Fire Chief Tony Keeling, Recorder-Treasurer Marge McKernan, and City Attorney John Spicer.

#### III. APPROVAL OF MINUTES

MOTION was made by Councilman Allen, seconded by Councilman Allsup and carried that the minutes of March 20 and March 26,1979\_be approved as presented.

#### IV. COMMUNICATIONS

1. Request from Kay Lathrop, Chairman of Community Center Optimists, concerning use of Council Chambers.

Mrs. Lathrop ask to use the Council Chambers for a meeting on April 30,1979 and if the meeting seems to be advantageous them they would like the use of the Chambers the last Monday of each month.

MOTION was made by Councilman Canet, seconded by Councilman Lockman and carried that this request be approved.

2. Request from Rance Eagleton concerning vacancy on State Regional Health Planning Commission.

MOTION was made by Councilman Allsup, seconded by Councilman Canet and carried that this be tabled due to the fact that there was no one in the audience to discuss the request.

- 3. Don Ratisseau, Chairman of Azalea Festival, ask permission from the Council to have Beer Garden during the Festival, to be held on the Elks Parking Lot. Council gave their approval.
- 4. Tony Anusich, Director of Coos-Curry Housing Authority, disscussed the possibility of a elderly housing unit be proposed and constructed in the City of Brookings. This would be a low cost housing unit for the Elderly only. The State Housing Commission would loan 80% on the project. and the remaining 20% could possibly be from donation of property. It would have to be constructed close to facilities such as grocery stores and medical facilities. It was suggested that maybe the Palm Stout property deeded to the City could be used for this project, but was advised that this property can be used for park purposes and Community center only. No action was taken on this information.

1. Amendment and update of Ordinance No 37 dated November 5, 1952 pertaining to City Fire Department and personnel.

Ordinance No. 309, An Ordinance creating a FIRE DEPARTMENT PROVIDING FOR THE APPOINTMENT OF A CHIEF, TWO VOLUNTEER ASSISTANT OFFICERS, OTHER VOLUNTEER OFFICERS, AND MEMBERS THEREOF: PRESCRIBING DUTIES OF THE CHIEF: RELATING TO EQUIPMENT, THE PREVENTION AND SUPPRESSION OF FIRED, PROVIDING A PENALTY FOR VIOLATION THEREOF, AND DECALRING AN EMERGENCY was read in full.

MOTION was made by Councilman Lockman and seconded by Councilman Allsup that Ordinance No. 309 be read the second time by title only.

2. Request to accept sewer and water lines in Bird Island Subdivision. This is Anderson Subdivision.

After some discussion a MOTION was made by Councilman allen seconded by Councilman Canet and carried that this subdivision is not to be accepted until all of the work is complete.

5. Agreement between Curry County and the City of Brookings regarding mutual utilization of a Road Department Road Grader.

MOTION was made by Councilman Allen, seconded by Councilman Canet and carried that this agreement be approved., and Mayor is authorized to sign said agreement.

6. Police Service Mutual Aid Agreement between cities and counties of Coos And Curry Counties.

MOTION was made by Councilman Lockman, seconded by Councilman Allen and carried that this agreement be approved and the Mayor be authorized to sign said agreement.

7. Short-Term Promissory note for \$60,000. for High Level Water System project.

MOTION was made by Councilman Allsup, seconded by Councilman Lockman and carried unanimously that short term note be approved.

8. Review of City Liability Insurance by Mr. Jerry Ross.

Mr. Ross explained to the Council the coverage that they now have on the Liability Insurance, and suggested that the City take out an additional policy for Liability Insurance which would amount to approximately \$1,800. Councilman Allen requested that this additioal coverage be taken out immediately but was advised by the City Recorder that there is no money available in the current budget. Councilman Allen then made a MOTION that this additional coverage be included in the 79-80 budget. MOTION was seconded by Councilman Canet and carried unanimously, Copy of Insurance break down attached.

- 9. Proposed bylaw Amendment by the Coos-Curry Council of Government (CCCOG).
  MOTION was made by Councilman Allsup, seconded by Councilman Allen and carried that this be tabled.
- 10. Liquor Application Renewals

- 13. ORDINANCE NO. 310 AN ORDINANCE AMENDING THE ZONING MAP AND COMPREHENSIVE PLAN OF THE CITY OF BROOKINGS was read in full.

MOTION was made by Councilman Lockman and seconded by Councilman Allsup that Ordinance No. 310 be read the second time by title only.

#### VII. PARKS AND RECREATION COMMISSION

1. Parks Commission recommendation on Iris Street open space Viewpoint.

MOTION was made by Councilman Lockman, seconded by Councilman Allen and carried that money proposed in the forthcoming budget be considered for buying a fence to install at this location.

#### VIII. CITY MANAGER

1. Informational report on establishment of Explorer Post 546.

Fire Chief Keeling advised that the Fire Explorer Post 546 went into operation on March 1. That all helmets, coats, ect., have been obtained at no cost to the City (enough for 15 members. Through their initiative they have raised \$363.00 to date to obtain more equipment. Their purpose will be to help in cases of emergency, But they will not ride "Code 3" or make interior fire attacks. Ages will range from 14 years to 19 years of age. Chief is very pleased with enthusiasm they have expressed.

2. Increase inpreviously authorized purchase price of police vehicle from State Department of General Service.

3. Request from HGE Consulting firm for an additional \$2,000. to complete City Inflitration and Inflow waste water study.

Mayor Hitchcock advised that he felt when a contract price is submitted and approved there should not be any additional charges. Dick Nord, Engineer, advised that when they submitted the proposed price of approximately \$8,500. that there was a possiblity it might go higher for this study has been done on hourly base.

MOTION was then made by Councilman Allen, seconded by Councilman Allsup and carried that the additional amount of \$2,000. be approved.

Mr. Nored will present a progress report at the next regular Council meeting, also an estimate on costs for repair to the sewer system.

4. Request from Dawson Fire District Board to discusexisting Fire protection contract.

Per request this was withdrawn from the agenda.

Mayor Hitchcock called an executive meeting under ORS 192.622, Section 2(d).

When the Mayor and Council returned from the executive session the following motions were made:

C79-4-40 in the Circuit Court of the State of Oregon for Curry County of Francis A. Arrell, and Helen E. Arrell, Don F. Gibbs and Sheryn K. Gibbs, Petitioners vs The Common Council of the City of Brookings and that Mr. Fallert he contacted and ask for their help in ths case.
- b. MOTION was made by Councilman Canet, seconded by Councilman Lockman and carried that the City contest the case of the Underworld business vs City of Brookings on Ordinance No. 308 an Ordinance prohibiting dealing in drug paraphernalia and City Attorney be authorized to obtain outside help.

#### IX. PAYMENT OF VOUCHERS

MOTION was made by Councilman Allen, seconded by Councilman Canet and carried that vouchers in the amount of \$51,174.43 for the month of March, 1979 be paid.

MOTION was made by Councilman Allsup, seconded by Councilman Allen and carried that the meeting be adjourned. The meeting then adjourned at 11:35 p.m.

This could be termed as double insulation for the councilmen.

For limit of \$1,000,000.00 - Estimated Annual Premium - \$1,800.00

3. Blanket Liability including Automobiles -

Specifications are published annually. Beginning with the 1979-80 term Umbrella Liability - Limit \$1,000,000.00 will be included in the specifications for bid.
