# MINUTES BROOKINGS COMMON COUNCIL SPECIAL COUNCIL MEETING CITY OF BROOKINGS JULY 10, 1978

Meeting was called to order at 11:17 a.m. by Mayor Robert L. Kerr. Members present were Councilmen Darrell Allsup, Tony Leeds, and Jack Wheeler. Councilman Ray Lockman was absent. Staff present were City Manager Al R. Hooten and Recorder Marge McKernan.

#### LEGISLATIVE ACTION:

1. RESOLUTION NO. 208 - RESOLUTION ADOPTING BUDGET FOR FISCAL YEAR 1978-79.

Resolution No. 208 was read in full.

MOTION was made by Councilman Wheeler, seconded by Councilman Allsup and carried unanimously that Resolution No. 208 be adopted.

2. CHANGE ORDER NO. 1 ON OXFORD, MAPLE AND CEDAR STREET.
IMPROVEMENT PROJECT.

MOTION was made by Councilman Leeds, seconded by Councilman Wheeler and carried unanimously that this change order be approved. Copy attached.

3. TIME EXTENSION REQUEST FOR COMPLETION ON OXFORD, MAPLE AND CEDAR STREET IMPROVEMENT PROJECT.

MOTION was made by Councilman Allsup, seconded by Councilman Wheeler and carried unanimously that this extension of 30 days be granted, but that no more extension of time is to be approved.

4. REPAIR ON LOADER, ESTIMATE COST \$1,200.00.

MOTION was made by Councilman Allsup, seconded by Councilman Wheeler, and carried unanimously that the loader be repaired if the money is available.

#### OTHER MATTERS:

City Manager read his letter of resignation, to be affective August 1, 1978. Council tabled taking action on this resignation until the regular meeting of July 18, 1978.

Mayor Kerr read a letter from W. A. McKenzie, Manpower Technician, Coos-Curry Manpower Consortium in reference to CETA termination, which read:

The City of Brookings and Coos-Curry Manpower Consortium have a contractual agreement regarding the employment of CETA participants. We have noted in the Pilot that the City of Brookings wishes to terminate the agreement. a notification from the City, we have the following concerns:

- When is this termination to take effect?
- What will happen to the CETA employees currently enrolled? (Specifically the office clerk and the sewer treatment plant operator, whose contracts run beyond July 1, 1978.)
- 3. Is this termination to effect the CETA Title I NYC employees? If so, when?

After some discussion, the Council suggested that they review and consider further employment with CETA. City Manager was instructed to reply to Mr. McKenzie's letter.

Lynn Kofford, 1020 Fifield Street, requested that the Council put a catch basin on the corner of Fifield and Mill Beach Road. Councilman Allsup will check into this request and advise.

#### ADJOURNMENT:

MOTION was made by Councilman Allsup, seconded by Councilman Leeds and carried that the meeting be adjourned. The meeting then adjourned at 12 o'clock noon.

RE: Oxford, Maple and Cedar Street
Improvements for the City of
Brookings

This is to report to you what has transpired on the above job and to explain our request, which follows, for an extension of time.

It was our plan, from the beginning, to use a curb and gutter machine to meet the requirements of the plans, saving the City several thousand dollars, and we made arrangements early with Kiser Cement of Coos Bay to do the work. Kiser had to delay us three days on their arrival, and then, when work proceeded on the curb and gutters, all the local aggregates, as well as that which we had hauled in from Crescent City, simply would not provide a concrete that was usable. We made every possible effort to accommodate the machine, but it finally was the concensus of everyone concerned, that the work would have to be done with forms, and we have arranged for Goldie Gentle Construction, Portland, to commence the work with steel forms beginning 5 July.

This work, of course, will be at considerably more expense than figured on in the bid, and the additional cost will be out of our pocket by our agreement. However, trying to solve the problem with the machine cost a good deal of time, and we honestly feel that although the added expenses must be ours, we should be granted an additional thirty days beyond the present completion date.

After you have discussed this matter with the City Manager and John Thorp, we would appreciate hearing from you.
