MINUTES BROOKINGS COMMON COUNCIL CITY OF BROOKINGS OCTOBER 2, 1978

Meeting was called to order at 7:40 p.m. by Mayor Robert L. Kerr. Members present were: Councilman Darrell Allsup, C. Dwright, and Ray Lockman. Councilman Jack Ross was absent. Staff present was Marge McKernan, Recorder.

The purpose of this meeting was for holding the following three Public Hearings on comprehensive plan and zone changes.

1. REQUEST BY CUSTOM LEASES FOR AMENDMENT TO ZONING ORDINANCE AND COMPREHENSIVE PLAN FOR ZONE CHANGE ON TAX LOT 500,
MAP 41-13-6CA FROM RH TO CG ZONE TO PERMIT LIGHT COMMERCIAL DEVELOPMENT.

Mayor Kerr was the presiding officer of these hearings.

Chairman Kerr inquired of the Panel whether any member thereof wishes to abstain from participation in the hearings and was advised that they would participate. The hearing then commenced.

Murry Palmer, applicant-proponent for Custom Leases advised that it is well determined that there is a need for commercial property and that was the purpose of purchasing this property. This property is located to the rear side of other commercial establishments and would not be a spot zone change. The Property on Fifield street would stay as residential. There would be no traffic problem. All streets will be paved. Brookings Planning Commission had recommended that the Coucil approve this zone change.

Charles Rosendale, opponent, cross examind Mr. Palmer. Mr. Rosendale ask Mr. Palmer, "if he was duly qualified to do business in the state of Oregon?" Mr. Palmer replied "yes." Mr. Rosendale ask who the associates in the Custom Leases are" and Mr. Palmer replied "Don Horton and Virginia Manley."

Mr. Rosendale said "that the last time he was duly notified was at the Planning Commission and Mr. Palmer's petition was turned down, and that Pauline Kimble had not been notified of this public hearing, and I object to this underhanded leaszy type of government and that Mr. Palmer was turned down three times by the Planning Commission." Chairman Kerr objected to this statement and advised Mr. Rosendale that he and Mrs. Kimble had been notified by certified mail on September 21, 1978 that this meeting was scheduled. Mr. Rosendale then said "so much underhanded cheap deals." Councilman Lockman then told Mr. Rosendale that he had not stated any reson for objection, just gripes. More argumentive conversation went on between Mr. Rosendale and Councilman Lockman. Chairman Kerr once again brought down the gavel.

City Attorney advised that the purpose of this hearing is to present evidence why the zone change is to be or not to be made.

Mr. Palmer then advised that his petition had been turned down only once, not three times as Mr. Rosendale stated.

Mr. Rosendale then said that Mr. Palmer stated that Pauline Kimble had rescinded her objection to this zone change which was an out right lie".

Mr. Rosendale refused to act in an orderly manner and Chairman Kerr requested that the Sgt. of Arms of Police Station be called in.

Mr. Rosendale then stated "that is the way to do it, get rid of the opponent.

Chairman Kerr then ask for any other comments.

Mrs. Kimble objected to the drainage that she now gets from run off from Kawasaki. Councilman Allsup recommended that this run off be corrected by Custom Leases. Mrs. Kimble stated that she objected to having commercial property in the neighborhood.

Mr. Palmer then ask to question Mrs. Kimble. Mr. Palmer ask Mrs. Kimble "when we sold you the front portion and developed the back portion you stated that you had no objections" Mrs. Kimble replied " I guess so."

Chairman then ask if there was any rebuttal evidence, the answer no. Chairman then called the hearing closed.

MOTION was made by Councilman Allen, seconded by Councilman Lockman and carried unanimously to go with the proponents and they are to present the Council with finding of facts for their approval.

2. REQUEST BY JOHN R. DECK FOR AMENDMENT TO ZONING ORDINANCE
AND COMPREHENSIVE PLAN FOR CHANGE OF ZONE ON TAX LOT 2000.
MAP 41-13-6BD FROM RM ZONE' TO CG ZONE TO MAKE THIS PROPERTY
COMPATIBLE WITH HIGHWAY FRONTAGE BEING UTILIZED FOR COMMERCIAL PURPOSES

John R. Deck appeared on his own behalf and explained that he was planning on putting in a duplex above and business below, adjacent to Brookings Supply. Dick Purdue who owns adjacent property had no objections to the zone change, but he requested that a buffer zone be between the two properties. MOTION was made by Councilman Allsup, seconded by Councilman Allen that this be tabled until October 9, and that time an agreement be presented between the two parties.

3. REQUEST BY GEORGE DREISZUS FOR AMENDMENT TO ZONING ORDINANCE AND COMPREHENSIVE PLAN TO CHANGE TAX LOTS 8600, 8700, 8800, and 8900, MAP 41-13-5CB FROM RH ZONE TO CG ZONE TO ALLOW THE REMODELING OF CHURCH AND BUILDINGS TO ACCOMODATE RETAIL AND OFFICE FACILITIES.

There were no objections presented to this zone change.

MOTION was made by Councilman Allsup, seconded by Councilman Lockman and carried unanimously that this zone change be approved with the following stipulations recommended by the planning commission: No wrecking yard, no night club and no dog kennel be built on this property.

MOTION was made by Councilman Lockman, seconded by Councilman Allen and carried that the meeting be adjourned until October 9, 1978 at 11:00 a.m.
