Marquess and Associates will be asked for an opinion on pipe size and other pertinent facts.

Forms from the Oregon Ethics Commission were given to each Councilman and the Mayor and they were instructed to review these and prepare to fill them out prior to April 15, 1978.

The Planning Commissioners, Municipal Judge and City Manager along with the Council are to submit these statements of economic interest annually.

These forms will be sent to the City Hall and each effected person will be given their form for submission.
