# MINUTES BROOKINGS COMMON COUNCIL CITY OF BROOKINGS APRIL 18, 1978

Meeting was called to order at 8:00 p.m. by Mayor Robert L. Kerr. Members present were: Councilman Darrell Allsup, Tony Leeds, Ray Lockman and Jack Wheeler.

#### APPROVAL OF MINUTES:

MOTION was made by Councilman Leeds, seconded by Councilman Lockman and carried unanimously that the minutes of March 21, 1978 Council meeting be approved as presented.

#### PUBLIC HEARINGS:

A. ZONE CHANGE, REQUEST TO APPEAL THE DECISION OF THE PLANNING COMMISSION ON THE MATTER OF A ZONE CHANGE REQUEST BY CUSTOM LEASES ON TAX LOT 500, MAP 41-13-6CA FROM RH TO CG ZONE.

Mr. and Mrs. Charles Rosendale and Mrs. Kimble, who own property in the area of the above named tax lot, objected to this zone change.

After some discussion a MOTION was made by Councilman Leeds, seconded by Councilman Wheeler, and carried unanimously that this zone change be referred back to the Planning Commission.

B. SUPPLEMENTAL BUDGET 1977-78.

This Public Hearing was held for the purpose of public input on the supplemental budget. No objections were presented.

RESOLUTION NO. 206, ADOPTING THE SUPPLEMENTAL BUDGET.

Resolution No. 206 was read in full.

MOTION was made by Councilman Lockman, seconded by Councilman Allsup and carried unanimously that Resolution No. 206 be adopted.

#### LEGISLATIVE ACTION:

1. COUNCIL HEARING FOR KEN MAC LEOD.

William Mansfield, Attorney for Ken MacLeod, presented his case to the Council which was in part as follows:

In May of 1977, Mr. MacLeod contacted the City Building Inspector and told him that his neighbor, Leo Appel, was in violation of City Ordinances by building a greenhouse without permit, fence above height, and was storing furniture in outside building.

In July of 1977, the City Manager wrote to Appel advising him that he was in violation for building without a permit.

No building permit had been obtained by Mr. Appel, so in October 1977 the City Manager sent a certified letter to Mr. Appel. The violations were then corrected by Mr. Appel.

In December 1977 Mr. Appel, by letter to the City Manager, advised that Mr. MacLeod was in violation for he had let his hedge shrubs grow too high which technically violates the "Clear Vision Section" of the City ordinance and had put up a wind propeller which also offended his neighbor.

Mr. Mansfield continued: The City Manager then wrote to Mr. MacLeod advising him of violation and explained that he and the Building Inspector had tried to solve this problem between the two people and felt that it was an imposition on behalf of the city to be forced into settling these type of neighbor to neighbor squabbles when there were so many other pressing City wide problems. Mr. Mansfield advised that he thought this letter to Mr. MacLeod was in bad form and that the City Manager could be held libelous.

Mr. MacLeod had requested that he be heard before the Council, on this matter by writing to the Mayor and City Manager, but that no action had been taken until he had hired an attorney. Mr. MacLeod resented the fact that in order to be heard he had to hire an attorney.

Mr. Mansfield asked that the City Council state the fact that Mr. MacLeod was not in violation of the fence and the City Manager be instructed in the handling of this kind of situation in the future. Council were in agreement with this request and stated an executive meeting would be held on the matter with an evaluation of the situation and any corrections would be taken care of.

# 2. ORDINANCE NO. 294 AN ORDINANCE DECLARING THE CITY'S ELECTION TO RECEIVE STATE REVENUE.

Ordinance No. 294 was read in its entirety.

#### 6. WHARF STREET PROJECT.

This project is replacement of sewer lines on Wharf and Spruce Streets.

MOTION was made by Councilman Leeds, seconded by Councilman Allsup and carried unanimously that the City advertise for bids. Estimated cost, including engineer charges, is \$33,355.00.

7. CONTRACT AWARD OF OXFORD, MAPLE & CEDAR STREETS IMPROVEMENT.

MOTION was made by Councilman Allsup, seconded by Councilman Lockman and carried unanimously that this contract be awarded to the lowest bidder who was M & F Builders at the cost of \$74,096.00.

#### 8. SEWER CLEANING MACHINE PURCHASE.

MOTION was made by Councilman Allsup and seconded by Councilman Wheeler that the City purchase this machine for the amount of \$8,148.00. Councilman Leeds opposed this purchase. Motion passed.

9. RENEWAL OF LIQUOR APPLICATION.

MOTION was made by Councilman Leeds, seconded by Councilman Wheeler and carried unanimously that the liquor application for Ray's Sentry be approved.

#### PAYMENT OF VOUCHERS - MARCH 1978:

MOTION was made by Councilman Leeds, seconded by Councilman Lockman and carried unanimously that vouchers in the amount of \$69,492.06 be paid.

MANAGER'S REPORT: Attached.

#### OPEN DISCUSSION:

Resignation of C. M. "Bud" Cross, Chief of Police, was read and accepted.

Mr. Lee Van Duzee advised the Council that he objected to Article 3 of

Ordinance No. 288. He had requested authorization for partitioning land at the end of Hampton Road, and did not feel that he should be obligated to sign a statement of waiver of protest to street improvement assessments. No action was taken on this request.
