MINUTES BROOKINGS COMMON COUNCIL CITY OF BROOKINGS SEPTEMBER 13, 1977

The meeting was called to order at 8:05 p.m. by Mayor Robert L. Kerr. Members present were Councilmen Tony Leeds, Ray Lockman, Darrell Allsup and Jack Wheeler. Also present were City Manager Al Hooten and Recorder-Treasurer Marjorie B. McKernan.

APPROVAL OF MINUTES:

MOTION was made by Councilman Allsup, seconded by Councilman Lockman and carried unanimously that the minutes of August 9, 1977 be approved as presented.

PUBLIC HEARINGS - None.

MONTHLY REPORTS:

City Attorney - none.

Consultant Engineer - Joe Stonecypher advised that the bid openings on the High Water Level project is scheduled for 7:00 p.m. on Sept. 271977.

LEGISLATIVE ACTION:

LIQUOR APPLICATION - LITTLE ITALY.

MOTION was made by Councilman Lockman, seconded by Councilman Wheeler and carried unanimously that the liquor application for Little Italy be approved.

PRESENTATION OF A NAME FOR RANSOM AVENUE PARK.

Mrs. Thelma Canet presented a petition to the Council with 600 signatures asking that the Ransom Avenue Park be named "Bud Cross Park".

Mrs. Canet stated the Police Chief, Bud Cross, has served the Brookings community for 30 years and he had contributed much to the community.

Mr. Watkins, Parks and Recreation committee member, was in the audience and advised they had approved of naming it Bud Cross Park. After some discussion,

MOTION was made by Councilman Leeds, seconded by Councilman Wheeler and carried that the petition be accepted and that Ransom Avenue Park be named "Bud Cross Park". Mayor's Proclamation on new name for park is forthcoming.

3. AUTHORIZATION TO ADVERTISE FOR POLICE CAR BIDS.

MOTION was made by Councilman Allsup, seconded by Councilman Leeds that authorization be given to advertise for Police Car bids to be opened on October 11, 1977.

4. REQUEST FROM BROOKINGS-HARBOR SCHOOL DISTRICT FOR REVIEWING THE CITY'S PROCEDURE FOR ISSUING BUSINESS LICENSES.

City Manager was directed to investigate current Cities Ordinances and recommend to Council.

5. REQUEST FOR DUST ABATEMENT ON TANBARK ST. EXTENSION.

City Manager advised that at the present time a barricade has been placed on this street so no vehicles can use this street. Property owners in this area will soon be approaching the City to form a Street Improvement District for this area.

6. REQUEST FOR INSTALLATION OF SEWER LINE AT 5TH & EASY STREETS.

Mr & Mrs. Clyde Holland requested that a sewer line to their property be extended. Mayor Kerr expressed his views on putting in any more small sewer districts, the problems that could arise by sewer lines not being large enough to necessitate future growth in these areas. He suggested that one large sewer district be formed to take in the unsewered large area in Brookings which is North of Easy Street, East of 5th Street, West of Pioneer Road and South of Meadow Lane.

MOTION was then made by Councilman Leeds, seconded by Councilman Allsup and carried unanimously that the request for sewer line extension of Mr. & Mrs. Clyde Holland be denied.

MOTION was then made by Councilman Allsup, seconded by Councilman Leeds and carried unanimously that the City proceed with sewer district in the above named area.

PAYMENT OF VOUCHERS:

MOTION was made by Councilman Allsup, seconded by Councilman Leeds and carried unanimously that vouchers in the amount of \$52,677.42 for August 1977 be paid.

MANAGER'S REPORT - Attached.

Al Hooten read a letter of resignation from Pool Manager Carol Drake to be effective September 30, 1977. Her husband, who works for Coos-Curry Electric, has been transferred to Coquille.

John Thorp, Engineer, was in the audience and requested decision on the English Subdivision concerning sidewalks. Mr. Thorp advised that after the subdivision was approved without sidewalks he was then advised by a City employee that sidewalk had to be installed in this subdivision.

After some discussion the Council scheduled a meeting on Sept. 15, 197 to meet with developers and interested individuals to discuss this matter.

Mr. Hooten discussed the proposed application through BOR monies for

restroom facilities at the "Bud Cross Park". Council directed him to proceed with this application.

Mr. Hooten told the audience and Council that some of the new sewer charges would have to be revised. This is the first time that the water and sewer bills have been computed on the City's new bookkeeping machine. After the bills were completed it was then discovered that on the commercial rates a different formula will have to be used. The commercial rates that were computed in error will be given credit for the overcharge.

Jack Ross, Library Board Member, requested that the Council approve a Resolution stating that the Chetco Community Library Board of Trustees form a public foundation (a non-profit entity) for the purpose of serving the cultural, recreational and educational enrichment and need of the Brookings-Harbor community. Resolution is to be prepared for the next regular Council meeting of October 11, 1977.

Mr. Watkins, Parks and Recreation member, requested that Council prepara Resolution for donations received for Palm Stout Park, similar to Resolution requested by Library Board. Resolution to be prepared for next regular Council meeting.

ADJOURNMENT:

MOTION was made by Councilman Allsup, seconded by Councilman Lockman and carried unanimously that the meeting be adjourned. The meeting then adjourned at 9:30 p.m.
