The meeting was called to order at 8:00 p.m. by Mayor Robert L. Kerr. Members present were Councilmen Jack Wheeler, Ray Lockman, Tony Leeds, and Darrell Allsup. Also present were Al R. Hooten, City Manager and Marjorie B. McKernan, Recorder-Treasurer.

APPROVAL OF MINUTES - November 8, 9, & 22, 1977.

MOTION was made by Councilman Lockman, seconded by Councilman Wheeler and carried unanimously that the minutes be approved as presented.

#### SURPRISE!

Mr. & Mrs. Frank MacLvor, who now live in Harbor, presented Mayor Kerr with the key to Redondo Beach, which was given to them by Mayor David K. Hayward of Redondo Beach. Mayor Kerr expressed his appreciation.

#### BIDS:

1. BANCROFT IMPROVEMENT BONDS IN THE AMOUNT OF \$26,732.61.

Bids were received from the following:

MOTION was made by Councilman Allsup, seconded by Councilman Lockman and carried unanimously that the lowest bid, which was Western Bank, be accepted at the effective interest rate of 4.9267%.

PICKUP FOR FIRE DEPARTMENT.

MOTION was made by Councilman Lockman, seconded by Councilman Leeds and carried unanimously that these bids be referred back to the Fire Department for their review and a bid is to be approved at the continuation of this meeting to be held on December 15, 1977.

### PUBLIC HEARINGS:

 ZONE CHANGE FROM RL TO CG ON TAX LOTS 10600, 10700, & 10800, MAP 41-13-5CB TO PERMIT THE CONSTRUCTION OF A MOTEL - APPLICANT, JAMES R. BARRETT.

Mr. Barrett presented the Council with information outlining

his proposal, advising that there would be 100 units in this motel. This property is located next to the bowling alley. Mr. Barrett inquired from Council if two right of way easements could be vacated on this property and he was advised that a Public Hearing would have to be held on the vacation of these right of ways.

MOTION was made by Councilman Wheeler and seconded by Councilman Lockman that this zone change be approved with stipulations that it be in accordance with City Building Department and Engineering Department. Councilman Leeds voted "No". Motion carried.

Ordinance is to be prepared on this zone for regular Council meeting in January, along with Public Hearing on vacated right of ways.

2. AMENDMENT TO THE COMPREHENSIVE PLAN TO BE HEARD CONCURRENTLY WITH REQUEST FOR ZONE CHANGE FROM RL TO RH ON TAX LOT 8000, MAP 41-13-5CD - APPLICANT, DR. & MRS. GERRID JOY.

Bud Jones represented Dr. & Mrs. Joy and advised that this would be a Towne House Development with possibly 15 units and showed drawing of proposed development. Mr. Jones also advised that no existing view would be ruined and that it would not be a high rise construction, no structure over two stories high.

MOTION was made by Councilman Wheeler, seconded by Councilman Allsup and carried unanimously that Comprehensive Plan and zone change be approved with the stipulation that it be in accordance with Building and Engineering Departments and Council review the building permit before being issued.

Ordinance to be prepared for the regular Council meeting in January.

#### MONTHLY REPORTS:

Cameron C. Thom, City Attorney, advised that the two lawsuits the City was involved in had been settled out of Court.

Consultant Engineer - Joe Stonecypher advised that the contracts for the Upper Water Level project were ready to be signed.

MOTION was made by Councilman Allsup, seconded by Councilman Lockman and carried unanimously that Mayor Kerr be authorized to sign the contracts.

#### LEGISLATIVE ACTION:

#### 1. BROOKINGS SOROPTIMIST

Marian Lamm, President, and Thelma Canet and Carol Lockman spoke on behalf of the Soroptimist Club. They advised that

they are hoping to help in the process of developing a Community Center in the City. They advised that they had met with the Curry County Commissioners and were told that the County are planning on building some offices in Brookings and it was a possibility it could be combined with a Community Center.

They asked the Council if they would be willing to donate the City property adjacent to City Hall for parking purposes if property now owned by Jerry Ross & Alden Loring, which is adjacent to the City property, could be purchased for the Community Center. The Council recommended the Soroptomist check into the impact this would have on the community and also check to see how many cars could be parked on the City property and bring the information back to them.

# 2. DISCUSSION OF BUSINESS LICENSING - AMENDMENT CURRENT ORDINANCE

Al R. Hooten, City Manager, recommended to the Council that in the present City License Ordinance there is nothing to prevent undesirable businesses from coming into town and it should be amended. The matter was under discussion because of the rumors that obscene material might be sold in this area.

City Attorney was instructed to supply the Council with a sample ordinance for the next regular Council meeting. City Manager presented the Council with a newly formed application that has to be filled out before a City License can be sold. Council had no objections to this application form.

## 3. REQUEST OF PARKS & RECREATION COMMISSION

Asked that the Council consider and act on the following proposals:

1. That the Chetco Avenue Park & Fountain be maintained and operated throughout the entire year.

Mayor Kerr advised that he had instructed the manager to shut down the fountain for it was not operating properly and it would be an expense to the City to prepare it. City Manager advised that he had just hired an employee in the Parks & Recreation Department and also hired a new CETA employee to work in this department, and that the parks would now be maintained. Council agreed that the fountain should be repaired.

That the Children's Park on Easy Manor Drive be named "Elmer Lee Park" in honor of him. The inspiration and promotional efforts that Elmer Lee has provided throughout the many years that he served the City made him worthy of honor. The City's total recreational facility has benefitted because of Mr. Lee's personal commitment to parks, open spaces, and people enjoying themselves.

Mayor Kerr advised that Mr. Lee was being paid by the City when this park was being formed and it was part of his job. Mr. Lee Hansen, who was in the audience, stated that "Mr. Lee had put in many hours of his personal time working on Parks in the City".

MOTION was made by Councilman Allsup and seconded by Councilman Lockman that the Easy Manor Park be named Elmer Lee Park. Mavor Kerr, Councilman Wheeler voted "Naye" and Councilman Leeds abstained from voting. Motion did not carry.

3. That no final action be taken on removing the Stout Park from City possession without approval of the City Attorney, the Parks Commission, and a duly advertised public hearing.

Mayor Kerr agreed with the Park Commission. Councilman Wheeler advised that he had changed his mind about relinquishing the Stout Park. No legal action has been taken as of this date to return the property to Mrs. Stout.

MOTION was then made by Councilman Lockman and seconded by Councilman Wheeler that the City retain the Stout Park. Councilman Leeds voted "Naye". Motion carried.

4. EVALUATION OF SEWER DISTRICT #5 - PROJECT REPORT FROM ENGINEERING DEPARTMENT

This was tabled until January Council meeting.

- 5. ORDINANCE NO. 288 AN ORDINANCE ON STREET IMPROVEMENT

  This Ordinance was read in full. No action was taken this date but is to be considered at the continuation of this meeting to be held on December 15, 1977.
- 6. RESOLUTION NO. 204 RESOLUTION AUTHORIZING TRUST FOUNDATION FOR CHETCO COMMUNITY LIBRARY

Resolution No. 204 was read in full but no action was taken.

7. CONSIDERATION OF SELECTING ENGINEERING CONSULTANT
No action was taken.

MOTION was made by Councilman Leeds seconded by Councilman Wheeler and carried unanimously that vouchers in the amount of \$35,838.92 be paid.

This letter was an invitation to the Welcome Back Party for the Cross Country Track Team on December 16, 1977 at 3 p.m. Lyn Purdue, Jenny Batty and Jeff Pruden placed high enough to qualify for next years Junior Olympics to be held in Shawnee, Kansas. ## ITEM 2 WHARF STREET PROJECT

Niemi & Thorp are currently designing the sewer line that must be placed in this street and we will be working with the design section people starting in January 1978.

## ITEM 3 CEMBELLIN SEWERAGE SYSTEM OFF MILL BEACH
