MINUTES BROOKINGS COMMON COUNCIL CITY OF BROOKINGS FEBRUARY 8, 1977

The meeting was called to order at 8:05 p.m. by Mayor Robert L. Kerr. Members present were Councilmen Ray Lockman and Ellis Dowden. Also present was City Manager Al R. Hooten. Absent were Councilmen Tony Leeds and Darrell Allsup.

APPROVAL OF MINUTES:

MOTION was made by Councilman Dowden, seconded by Councilman Lockman and carried unanimously that the minutes of January 11, 1977 regular Council meeting be approved as presented.

PUBLIC HEARINGS:

1. REQUEST FOR ZONE CHANGE BY JOHN C. DULISSE ON TAX LOT 1601, MAP 41-13-5CC FROM RL TO RM TO PERMIT THE BUILDING OF A TWO FAMILY DWELLING.

The reason Mr. Dulisse requested this zone change was for the purpose of adding an addition to the house for his mother. This would enable him to have constructed another kitchen attached to the house. There were no remonstrances on this zone change.

MOTION was made by Councilman Lockman, seconded by Councilman Dowden and carried unanimously that this zone change be approved.

2. REQUEST FOR ZONE CHANGE BY JOHN DARJANY AND DONALD HORTON ON TAX LOTS 2600, 2500, 2700, AND 2701, MAP 41-13-6DD FROM ML TO MG TO PERMIT THE EXISTING AUTO WRECKING YARD TO CONTINUE OPERATION AND COMPLY WITH CITY AND STATE REQUIREMENTS.

There were no remonstrances on this zone change request.

MOTION was made by Councilman Dowden, seconded by Councilman Lockman and carried unanimously that this zone change be approved.

3. REQUEST FOR ZONE CHANGE BY FRANK M. CEMBELLIN ON TAX LOT 300 MAP 41-13-6CD FROM RL TO RH TO PERMIT THE BUILDING OF A CONDOMINIUM.

Michael P. O'Dwyer, attorney for Mr. Cembellin, gave the presentation of the proposed construction of this condominium. There would be twelve to fourteen condominiums which would be connected with a breeze way. One garage and space for another vehicle at each dwelling. An artist's sketch was shown along with map showing the exact location at the end of Mill Beach Road along the ocean. Slides were shown of a similar condominium that Mr. Cembellin had constructed in California. These proposed units would lie from ten to twelve feet below the bluff and would not obscure the view of other residents in the area. There are no sewer facilities in this area, so Mr. Cembellin would build one

to serve his property, also would be able to incorporate other properties who do not presently have sewer. The construction would be in compliance with the building code. Roadway would be built to the end of property, width being City's specifications. This would then give people access to the beach.

James Barnes, property owner of adjoining property, was in favor of this proposed condominium.

Larry Marvin, another property owner in this area, stated that he preferred to see the zone stay in its present status.

Mr. & Mrs. Dwight Allen objected to this zone change because of the added traffic in this area. They are also property owners within this area.

The Brookings Plywood Corporation, also property owners involved, objected to this zone change. William Hutchinson, attorney for Plywood, advised that they were fearful that would-be residents of this condominium might object to the Plywood's operation, which may force the Plywood to move.

Mr. Cembellin's attorney, Michael P. O'Dwyer, advised that it would be stated in the sale of each unit that the owners could not bring any claim against the Brookings Plywood Corporation for the fall-out, smoke, or noise.

Also it would state in the zone change that a time limit be set on the construction of this unit.

After more discussion, a MOTION was made by Councilman Dowden, seconded by Councilman Lockman and carried unanimously that this zone change request be tabled.

MONTHLY REPORTS:

City Attorney - None.

Consultant Engineer's Report - Joe Stonecypher advised that Sunset Underground had begun on the construction of Chetco water line.

The Mill Beach Pressure Main has been completed. During the construction the pumps at Mill Beach Pump Station were damaged. Retainage on the final payment of this contract is being held until this damage is finalized.

4. AGREEMENT FOR ENGINEERING SERVICE WITH H.G.E., INC.

Joe Stonecypher, P.E., advised that the time limit could be changed to whatever the Council desires, one year, two years, or what ever. More discussion followed, but no action was taken.

An official of the Coos Curry Regional Housing Authority explained to the Council what this entails. Copy of this information is attached to the minutes. If the Council approves this Authority, they then in turn will have to approve a Resolution so stating.

CITY MANAGER REPORT FEBRUARY 8, 1977

ITEM - BUDGET COMMITTEE TRIP

Thursday, February 17, 1977 at 2:30 p.m. Tentative date for the Committee and City Department heads to start at City Hall by visiting the Police Department facilities, the Courts, and Jail facilities.

Next will be the Engineer's office, the Building Department w/Planning and Zoning along with the City Hall offices.

The Fire Department will then be visited and members of the Committee will see equipment and the Department's facilities.

We will then tour the Sanitary Wastewater Treatment Plant and City shops.

The Ransom Park Complex will be included next with the various facilities including swimming pool complex, Little League Field, the Tennis Court project, then to Easy Manor Playground on Easy Street.

The final facility will be the City Water Treatment Plant.

This tour is designed specifically to inform the Committee of the various City facilities and will provide an opportunity for traveling about the City in a fashion where questions and answers can be exchanged in an "on site" situation.

ITEM - THE FIRST MONTHLY MEETING OF THE CURRY COUNTY INDUSTRIAL DEVELOPMENT ADVISORY COMMITTEE occurred last Friday at Gold Beach.

The staff representative for CCD is Jerry Gilbertson.

Experience to date:

500 letters were sent out in January!

One firm has selected Curry County for its activities so far.

This is a small manufacturer who does a great amount of flying in his business and will develop at Port Orford. He makes electrical components.

The CCD does provide much information to any person who may be considering a business venture.

Consultant services are available in:

- (a) Location facts
- (b) Facility availability (Buildings)
- (c) Management Council
- (d) Financing information

CCD has applied for next year financing for this project and is hoping to see it develop.

ITEM - CITY CENSUS PROJECT

I have contacted the J.C.'s and they will be giving the City a proposal for their services to provide a preliminary head count to evaluate whether the City should proceed to do a full scale census count.

Current census is a July 1, 1976 certified estimate of 3240 people.

Estimated J.C. cost - \$200.00.

The Portland State Center for Population and Research would do the certified count procedure at an estimated cost of \$1,450.00 and the City would hire five (5) enumerators for a one week period - total \$2,200.00.

100 persons would be required to equal out this cost at the current rate of \$22.71 per capita which was used in the budget estimates for fiscal 1976-77.

ITEM - LITTLE LEAGUE BALL PARK

Estimated completion date: March 31

ITEM - TENNIS COURT PROJECT

We are presently obtaining cost figures on this project from local contractors and have begun construction on the parking lot and sub-base of the court area.

OS CURRY REGIONAL HOUSING AUTHORITY

The Counties of Curry and Coos recently took the necessary action to establish a regional housing authority for the purpose of applying for Section 8 Assistance for low income families through the Department of Housing and Urban Development.

Section 8 is a federally funded program that provides payments to private property owners on behalf of assisted families.

The Housing Authority pays the difference between the market rent of a unit and what the family can afford to pay which may not exceed 25% of their gross income, nor be less than 15%.

A family that is determined eligible by the Housing Authority will be given a certificate of participation. This family may then seek a suitable rental anywhere within the Coos Curry area. If an owner is willing to lease a unit and the unit is determined to be in decent, safe and sanitary condition and if the Gross Rent is within the H.U.D. established Fair Market Rent for existing housing, a lease may be executed between the tenant and the owner. This contract will assure a monthly payment to the owner in an amount sufficient to make up the difference between the rent payable by the family and the contract rent to the owner.

A family does not have to be without housing to qualify for assistance under this program. If they meet the eligibility requirements for income, etc. and the unit they are presently renting meets the necessary criteria and if the owner is willing to participate, then the Housing Authority may approve the rental contract and make the payments on behalf of the family.

Although Curry and Coos Counties have taken the necessary action to establish a Regional Housing Authority, they may not operate the Section 8 program in any city within the two counties without the local governing bodies specific approval.
