MINUTES BROOKINGS COMMON COUNCIL CITY OF BROOKINGS NOVEMBER 9, 1976

The meeting was called to order at 8:00 p.m. by Mayor Robert L. Kerr. Members present were Councilmen Jack C. Ross, Ellis Dowden, and William Guthrie. Also present was City Manager Al R. Hooten. Absent was Councilman Darrell Allsup.

APPROVAL OF MINUTES:

MOTION was made by Councilman Guthrie, seconded by Councilman Ross and carried unanimously that the minutes of October 12, 1976 be approved as presented.

PUBLIC HEARING:

PROPOSED STREET IMPROVEMENTS ON OXFORD, MAPLE AND A PORTION OF CEDAR STREET.

Estimate of this project is made a part of these minutes.

One notice of objection was submitted to this street improvement by William LaVigne, who owns Lot 6 in the Coast View Subdivision.

After further discussion a MOTION was made by Councilman Ross, seconded by Councilman Guthrie and carried unanimously that the City proceed with the next step to implement this improvement district.

Resolution No. 192, for the purpose of commencing this improvement district, was read in full.

MOTION was made by Councilman Ross, seconded by Councilman Dowden and carried unanimously that Resolution No. 192 be adopted.

MONTHLY REPORTS:

City Attorney - None.

Consultant Engineer's Report - Joe Stonecypher, Project Engineer, reported on the following:

BIDS ON CHETCO AND PACIFIC AVENUES WATER LINE.

Approximately the amount of \$80,000 was allocated for the high level water improvements. Due to the fact that the bids on the Chetco and Pacific water lines were higher than the engineers estimate, Mr. Stonecypher suggested that the City take the amount of \$75,000 from the amount allocated for the upper level improvement and apply to the Chetco and Pacific water line and recommended that the bid be awarded to Kenneth Bostick, the lowest bidder, for the basic bid and Alternate No. 1, for the amount of \$192,840.

Mayor and Council then advised the engineer that in the specifications on this water line, it was not their intentions to have the fire hydrant crossings installed on the opposite side of the highway, and if these were deleted from the project, a local contractor would be the lowest bidder. Mr. Stonecyper stated " that the bids being totaled as they were opened and with no adjustments being made, the apparent low bidder was Ken Bostick."

After more discussion a MOTION was made by Councilman Guthrie, seconded by Councilman Ross, and carried unanimously that all bids be rejected.

MOTION was then made by Councilman Dowden, seconded by Councilman Ross and carried unanimously that new bids be submitted on this project deleting the hydrant crossings.

PUBLIC WORKS APPLICATION.

Engineer advised that City would have to adopt a resolution to be eligible to apply for a grant from the Economic Development Administration under Title I of the Public Works Employment Act of 1976, for further water improvements on Parkview Drive, Meadow Lane, Upper 7th Street, and Old County Road, along with a signed contract for engineering.

Resolution No. 191, a resolution authorizing the application for a grant under the local public works capital development was read in full.

MOTION was made by Councilman Ross, seconded by Councilman Dowden and carried unanimously that Resolution No. 191 be adopted.

MOTION was made by Councilman Guthrie, seconded by Councilman Ross that this council meeting be adjourned until Thursday, November 18, 1976, at 7:30 p.m. at which time a contract for engineering services with H.G.E., Inc. for the above named improvements will be signed.

MILL BEACH PRESSURE MAIN.

E.P.A. approval has been received on this project and construction will begin soon.

LEGISLATIVE ACTION:

1. POLICE CAR BIDS.

3. REQUEST FOR FIRE ZONE CHANGES WITHIN CITY LIMITS.

These fire zone changes were requested by Merle Frank, Fire Chief, and Wendell Bartholomew, Building Inspector.

MOTION was made by Councilman Ross and seconded by Councilman Dowden that City Attorney be authorized to prepare an ordinance for the requested fire zone changes. Councilman Guthrie abstained from voting. Motion carried.

4. PROPOSAL WITH WALLACE & TIERNAN FOR ELECTRO-PROOFING CATHODIC PROTECTION SERVICE ON THE WATER RESERVOIR.

This proposal is for the calendar year 1977 for the amount of \$160.00.

MOTION was made by Councilman Dowden, seconded by Councilman Ross and carried unanimously that this proposal be accepted and Mayor Kerr be authorized to sign said proposal.

5. DISCUSSION ON CITY SEWER USER FEES AS ESTABLISHED BY ORDINANCE NO. 236. WHICH ARE NOT ACCEPTABLE TO E.P.A.

6. APPROVAL FOR PURCHASE OF NEW PHOTO COPY MACHINE.

MOTION was made by Councilman Guthrie, seconded by Councilman Ross and carried unanimously that this be tabled until the November 18, 1976, meeting.

7. AUTHORIZATION FOR GREGORY W. BYRNE, ATTORNEY, TO PROCEED WITH THE CASE CITY OF BROOKINGS v. BROOKINGS UTILITY COMPANY, et al.

MOTION was made by Councilman Dowden, seconded by Councilman Ross and carried unanimously that this be tabled until the regular Council meeting of January 11, 1977.

8. PAYMENT OF VOUCHERS.

MOTION was made by Councilman Ross, seconded by Councilman Dowden and carried unanimously that vouchers in the amount of \$27,926.54 for the month of October 1976 be paid.

CITY MANAGER'S REPORT.

ITEM CCD-EIA PROJECTS.

#1. The City of Brookings is applying for an Industrial Park Site and Water System Feasibility Study Grant from Economic Development Administration.

This study will require a consultant firm to identify and propose specific industries that could be induced to settle in this area, to specify the utility needs such as water, electricity, access needs, plus the comparison of certain industries to one another regarding the impact upon the environment of said industry.

All information including land parcels being proposed together with Port of Brookings, Brookings Plywood, the Brookings airport facility, and South Coast and Agnew lumbering complex lands will be identified in this study.

#2. Curry County will contract with CCD staff to do an evaluation of the Harbor Bench area dealing with the current agricultural use versus the kinds of impacts were urbanization to occur on this land.

Several specific items concerning this comparison will be most valuable in the local planning process of this total area.

ITEM THE BROOKINGS WATER STORAGE TANK.

The 1,500,000 gallon storage tank has recently developed a rusting problem and upon final draining of the tank today the representatives of U.S. Tank Contractors inspected the facility with the following consensus:

- (1) The tank will need to be completely re-done as far as the interior surface.
- (2) The vinyl coating is not adhering to the metal interior and there is a rusting and bubbling condition.
- (3) In about 4 6 months a person will come and re-inspect the tank to evaluate further the rusting and amount of increase in the damaged areas.
- (4) Next year during proper weather conditions a time that is convenient with the City and U.S. Tank will be selected to complete the necessary repairs. The tank will be out of service for an estimated 5 weeks.

ITEM CRISSEY CIRCLE SEWER PROJECT.

This service line was originally expected to be a gravity line serving 5 - 6 properties.

Upon surveying the properties it was discovered that only two could gravity feed into this line.

Because of the starting depth (14 feet) of the line and the 700 approximate lineal feet the cost was prohibitive so it will be designed as a pressure line, installed at a minimum depth and all properties will pump into it.

ITEM SPRUCE STREET SEWERS.

This particular system needs to be replaced and there are funds ear-marked for the project.

The City will proceed to design this line and contract its construction.

ITEM INFILTRATION INTO SYSTEM (SEWERS).

The total sewerage collection system has a tremendous amount of drainage water that flows into the treatment plant and this must be controlled. The City will continue smoke testing and identifying those drain pipes, catch basins, and other areas where water is gaining direct access to the system and make necessary changes.

Private citizens will be advised of these conditions and given certain time to make repairs.

ITEM MEDICAL CLINIC DRAINAGE.

ALDER Street W

The County owned facility on Armstd Street will be receiving pavement on its parking lot and the surface drainage water must be collected and diverted to a drainage system.

The City has proposed to the County a plan whereby the materials would be purchased or furnished by the County and the City would furnish manpower and equipment to construct this line.

ITEM HIGH SCHOOL GOVERNMENT DAY.

The high school held an election of "City Officials" on Nov. 2, 1976 coinciding with the National and City elections.

On Friday Nov. 5 they closed application for the staff positions and on Nov. 12 the "Officials" will proceed to interview and appoint their staff.

At a later date an orientation meet will take place then in mid-December the High School Government Day will take place with these students filling the positions of City Government.

ITEM LEAGUE OF OREGON CITY CONVENTION - NOVEMBER 14, 15, AND 16.

The Police Chief and Assistant Police Chief and City Manager, along with City Attorney will be attending this year.

The City Manager will be moderating the workshop on Sunday afternoon on the Safe Drinking Water Act involving State Health Division staff personnel.

Also on Monday he will act as a panelist on the Small City Workshop. This is an informal format with the basic purpose of having a group of small cities represented for a general question-answer period of exchanging ideas, explanations of problem solving in specific needs and is generally a very popular session at the Convention.

OPEN DISCUSSION.

Mayor Kerr designated November 12, 1976 as Sports Appreciation Day honoring Brookings-Harbor High School athletes who will participate in the forthcoming weekend in State level events.

Mayor Kerr announced that the City of Brookings have to appoint four budget committee members. It will soon be time to start

MOTION was made by Councilman Ross, seconded by Councilman Guthrie and carried unanimously that the meeting be adjourned. The meeting then adjourned at 10:15 p.m. to reconvene at 7:30 p.m. on November 18, 1976.
